### PENSION FUNDS ACT, 1956 (ACT NO. 24 OF 1956)

#### AMENDMENT OF PRESCRIBED FEES

The Minister of Finance has under section 36 of the Pension Funds Act, 1956 (Act No. 24 of 1956), made the regulations in the Schedule.

#### SCHEDULE

##### Definition
