#### TRADITIONAL HEALTH PRACTITIONERS ACT, 2004 (ACT NO. 35 OF 2004)

#### INVITATION FOR NOMINATION OF CANDIDATES FOR APPOINTMENT TO THE INTERIM TRADITIONAL HEALTH PRACTITIONERS COUNCIL

1. Notice is hereby given in terms of section 7(c), (e),(h) and (i) of the Traditional Health Practitioners Act, 2004 (Act No 35 of 2004) (hereinafter referred to "the Act"), that the Minister of Health invites nominations of persons as candidates for appointment to the Interim Traditional Health Practitioners Council (hereinafter referred to as "the Council").
2. Section 7 of the Act makes provision for the establishment of a Council consisting of a maximum of 22 members appointed by the Minister.
3. The following paragraphs of section 7 of the Act guide the Minister in appointing the said members of the Council:
  - (a) paragraph (c) of section 7 of the Act makes provision for appointment of nine traditional health practitioners as defined in the regulations relating to the appointment of members of the Council made under the Act, to represent each province;
  - (b) paragraph (e) of section 7 of the Act makes provision for the appointment of a person on account of his or her knowledge of the law;
  - (c) paragraph (h) of section 7 of the Act requires three community representatives to be appointed as members of the Council; and
  - (d) paragraph (i) of section 7 of the Act requires one traditional health practitioners from each category of traditional health practitioners, i.e. diviner, herbalist, traditional birth attendant and traditional surgeon.
4. A person appointed as a member of the Council in terms of section 7(c) and (i) of the Act must have been in practice for not less than 5 years as traditional health practitioner or in the category he or she is representing.
5. Nominations of candidates for appointment in terms of section 7(c) of the Act must be submitted to the Member of the Executive Council responsible for health in the province in which the nominated traditional health practitioner predominantly practices.

6. Nominations of candidates for appointment in terms of section 7(e), (h) and (i) of the Act must be submitted to the Minister of Health.
7. Nominations must be submitted in the format contained in the Annexure to the regulations relating to the appointment of members the Council made under the Act.
8. Nominations must be submitted within 30 days of the date of this notice:


