FILMS AND PUBLICATIONS ACT

FILMS, PUBLICATIONS AND INTERNET REGULATIONS

The Film and Publication Board has, under section 31(2) of the Films and Publications Act, 1996 (Act No. 65 of 1996), made the Regulations in the Schedule.

SCHEDULE

Definitions

1. In these Regulations, any meaning assigned to any word or expression in the Act will have that meaning and, unless the context indicates otherwise-

"business of adult premises" means a business contemplated in section 24(1) of the Act;

"home-entertainment format" means a film in a format intended for viewing through an electronic, mechanical or other device in private;

"public-entertainment format" means a film in a format that is intended for screening or exhibition to the public in cinemas, theatres and other public places;

"prescribed fee" means the applicable fee prescribed by the Minister under section 31(1)(a) of the Act:

"restricted film" means a film which contains any scene described in Schedule 6 or 7, read with Schedule 9, or any scene described in Schedule 10, of the Act;

"submittable publication" means a publication contemplated in section 17(4) of the Act;

"Act" means the Films and Publications Act (Act No. 65 of 1996);

"unrestricted film" means a film which does not contain any scene described in either Schedule 6 or 7 of the Act.

PROCEDURES

Registration as a distributor and/or exhibitor of films

2. Any person who intends to distribute or exhibit any film shall first register with the Board as a distributor or exhibitor, or a distributor and exhibitor, of films by completing, in all respects, and returning, to the Chief Executive Officer, Form FPB/R/18/1A, together with the prescribed fee.

Procedure for complaints against publications

- 3. A complaint in terms of section 16(1) of the Act that a publication distributed in South Africa, which has not been decided upon by the Board, be referred to a classification committee for a decision and classification in terms of section 17(1) of the Act, shall be submitted, in writing, to the Chief Executive Officer of the Board and shall include the following-
 - (a) the publication or a copy thereof or, where it is not practical to submit the publication or a copy thereof, the full address of the place where that publication may either be obtained or examined by the Board;
 - (b) the full name and address, including a contact telephone or fax number and, if available, an e-mail address, of the complainant, unless the complainant wishes to remain anonymous;
 - (c) the title of the publication forming the subject-matter of the complaint;
 - (d) the date and number of the edition or issue of the publication;
 - (e) the name and address of the publisher;
 - (f) the name and address of the distributor of that publication in South Africa; and
 - (g) a brief statement of the complaint in which reference is made to page numbers and specific paragraphs or lines forming the subject-matter of the complaint.

Classification of publications

- 4. Any person who intends to publish, distribute or exhibit any publication contemplated in section 17(4) of the Act, shall submit such publication to the Chief Executive Officer of the Board, prior to its publication, distribution or exhibition, together with completed Form FPB/SP/17(4) and the prescribed fee.
- 5. An application in terms of section 16(2) of the Act shall be done on completed Form FPB/RCP/16, and submitted to the Chief Executive Officer together with the prescribed fee.

Classification of films

- 6. (1) An application for the classification of a film in terms of section 18(1) of the Act shall be done on completed Form FPB/FC/18/1A(b).
 - (2) Where the film contemplated in subsection (1) is in home-entertainment format, a copy of the film in the format of its intended distribution, shall be submitted with the application to the Chief Executive Officer of the Board.
 - (3) Where the film contemplated in subsection (1) is in a public-entertainment format, the applicant shall, at her or his own expense, arrange for the screening of that film to a classification committee of the Board at a venue, date and time agreed to by the Board.
- 7. (1) An application in terms of section 18(8) shall be submitted to the Chief Executive Officer on completed Form FPB/RC/18/8, together with the prescribed fee.
 - (2) Where there have been changes to the film submitted in terms of subsection (1) since it was last classified, a copy of the film, if in home-entertainment format, incorporating the changes, must be submitted with the application. In the case of a film in public-entertainment format, arrangements for the screening of that film to the Board, at the expense of the applicant, must be made at a venue and on a date and at a time agreed to by the Board.
- 8. An application for exemption from sections 25, 27 and 28 of the Act shall be made on completed Form FPB/E/22 and submitted to the Chief Executive Officer of the Board, together with the prescribed fee.
- 9. An application for exemption from section 26 of the Act shall be made on completed Form FPB/E/23 and submitted to the Chief Executive Officer of the Board, together with the prescribed fee.
- 10. An application for the classification of a film which has been exempted in terms of section 8 or 9, for subsequent release for general distribution or exhibition, shall be made in the manner specified in section 6.
- 11. An application for approval to exhibit in public, during the same screening session, or to distribute on the same film, an advertisement or a trailer of a film with a more restrictive classification than the featured film shall be done on completed FormFPB/E/26(e), and shall be submitted to the Chief Executive Officer together with the prescribed fee.

Internet service providers

12. An Internet service provider shall register with the Board by completing, in all respects, and returning to the Chief Executive Officer, Form FPB/ISP/27A, together with the prescribed registration fee.

Appeal to the Review Board

- 13. An appeal under section 20(1) of the Act shall be made by completing, in all respects, and returning to the Chief Executive Officer, a Notice of Appeal, on Form FPB/RB/20, together with the prescribed fee.
- 14. The Notice of Appeal must-
 - set out the name and address of the appellant and indicate the interest she, he
 or it has in the outcome of the appeal
 - (ii) identify the decision which is the subject of the appeal
 - (iii) contain a concise statement of the grounds of appeal, with reasons for the conclusion that that decision is incorrect, with reference to the classification guidelines where the appeal is against a classification or reclassification decision
 - (iv) indicate, with supporting arguments and copies of any document upon which the appellant will rely, what the decision ought to have been
 - (v) be signed by the appellant or a duly authorized representative of the appellant, and `
 - (vi) be accompanied by proof of payment of the applicable fee.
- 15. The Board shall, within 7 days from the date on which the Notice of Appeal was received, prepare and serve on the appellant a written response to the appeal, setting out the Board's reasons for the decision, together with any documents that the Board may produce in support of its decision.
- 16. The appellant may, within a period of 7 days from the date when the Board's reply was received, respond to the Board's submissions, together with any further documents that may be used to support the appeal.
- 17. Immediately after the expiry of the period referred to in paragraph 16 above, the Board shall, forthwith:
 - (i) serve on the Chairperson and each member of the Review Board, copies of the Notice of Appeal, the response of the Board, the further submissions of the appellant and all supporting documents, and
 - (ii) in consultation with the Chairperson of the Review Board, notify the appellant and each member of the Review Board, of the date, time and venue of the hearing of the appeal.

Repeal of Regulations

18. Regulation No R. 57, 1998, published in Vol. 395 No. 18935 of 29 May 1998, is hereby repealed with effect from the date of the publication in the *Gazette* of these regulations.

Short Title and Commencement

19. These Regulations shall be called the Films and Publications Regulations 2006 and shall come into effect on the day of its publication in the *Gazette*.
