NOTICE OF CORRECTION

DETERMINATION OF UPPER LIMITS OF THE SALARIES, ALLOWANCES AND BENEFITS OF DIFFERENT MEMBERS OF MUNICIPAL COUNCILS

It is hereby notified that, whereas an error occurred in Government Notice No. R. 653 of 30 June 2006, that Notice is corrected –

- (a) by the substitution in item 1 for the definition of “population” of the following definition:

“ “**population**” means the latest available official statistics of the population residing in the area of jurisdiction of a metropolitan, local or district municipality, as determined by the Statistician-General in terms of the Statistics Act, 1999 (Act No. 6 of 1999);” and

- (b) by the substitution in item 1 in the English text for the definition of “total remuneration package” of the following definition:

“ “**total remuneration package**” is the total cost to a municipality of a basic salary component, a travelling allowance as provided in items 6(a) and 9(a), a housing allowance as provided in items 6(b) and 9(b), the municipal contribution to a pension fund as provided in item 11(a), and the municipal contribution to a medical aid as provided in item 11(b) to a councillor in a municipal financial year.” .
