AMENDMENT OF REGULATIONS MADE UNDER INTEGRATION OF LABOUR LAWS ACT, 1994 (ACT NO. 49 OF 1994)

The Minister has, under section 3 of the Integration of Labour Laws Act, 1994 (Act No. 49 of 1994), made the regulations in the Schedule.

SCHEDULE

Definitions

1. In this Schedule "Social Development Initiatives Funding Window" means the funding window of the National Skills Fund as approved by the Director-General of the Department of Labour.

"the Regulations" means the Regulations published under Government Notice No. R 953 of 6 August 1999.

Amendment of regulation 1

2. Regulation 1 is hereby amended by substitution of the definition of "Provincial Director" by the following definition:
" 'Provincial Executive Manager' means the Provincial Executive Manager: North West Province of the Department of Labour".

Amendment of regulation 2

3. Regulation 2 is hereby amended by the addition of the following subregulations:

"(4) When the Director-General dissolves the committee in terms of regulation 12(2), it shall be ensured that the balance of any earmarked money shall be transferred to the Social Development Initiatives Funding Window of the National Skills Fund."

"(5) The money transferred in terms of subregulation (4) must be utilised according to criteria and procedures of the Social Development Initiatives Funding Window."

Amendment of Regulations

4. In this Regulations, wherever the phrase "Provincial Director" appears, it shall be deleted and replaced by the phrase Provincial Executive Manager.

Commencement

5. These amendments shall come into operation on the date of publication hereof in the Government Gazette.
