SCHEDULE

BARGAINING COUNCIL FOR THE BUILDING INDUSTRY, KIMBERLEY

COLLECTIVE AMENDING AGREEMENT

in accordance with the provisions of the Labour Relations Act, 1995, made and entered into by and between the -

Northern Cape Master Builders' and Allied Trades Association

(hereinafter referred to as the "employers" or the "employers' organisation"), of the one part, and the

Amalgamated Union of Building Trade Workers of South Africa

(hereinafter referred to as the "employees" or "trade union"), on the other part, being the parties to the Bargaining Council for the Building Industry, Kimberley, to amend the Collective Agreement published under Government Notice No. R. 957 of 7 August 1998, as amended and extended by Government Notices Nos R. 745 of 11 June 1999, R. 1365 of 15 December 2000, R. 1018 of 18 July 2003, R. 1049 of 25 July 2003 and R. 865 of 23 July 2004.

1. SCOPE OF APPLICATION

- (1) The terms of this Agreement shall be observed in the Building Industry -
 - (a) by the employers and employees who are members of the employers' organisation and the trade union, respectively;
 - (b) in an area bounded by and included in a radius of 20 kilometres of the General Post Office, Kimberley, in the Magisterial District of Kimberley;
 - (c) in the Magisterial District of Gordonia.
- (2) Notwithstanding the provisions of subclauses (1)(a) and 1A, the terms of this Agreement shall apply to -

- (a) apprentices only in so far as these provisions are not inconsistent with the provisions of the Skills Development Act, 1998, or any contract entered into or any conditions fixed thereunder;
 - (b) trainees under the Skills Development Act, 1998, only in so far as these provisions are not inconsistent with the provisions of that Act or any conditions fixed thereunder;
 - (c) labour-only contractors, working partners and working directors, principals and contractors.
- (3) Notwithstanding the provisions of subclause (1)(a), the terms of this Agreement shall not apply to -
- (a) clerical employees and administrative staff;
 - (b) university students and graduates in building science, and to construction supervisors, construction surveyors and other persons doing practical work, in the completion of their academic training;
 - (c) non-parties in respect of clauses 1(1)(a) and 1A of the Collective Agreement as extended or amended from time to time.

CLAUSE 1A: PERIOD OF OPERATION OF AGREEMENT

This Agreement shall come into operation on such date as may be fixed by the Minister of Labour in terms of section 32 of the Labour Relations Act, 1995, and shall remain in force until 31 July 2011.

2. CLAUSE 21: MINIMUM WAGES



4. CLAUSE 30: BENEFIT FUND FOR ARTISANS

Substitute the following for subclause (4)(c):

"(c) **Medical benefits:** If a member and his or her accepted dependants incur medical expenses, he or she may claim benefits which shall not in any one calendar year exceed R2 000,00 per member, subject to the discretion of the Management Committee: Provided that benefits shall not be payable in respect of the following:

- (i) Claims arising through the member's own misconduct or negligence;
- (ii) claims arising that are compensable in terms of the Compensation for Occupational Injuries and Diseases Act, 1993, or from any other source;
- (iii) claims arising from any disease, abnormality or infirmity from which the member or his or her dependant was suffering at the date of commencement of membership;
- (iv) holidays for recuperating purposes;

- (v) claims not medically essential, including non-essential plastic surgery or for cosmetic or similar reasons;
- (vi) supply of false teeth, artificial limbs or appliances;
- (vii) unprescribed or patent medicines;
- (viii) cost of specialist services not referred by a general practitioner;
- (ix) claims arising through riot, strike, civil commotion or war;
- (x) travelling expenses; and
- (xi) 20 per cent of the cost of all medicines dispensed by chemists or doctors.".

- "(a) The employer shall deduct from the earnings of his or her employees 4,5% of the employee's monthly wage with effect from the date of coming into operation of this Agreement to 28 February 2011. To the amounts so deducted the employer shall, in respect of each employee, add the same amount.
- (b) The employer shall then forward the total amount not later than the 7th day of the following month to the Chief Administrative Officer of the Council, P.O. Box 1256, Pretoria, 0001, or pay the total amount directly into the account of the Bargaining Council Provident Fund, Standard

Bank, account number 010331484, and submit proof to the Council with details in respect of each employee for whom the total amount was paid.

SCHEDULE**Definitions**

1. In these regulations—

“the Biodiversity Act” means the National Environment Management: Biodiversity Act, 2004 (Act. No. 10 of 2004); and

“the Regulations” means the Threatened or Protected Species Regulations, 2007 published in Government Gazette No. 29657, Government Notice No. R 152 of 23 February 2007, as amended by Government Notice No. R. 69 of 28 January 2008, published in Government Gazette No. 30703.

Amendment of regulation 1 of the Regulations

2. Regulation 1 of the Regulations is hereby amended by the substitution of the definition “management plan” for the following definition:

“management plan”, means—

- (a) a management plan referred to in section 41 of the National Environmental Management: Protected Areas Act, 2003 (Act No. 57 of 2003);
- (b) a biodiversity management plan developed in terms of section 43 of the Biodiversity Act; or
- (c) a management plan done in terms of paragraph 6 of the National Norms and Standards for the Management of Elephants in South Africa, 2008 issued in terms of section 9 of the Biodiversity Act.”.

Amendment of regulation 6 of the Regulations

3. Regulation 6 of the Regulations is hereby amended by the deletion of the word “and” at the end of subregulation (3)(d) and the insertion in subregulation (3) after paragraph (d) of the following paragraph:
“(dA) An approved management plan; and”.

Amendment of regulation 25 of the Regulations

4. Regulation 25 of the Regulations is hereby amended by the substitution of paragraph (b) for the following paragraph:
“(b) trade in artificially propagated specimens of critically endangered or endangered *Encephalartos* species, or the export of such specimens with a stem diameter of more than 15cm, except where provided for in a Biodiversity Management Plan approved by the Minister in terms of section 43 of the Biodiversity Act;”.

Amendment of regulation 73 of the Regulations

5. Regulation 73 of the Regulations is hereby amended by—

- (a) the insertion in subregulation (1) after paragraph (a) of the following paragraph:
"(aA) undertakes an activity prohibited in terms of regulations 23, 24, 25, 26, or operates in contravention of subregulation 27(1);" and
- (b) the addition to subregulation (1) of the following paragraph:
"(e) permits or allows any other person to undertake any restricted activity, which is an offence, in terms of paragraph (a)."
- (c) the insertion in subregulation (2) after paragraph (a) of the following paragraph:
"(aA) conducts a captive breeding operation, commercial exhibition facility, nursery, scientific institution, sanctuary, rehabilitation facility or acts as a wildlife trader involving specimens of any listed threatened or protected species without being registered with the issuing authority in terms of Chapter 3 of these regulations;" and
- (d) the addition of the following subregulation:
- "(6) A person who—
- (a) owns or is in control of an elephant or land on which an elephant roams or is kept, or
Is guilty of an offence if he or she or it fails to comply with the norms and standards issued in terms of section 9 of the Biodiversity Act."

Short title and commencement

6. These regulations are called the Threatened or Protected Species Second Amendment Regulation, 2008, and take effect on a date determined by the Minister by notice in the Government Gazette.
