(hereinafter referred to as the 'employers' or the 'employers' organisation') of the one part, and the

Amalgamated Union of Building Trade Workers of South Africa

(hereinafter referred to as the 'employees' or the 'trade union') on the other part, being parties to the Bargaining Council for the Building Industry, Kimberley to amend the Agreement published under Government Notice No. R.957 of 7 August 1998, as amended, extended and renewed by Government Notices Nos R.745 of 11 June 1999, R.1365 of 15 December 2000, R.1018 of 18 July 2003, R.1049 of 25 July 2003, R. 865 of 23 July 2004, R.906 and R.907 of 29 August 2008.


1. SCOPE OF APPLICATION

- (1) The terms of this Agreement shall be observed in the Building Industry -
- (a) by the employers and employees who are members of the employers' organisation and the trade union, respectively,
 - (b) in an area bounded by and included in a radius of 20 kilometers of the General Post Office, Kimberley, in the Magisterial District of Kimberley; and
 - (c) in the Magisterial District of Gordonia.
- (2) Notwithstanding the provisions of sub-clauses 1(1)(a) and 1A, the terms of this Agreement shall apply to -

- (a) apprentices only in so far as they are not inconsistent with the provisions of the Skills Development Act, 1998, or any contract entered into or any conditions fixed thereunder;
 - (b) trainees under the Skills Development Act, 1998, only in so far as they are not inconsistent with the provisions of that Act or any conditions fixed thereunder;
 - (c) labour-only contractors, working partners and working directors, principals and contractors.
- (3) Notwithstanding the provisions of sub-clause (1)(a), the terms of this Agreement shall not apply to-
- (a) clerical employees and administrative staff;
 - (b) university students and graduates in building science, and to construction supervisors, construction surveyors and other persons doing practical work, in the completion of their academic training;
 - (c) non-parties in respect of clauses 1(1)(a), and 1A of the Collective Agreement as extended or amended from time to time.

2 CLAUSE 1 A: PERIOD OF OPERATION OF AGREEMENT

This Agreement shall come into operation on such date as may be fixed by the Minister of Labour in terms of Section 32 of the Labour Relations Act, 1995, and shall remain in force until 31 July 2011.




1. SCOPE OF APPLICATION

- (a) clerical employees and administrative staff;
 - (b) university students and graduates in building science, and to construction supervisors, construction surveyors and other persons doing practical work, in the completion of their academic training;
 - (c) non-parties in respect of clauses 1(1)(a) and 1A of this Agreement.



The Minister of Transport has under section 80(1) (d) of the National Ports Act (Act No. 12 of 2005), made regulations in the Schedule.

The Port Limits Regulations contain a description in words and diagrams depicting the correct port limits.

WHEREAS the generally accepted current port limits of the respective ports are incorrectly reflected in Government Notice No. R. 1091 of 23 November 2007;

WHEREAS it is necessary to create legal certainty by reflecting the correct port limits of each port; and

WHEREAS the correct description of the respective port limits has been published for public comment under Government Notice No. 1486 of 26 November 2008 as so-called "revised Port Limits", the correct port limits are hereby confirmed and described:

Definitions

1. (1) In these Regulations any word or phrase to which a meaning has been assigned in the National Ports Act, 2005 (Act No. 12 of 2005), has the meaning so assigned and, unless the context otherwise indicates—

"point" means a point of reference referred to in a description of a port limit in these Regulations as indicated on the applicable Surveyor-General diagram, and which is geographically positioned by way of coordinates in the table of coordinates contained in that diagram, or defined in the description of a port limit;

"survey direction" means the direction from one point to another point based on a South Azimuth System where zero degrees is due south;

"Surveyor-General" means a Surveyor-General as defined in the Land Survey Act, 1997 (Act No. 8 of 1997); and

"Surveyor-General diagram" means the applicable diagram of a port lodged with a Surveyor-General and identified by a number with the prefix "S.G.".

(2) The visual representations of port limits in the Appendices are for ease of reference only and may not be used to determine or verify any port limits.

Description of port limits

2. The port limits for the ports of Richards Bay, Durban, East London, Ngqura, Port Elizabeth, Mossel Bay, Cape Town, Saldanha Bay and Port Nolloth are the areas described below:

(1) Port of Richards Bay

The Port of Richards Bay comprises the area reflected in Surveyor-General diagram S.G. No. 1617/2009, which is visually represented for ease of reference in Appendix 1, and described as follows with reference to Surveyor-General diagram S.G. No. 1617/2009 and the table of coordinates contained therein:
