PETROLEUM PRODUCTS ACT, 1977 (ACT No. 120 OF 1977)

REGULATIONS IN RESPECT OF THE SINGLE MAXIMUM NATIONAL RETAIL PRICE FOR ILLUMINATING PARAFFIN

1. I, Ms. E D Peters, Minister of Energy, under section 2(1)(c) of the Petroleum Products Act, 1977 (Act No. 120 of 1977), determine that a maximum retail price for illuminating paraffin (excluding the price of any form of packaging) will become effective on the first Wednesday of each month.
2. The maximum retail price for illuminating paraffin, excluding the price of any form of packaging, for the period 01 December 2010 to 04 January 2011 will be 716.0 c/l.
3. **Commencement**
These regulations shall come into operation at **00:01 on 01 December 2010.**

AMENDMENT OF THE REGULATIONS IN RESPECT OF PETROLEUM PRODUCTS

The Minister of Energy has, under section 2 (1) (c) of the Petroleum Products Act, 1977 (Act No. 120 of 1977), made the regulations set out in the Schedule.

SCHEDULE

1 Definitions

In these regulations "the Regulations" mean the regulations published by Government Notices Nos.
