DRAFT AMENDMENT REGULATIONS ON NATIONAL GAMBLING REGULATIONS, 2004 (RE-CERTIFICATION OF GAMBLING MACHINES)

SCHEDULE

Amendment of regulation 1 of Regulations

"Definitions

1. Regulation 1 of the regulations is hereby amended by the insertion of the following definition:

"significant amendment" means amendment made to the applicable standard to a gambling machine or device of any type, variation or model resulting in a publication in the Government Gazette of the new standard".

Amendment of regulation 8(4) of the Regulations "Re-certification of Gambling Machines

- 2. Regulation 8(4) of the Regulations is hereby amended
 - a. by the substitution for sub-regulation (4) of the following sub-regulation:
- (4) [Where the standard applicable to a gambling machine or device is amended or substituted, any type, variation or model of gambling device certified as complying to the former standard may be exposed for play for a maximum of three years after such substitution or amendment and, if it is to continue to be exposed for play after such period, must be certified against the amended or substituted standard.]
- (a) Re-certification of any gambling machine or device, of any type, variation or model made available for play by the public in the Republic of South Africa must be conducted every six years: Provided that the certification or re-certification of existing gambling machine or device

of any type, variation or model shall be done within twelve (12) months from the date of coming into operation of these Regulations.

- (b) Where the standard applicable to a gambling machine or device of any type, variation or model is amended or substituted significantly, the licensee must within three years of such amendment or substitution, re-certify such gambling machine or device of any type, variation or model in line with the new standard, irrespective of when last such gambling machine or device of any type, variation or model was certified or re-certified. If the six year cycle referred to in paragraph (a) will lapse before the three years after the significant amendments to the standards have been made, the re-certification will therefore be upon the lapse of the six year cycle."
- (c) The six year period will start running from the date of re-certification of a gambling machine or device of any type, variation or model".
