### HEALTH PROFESSIONS ACT, 1974 (ACT NO.56 OF 1974)

### REGULATIONS RELATING TO THE REGISTRATION OF STUDENT DENTAL ASSISTANTS: AMENDMENT.

The Minister of Health has, under sections 61 of the Health Professions Act, 1974 (Act No. 56 of 1974), and after consultation with the Health Professions Council of South Africa, made the regulations in the schedule.

#### SCHEDULE

##### Definitions

1. In these regulations "**the regulations**" means the regulations relating to the registration of student dental assistants as published under Government Notice No. R. 581 of 30 May 2008, and any word or expression to which a meaning has been assigned in the regulations shall have that meaning and, unless the context otherwise indicates -

##### Amendment of Regulation 2 of the regulations.

2. Regulation 2 of the regulations is hereby amended by the substitution for sub-regulation (2) of the following sub-regulation:-

"(2) In the case of a person who have worked as dental assistants prior to the date of publication of this amendment for a period of less than five (5) years, within four months from the date of publication of this amendment: Provided that the registrar shall not, after

four months from the date of publication of this amendment, register any person referred to in this sub regulation".

**WET OP GESONDHEIDSBEROEPE, 1974 (WET NO. 56 VAN 1974)**  
**REGULASIES BETREFFENDE DIE REGISTRASIE VAN STUDENT TANDHEELKUNDIGE**  
**ASSISTENTE: WYSIGING**

Die Minister van Gesondheid het ingevolge artikel 61 van die Wet op Gesondheidsberoepe, 1974 (Wet No. 56 van 1974), en na oorleg met die Raad vir Gesondheidsberoepe van Suid-Afrika, die regulasies in die Bylae uitgevaardig.

**BYLAE**

**Woordomskrywing**

1. In hierdie regulasies beteken "**die regulasies**" die *Regulasies betreffende die registrasie van student tandheelkundige assistente*, afgekondig by Goewermentskennisgewing No. R. 581 van 30 Mei 2008, en het 'n uitdrukking waaraan die regulasies 'n betekenis heg, daardie betekenis, tensy uit die samehang anders blyk.

**Wysiging van Regulasie 2 van die regulasies**

2. Regulasie 2 van die regulasies word hierby gewysig deur subregulasie (2) deur die volgende subregulasie te vervang:-

"(2) in die geval van persone wat vir 'n tydperk van minder as vyf (5) jaar as tandheelkundige assistente gewerk het voor die datum van publikasie van hierdie wysiging, binne vier (4) maande vanaf die datum van publikasie van hierdie wysiging: Met dien verstande dat die registrateur, na vier (4) maande vanaf die datum van publikasie

van hierdie wysiging, nie enige persoon in hierdie subregulasie bedoel, moet registreer  
nie."
