**HEALTH PROFESSIONS ACT, 1974 (ACT NO.56 OF 1974)****REGULATIONS RELATING TO THE SPECIALITIES AND SUBSPECIALITIES IN  
MEDICINE AND DENTISTRY: AMENDMENT**

The Minister of Health has, in terms of section 35 (2) read together with section 61 (1) (f) of the Health Professions Act, 1974 (Act No. 56 of 1974), after consultation with the Health Professions Council of South Africa, made the regulations in the Schedule.

**SCHEDULE****Definitions**

1. In this Schedule "Regulations" means the Regulations published under Government Notice R590 in Government Gazette 22420 of 29 June 2001.

- (c) the insertion before the subspeciality of “Geriatric Psychiatry” of the following subspeciality—

Speciality	Designation
“Geriatric Psychiatry	Geriatric Psychiatrist”

- (d) the insertion before the subspeciality of “Paediatric Surgery” of the following subspeciality

Speciality	Designation
“Neuropsychiatry	Neuropsychiatrist”.
