HEALTH PROFESSIONS ACT, 1974 (Act No. 56 of 1974)

REGULATIONS RELATING TO NAMES THAT MAY NOT BE USED IN RELATION TO THE PROFESSION OF EMERGENCY CARE

The Minister of Health had, under section 61(1)(d) read with section 40 of the Health Professions Act, 1974 (Act No. 56 of 1974), and after consultation with the Health Professions Council of South Africa, made the regulations in the schedule.

SCHEDULE

Definitions

1. In this schedule, "the Act" means the Health Professions Act, 1974 (Act No. 56 of 1974) and any expression or word to which a meaning has been assigned in the Act shall have that meaning, unless the context otherwise indicates.

Names that may not be used

2. No person, who is not registered in terms of the Act as:-
 - (a) Basic Life Support Provider;
 - (b) Intermediate Life Support Provider; or
 - (c) Advanced Life Support Provider in any of the following categories of advanced life support:-
 - i. Paramedic;
 - ii. Emergency Care Technician; and
 - iii. Emergency Care Practitioner,

may use that particular appellation or title or any derivatives thereof.

Repeal

3. The regulations published in Government Notice No. 1213 of 22 October 2004 are hereby

repealed.

BYLAE**Woordomskrywing**

1. In hierdie bylae beteken "die Wet" die Wet op Gesondheidsberoep, 1974 (Wet No. 56 van 1974), en het enige uitdrukking waaraan 'n betekenis in die Wet geheg word, daardie betekenis, tensy uit die konteks anders blyk.

Name waarvan nie gebruik gemaak mag word nie

2. Niemand wat nie ingevolge die Wet geregistreer is nie as—
 - (a) 'n basiese lewensorondersteuningsverskaffer; of
 - (b) 'n intermediêre lewensorondersteuningsverskaffer; of
 - (c) 'n gevorderde lewensorondersteuningsverskaffer in enige van die volgende kategorieë van gevorderde lewensorondersteuning:
 - (i) paramedikus;
 - (ii) noodsorgtegnikus; of
 - (iii) noodsorgpraktisyn,

mag van daardie betrokke benaming of titel of enige afleiding daarvan gebruik maak nie.

Herroeping
