

**REGULATIONS RELATING TO THE PAYMENT OF LEVY AND FEES WITH REGARD TO
COMPULSORY SPECIFICATIONS: AMENDMENTS**

It is hereby made known under section 14(3) (b) of the National Regulator for Compulsory Specifications Act, (Act 5 of 2008), that I, Dr. Rob Davies, the Minister of Trade and Industry, hereby with effect from the **date of publication**, amends Schedule 2 of the Regulations published by Government Notice No. R735 of 14 September 2012 by the deletion of the existing tariffs for Automotive; Chemical, Mechanical and Materials; Electrotechnical; as well as Food and Associated Industries, and the substitution thereof with the tariffs as set out in the Schedule.


