SCHEDULE

Definitions

1. In this Schedule, unless the context indicates otherwise, every word has the same meaning as in the Act and--

"the Act" means the Electoral Act, 1998 (Act No. 73 of 1998); and

"the Regulations" means the Regulations Concerning The Registration of Voters, 1998, published in GN R1340 in Government Gazette No. 19388 of 16 October 1998 as amended by GN R912 in Government Gazette No. 21558 of 6 September 2000 as amended by GN R15 in Government Gazette No. 25894 of 7 January 2004 as amended by GN 847 in Government Gazette No. 27956 of 23 August 2005
