Definitions

1. In this notice "the Notice" means the notices published by Government Notice No. R. 545 of 2 August 2010, as amended by Government Notices Nos. R. 660 of 30 July 2010 and R. 1159 of 10 December 2010.

Amendment of Appendix 1 to the Notice

- 2. Appendix 1 to the Notice is hereby amended by the addition of the following item after item 26:
- **"27.** The construction of facilities for the treatment of effluent, wastewater or sewage with a daily throughput capacity of 15000 cubic metres or more.".
