

**DIAMOND ACT (ACT NO. 56 OF 1989) AS AMENDED
AMENDMENT OF REGULATIONS**

I, Advocate Ngoako Ramatlhodi, MP, Minister of Mineral Resources, after consultation with the South African Diamond and Precious Metals Board and in concurrence with the National Treasury in terms of section 95 of the Diamond Act (Act No. 56 of 1989) as amended hereby make the regulations in the Schedule.

SCHEDULE

Definitions

1. In the regulations “the Regulations” means the regulations published under Government Gazette No. R.680 dated 01 April 1987, as amended by Government Notice R.462 under Government Gazette 19930, dated 16 April 1999, Government Notice R1361 under Government Gazette 24008, dated 01 November 2002, Government Notice R.519 under Government Gazette 24740, dated 11 April 2003, Government Notice R.569 under Government Gazette 30061, dated 09 July 2007, Government Notice R.295 under Government Gazette 30123, dated 27 July 2007, Government Notice R.386 under Government Gazette 30942, dated 04 April 2008.

Amendment of Fees and Penalties

- 2.1 Regulation 10 of the Regulations is hereby amended as set out in annexure A hereto by deleting the amounts in column 5 and substituting them with the amounts in column 6 in respect of the fees payable in terms of the regulations in column 2.
- 2.2 Regulation 14 is hereby amended by the insertion of the following subsection:

“(d) in the case of an offence referred to in Regulation 13 (4), to a fine not exceeding R 500.00, or to imprisonment for a period not exceeding one month”.

Commencement

3. These regulations shall come into operation on the date of publication hereof.
