HEALTH PROFESSIONS ACT, 1974 (ACT NO.56 OF 1974)

REGULATIONS RELATING TO THE QUALIFICATIONS WHICH ENTITLE PSYCHOLOGISTS TO REGISTRATION: AMENDMENT

The Minister of Health intends, in terms of section 24 of the Health Professions Act, 1974 (Act No. 56 of 1974) and on the recommendation of the Health Professions Council of South Africa, to make the regulations in the Schedule.

Interested persons are invited to submit any substantiated comments in writing on the proposed amendments to the Director-General: Health, Private Bag X828, Pretoria, 0001 (for the attention of the Director: Public Entities Governance and Management), within three months from date of publication of this notice.

SCHEDULE

Definitions

1. In these regulations, "**the regulations**" means regulations relating to the qualifications which entitle psychologists to registration published under Government Notice R554 in *Government Gazette* 22390 of 22 June 2001, and any word or expression to which a meaning has been assigned in the regulations, shall have that meaning, unless the context otherwise indicates.

Amendment of regulation 2 of the regulations

2. Regulation 2 of the regulations is hereby amended, by -
- (a) the insertion, after the words "Counselling Psychology", of the words "Forensic Psychology and Neuropsychology"; and
- (b) the addition of the following qualifications:


