CALL FOR NOMINATIONS FOR MEMBERS OF THE SOUTH AFRICAN NURSING COUNCIL (2023 – 2028 TERM OF OFFICE)

The South African Nursing Council (SANC) is a statutory body established in terms of section 2 of the Nursing Act, 2005 (Act No. 33 of 2005) ("the Act") to regulate the nursing profession in a bid to protect the interests of the healthcare users.

The Honourable Minister of Health, **Dr MJ Phaahla** hereby invites nominations of suitable candidates to serve as Members of SANC in terms of section 5 of the Act, for a period of five (5) years with effect from **23 August 2023**, in the following categories:

- (a) fourteen (14) Professional Nurses or Midwives registered in terms of section 31(1)(a) and (b) of the Act, taking into account their expertise in nursing education, advanced midwifery, primary health care, occupational health and mental health;
- (b) one person with special knowledge of the law (preferably ethics and governance specialist);
- (c) one person with special knowledge of financial matters (preferably with financial management and health economics expertise);
- (d) one person with special knowledge of pharmacy;
- (e) one person with special knowledge of education (higher education);
- (f) one person with knowledge of consumer affairs;
- (g) three community representatives;
- (h) one (1) staff nurse registered in terms of section 31(1)(c) of the Act; and
- (i) one (1) auxiliary nurse registered in terms of section 31(1)(d) of the Act.

Remuneration: Successful candidates will be remunerated under Category A, subcategory A2 as published by the National Treasury. Employees of National, Provincial and Local Government, government agencies or entities, appointed as Council members of SANC are not entitled to additional remuneration without prior approval, and will not be remunerated for their service as members of the Council.

Nomination particulars: Nominations must be made on a prescribed nomination form obtainable from the South African Nursing Council website: www.sanc.co.za or Department of Health website at www.health.gov.za under VACANCIES. Kindly note that the nomination form also outlines the requirements, disqualification criteria and the remuneration of members of the SANC.

Closing date: 24 March 2023 at 16h00.
