SOCIAL ASSISTANCE ACT, 2004: AMENDMENT OF REGULATIONS RELATING TO COVID-19 SOCIAL RELIEF OF DISTRESS ISSUED IN TERMS OF SECTION 32, READ WITH SECTION 13, OF THE SOCIAL ASSISTANCE ACT, 2004 (ACT NO. 13 OF 2004), AS AMENDED

I, Lindiwe Zulu, Minister responsible for Social Development, under Section 32(1) and (2), read with section 13 of the Social Assistance Act, 2004 (Act No.13 of 2004), and with the concurrence of the Minister of Finance, hereby make amendments to the Regulations relating to Covid-19 Social Relief of Distress as set out in the Schedule.

SCHEDULE

In these regulations "Regulations" means the regulations published in the Government Notice No. R. 2042 of 22 April 2022, as amended by Government Notice No. R. 2381 of 16 August 2022.

Amendment of regulation 5 of Regulations

1. Regulation 5 of the Regulations is hereby amended by the substitution for sub-regulations (1) and (3) of the following sub-regulations:

"(1) The monthly amount of the Covid-19 Social Relief of Distress is R350 per person and is payable for the months in the period 1 April [2022] 2023 to 31 March [2023] 2024".

"(3) The payments in terms of these regulations-

- (a) are limited to the amount appropriated for the [2022/2023] 2023/2024 financial year to the vote of Social Development for social relief of distress; and
- (b) may only be made in respect of applications, made during the period 1 April 2022 to 31 March [2023] 2024, and approved by the Agency".

Short title and Commencement

2. These Regulations are called Social Assistance Act, 2004: Regulations Relating to COVID-19 Social Relief of Distress and take effect on 01 April 2023 by publication of this notice in the Gazette.
