PROCLAMATION

BY HIS ROYAL HIGHNESS THE HIGH COMMISSIONER.

Whereas the South African Stud Book Association has been incorporated in the Union of South Africa under the Registration of Pedigree Live Stock Act, 1920 (No. 22 of 1920) (herein after referred to as "the said Act");

And whereas it is expedient to confer certain rights on the said Association in the territory of Basutoland (herein after referred to as "the territory") and to make provision for the protection of such rights and for matters relating thereto;

Now therefore under and by virtue of the powers in me vested I do hereby declare, proclaim and make known as follows:

- 1. The South African Stud Book Association shall have the
 - (a) to register pedigrees of farm live stock bred in or imported
 - into the territory;

 (b) to the exclusion of any other person or body of persons in the territory to issue certificates of registration of pedigrees of farm live stock and to publish such pedigrees in the form of stud, herd or flock books.
- 2. Rights similar mutatis mutandis to those conferred on the Association under the preceding section may be conferred by the High Commissioner by notice in the Gazette on any breed record Society or live stock Society which is incorporated in the Union of South Africa, and is affiliated to the Association.
- 3. In the event of the Association or any Society on which rights have been conferred under section two of this Proclamation having its certificate of incorporation cancelled or suspended under the provisions of the said Act, the High Commissioner may confer the rights held by the Association or by such Society in the territory on such person or body of persons for such period and subject to such conditions as he may think fit.
 - 4. Any person who

 (a) makes any false statement in relation to the pedigree of any farm live stock intended for registration with the Association, knowing that statement to be false; or

 (b) wilfully or registration which is necessarily required for the proper registration with the Association of the pedigree of any farm live stock,

shall be guilty of an offence and liable on conviction to a fine not exceeding one hundred pounds, or, in the discretion of the Court, to imprisonment without the option of a fine for a period not exceeding six months or to both such fine and such imprisonment.

Any person who, or body of persons which, issues any certificate purporting to register or to state the pedigree of any farm live stock, or which publishes in any form such pedigrees and thereby infringes the exclusive right conferred by this Proclamation on the Association shall be guilty of an offence and liable on conviction to a fine not exceeding five hundred pounds.

The exclusive privileges conferred by this Proclamation upon the Association shall not be construed as preventing an owner of farm live stock which has not been registered with the Association from stating in writing or otherwise the pedigree of such live stock; provided that if he makes a false statement as to such pedigree, knowing it to be false, he shall be guilty of an offence and liable on conviction to a fine not exceeding one hundred pounds, or, in the discretion of the Court, to imprisonment without the option of a fine for a period not exceeding six months, or to both such fine and such imprisonment.

AUSTRO-HUNGARIAN BANK-NOTES.

Holders of currency notes issued by the Austro-Hungarian Bank are referred to Article 206 of the said Treaty, which contains provisions for the liquidation of the Austro-Hungarian Bank by receivers especially appointed for that purpose by the Reparation Commission. All such currency notes held in Basutoland, the Bechuanaland Protectorate, or Swaziland should be lodged with the Controller of the Local Clearing Office, care of the Government Secretary, Maseru, Mafeking, or Mbabane, as the case may be, not later than the 15th April next for delivery to the Reparation Commission.

In order to identify the notes, a memorandum stating the name and address of the holder, the distinctive number, and denomination of each note; and whether it was held in Basutoland, the Bechuanaland Protectorate, or Swaziland, as the case may be, by the person now holding it before the 15th June, 1919, should be attached in every case. The attention of holders of these notes is drawn to Clause 4 of the Annex to Article 206 of the above Treaty, which states that no notes issued on or prior to 27th October, 1918, wherever they may be held, will rank as claims against the Bank unless they are presented through the Governments of the country in which they are held.

Holders of bonds and notes are reminded that delay in delivering their securities to the Local Clearing Office may be prejudicial to them, especially as the liquidation of the Austro-Hungarian Bank has already commenced.
