#### SWAZILAND GOVERNMENT NOTICE.

Under and by virtue of the powers vested in me by Regulation No. 16 of the regulations published under High Commissioner's Notice No. 130 of 1918, as amended by High Commissioner's Notice No. 24 of 1923, issued under the Swaziland Diseases of Stock Proclamation, No. 43 of 1918:—

I hereby order that every owner of sheep and goats in the districts of Swaziland mentioned in the Schedule to this notice shall cause the same to be dipped twice, with an interval of eight to ten days between the dippings, in an approved lime and sulphur dip; and I further order that the dippings shall be completed by the 31st May, 1924.

This order shall have effect from and after the date of its publication in the Gazette. Failure to comply with this order will render the owner liable to the penalties provided under sections sixty-five and sixty-six of the Diseases of Stock Regulations (High Commissioner's Notice No. 130 of 1918),

#### SCHEDULE.

Mbabane.—The whole of the district, with the exception of the portion east of a straight line drawn from Kamhlabana Kop to Beacon L of Native Area No. 5, on the Komati River, west of Madhlangampisi's Kraal, near Balegane.

Mankaiana.—The whole of the district.

Hlatikulu.—All that portion west of a straight line drawn from the junction of the Mpapat Spruit with the Great Usutu River to the point where the Manzawayo River crosses the Transvaal-Swaziland border in the south.
