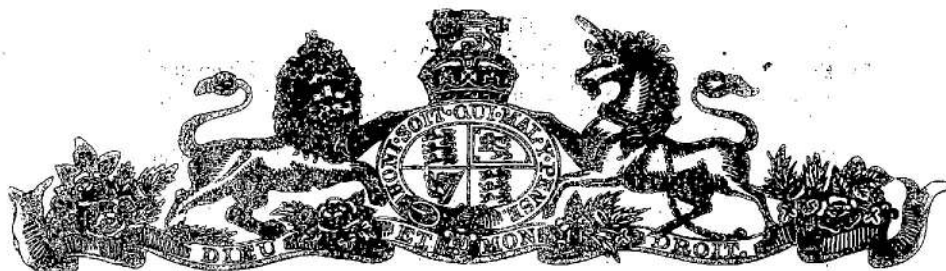

### PROCLAMATION

By His Excellency the High Commissioner.

Whereas by sub-section (1) of section one of the Swaziland Consolidated Loan Proclamation 1910 provision is made for the repayment to the Government of Basutoland of the Consolidated Loan of Eighty Thousand Pounds within a period of twenty-five years from the first day of April 1910;

And whereas under the provisions of section four of the said Proclamation sums amounting to forty-five thousand pounds have been paid by the Resident Commissioner of Swaziland to the Resident Commissioner of Basutoland;

And whereas it has been agreed between the two Governments that the period for repayment of the balance of the Consolidated Loan (namely, thirty-five thousand pounds) shall on certain terms and conditions be extended from the first day of April 1935 to the first day of April 1943:

And whereas it is expedient to repeal Proclamation No. 21 of 1910:

Now therefore under and by virtue of the powers, authorities and jurisdiction conferred upon and committed to me under the Swaziland Order-in-Council 1903 as amended by the Swaziland Order-in-Council 1906 and the Swaziland Order-in-Council 1909, I do hereby declare, proclaim and make known as follows:—

1. For the purposes of section one of the Swaziland Consolidated Loan Proclamation 1910 (herein after referred to as the principal law) the consolidated loan shall be deemed, as from the first day of April 1924, to amount to thirty-five thousand pounds and *mutatis mutandis* to be repayable as provided in the principal law within a period of nineteen years from the said date.

2. For the purposes of section three of the principal law the sum to be set aside on the first day of April 1924 and on the first day of April in each following year shall be not less than three pounds twelve shillings and threepence per cent. on the total nominal amount of the loan from time to time remaining unpaid.

3. Except as otherwise provided by this Proclamation the provisions of the principal law shall *mutatis mutandis* apply to the reduced Consolidated Loan.

4. Proclamation No. 21 of 1910 shall be and is hereby repealed.

5. This Proclamation may be cited as the Swaziland Consolidated Loan (Amendment) Proclamation 1924 and shall have force and take effect from the first day of April 1924.

### PROCLAMATION

By His Excellency the High Commissioner.

Whereas by Proclamation No. 2 (Swaziland) of 1906, it was provided that the Game Preservation Ordinance 1905 of the Transvaal should be deemed to be law within the Territory of Swaziland from the 6th day of April 1906;

And whereas by sub-section (b) of section three of the said Ordinance it is provided that it shall be lawful by Proclamation to prescribe a list of birds and animals to be protected throughout the year for a period to be specified (not exceeding three years);

And whereas it is expedient to repeal Proclamation No. 1 (Administration) of 1923;

Now, therefore, under and by virtue of the powers and authorities in me vested by sub-section (b) of section three of the said Ordinance and sub-section (2) of section two of the Swaziland Administration Proclamation 1907, I do hereby declare proclaim and make known as follows:—

1. Proclamation No. 1 (Administration) of 1923 shall be and is hereby repealed.

2. The birds and animals mentioned in the first column of the Schedule to this Proclamation shall for the period mentioned in the second column thereof be protected and not destroyed in the districts set opposite the names of such animals in the third column of the said Schedule.

3. This Proclamation shall have force and take effect from the date of its publication in the *Gazette*.
