Whereas it is expedient further to amend Proclamation No. 24 of 1911 which provides in the interests of the natives for the creation of a special fund and the imposition of a tax the proceeds of which shall be paid into such fund, and which as amended by Proclamation No. 32 of 1911 is herein after referred to as the principal law:

Now therefore under and by virtue of the powers authorities and jurisdiction conferred upon and committed to me by His Majesty under the Swaziland Order-in-Council 1903 as amended by the Swaziland Order-in-Council 1906 and the Swaziland Order-in-Council 1909 I do hereby declare proclaim and make known as follows:

1. Section four of the principal law shall be and is hereby amended by the deletion of all the words following after the word "Equator" in that section.

2. This Proclamation shall be read as one with the principal law and shall have force and take effect from the date of its publication in the Gazette.
