PROCLAMATION

BY HIS EXCELLENCY THE HIGH COMMISSIONER.

Whereas it is desirable to make provision out of the public revenue or other funds of Basutoland for the service of the year ending the 31st day of March 1925.

Now therefore under and by virtue of the powers in me vested I do hereby declare, proclaim and make known as follows:—

- 1. The public revenue or other funds of Basutoland are hereby charged towards the service of the year ending the 31st day of March, 1925, with a sum of £252,782 (two hundred and fifty-two thousand seven hundred and eighty-two pounds).
- 2. The moneys granted by this Proclamation shall be applied to the purposes and services set forth in the Schedule annexed hereto and more particularly specified in the Estimates of Expenditure of Basutoland for the year ending the 31st day of March, 1925, submitted to and approved by the Secretary of State for the Colonies.
- 3. The moneys granted by this Proclamation shall not be issued or applied to any use, intent or purpose other than the particular services to which the said amounts have been granted respectively by this Proclamation.
- 4. This Proclamation may be cited as the Basutoland Appropriation Proclamation 1924, and shall have force and take effect from the first day of April, 1924.

PROCLAMATION

BY HIS EXCELLENCY THE HIGH COMMISSIONER.

Whereas it is desirable to make provision for preventing the introduction into the Bechuanaland Protectorate (herein after called "the territory") and the spread therein of infectious or contagious disease and for preserving the public health therein;

Now therefore under and by virtue of the powers in me vested I do hereby declare proclaim and make known as follows:—

1. The Resident Commissioner may subject to the approval of the High Commissioner from time to time make regulations for the purpose of preventing the introduction into or dissemination within the territory of any infectious or contagious disease, and in particular but without prejudice to the generality of the power hereby conferred, such regulations may provide—

(a) for regulating restricting or problibition the entry into a respective conferred.

(a) for regulating restricting or prohibiting the entry into or departure from the territory or the movement from one part of the territory to another of any person or any specified class or description of persons;
(b) for regulating restricting or prohibiting the introduction into the territory or the transport from one part of the territory to another of any animal or thing;
(c) for the medical examination detention quarantine disinfection vaccination inoculation isolation or surveillance of persons or specified classes of persons residing in or entering or leaving the territory or the examination detention or disinfection of animals articles or things;
(d) for declaring and establishing ports of entry for the purpose of such regulations and for closing any or all of the borders of the territory for such period as the Resident Commissioner may deem necessary or advisable.
2. (1) The Resident Commissioner may subject to the approval

2. (1) The Resident Commissioner may subject to the approval of the High Commissioner from time to time make local public health regulations for such local areas within the territory as are not subject to public health regulations and may in such regulations define the limits of such areas and may, subject to the like approval, for the purpose of defraying any expenditure necessary for carrying out such regulations from time to time make orders imposing local rates in respect of the ownership or occupation of property within such areas or requiring the payment of fees for services rendered.

(2) Local regulations made under this section may provide for

(2) Local regulations made under this section may provide for the regulation of sanitation, water supply, and the sale of food or other articles and for the prevention and control of infectious diseases, and for such other matters as may be considered necessary by the Resident Commissioner in the interests of public health.

(3) Every regulation or order made under this section shall, when approved by the High Commissioner, be published in the Gazette and shall thereupon have the force of law within the area for which it is made.

3. Any medical officer or any person duly authorized thereto in writing under any regulations made in pursuance of this Proclamation may enter at any time by day upon any premises for any purpose authorized by any such regulation.

4. Any person who shall contravene or aid or abet the contravention of any regulation made under this Proclamation or of any order issued under any such regulation or who shall wilfully obstruct or resist the lawful exercise of any of the powers conferred by this Proclamation or any such regulation shall be guilty of an offence and shall be liable on conviction to a fine not exceeding ten pounds or in default of payment to imprisonment with or without hard labour for a period not exceeding six months.

5. This Proclamation may be cited as the Public Health (Bechuanaland Protectorate) Proclamation 1924 and shall have force and take effect from the date of its publication in the Gazette.

PROCLAMATION

BY HIS EXCELLENCY THE HIGH COMMISSIONER.

Whereas it is expedient further to amend Proclamation No. 1 B, 1889, dated the 1st day of November 1889 as amended by Proclamation No. 25 of 1913;

Now therefore under and by virtue of the powers in me vested I do hereby declare proclaim and make known as follows:—

1. In any civil case coming before him in which only Europeans are parties the Resident Commissioner may associate with himself, in place of or in addition to any European officer or officers, an advocate of the Supreme Court of South Africa as a member of the Combined Court constituted by section one of Proclamation No. 1 B, 1889, dated the 1st day of November 1889, as amended by Proclamation No. 25 of 1913; provided that the provisions of the said Proclamation as amended shall otherwise be of full force and effect.

2. This Proclamation shall have force and take effect from the date of its publication in the Gazette.

BECHUANALAND PROTECTORATE PUBLIC HEALTH REGULATIONS.

1. Where deemed necessary for preventing the spread of plague, the Resident Commissioner may—

e Resident Commissioner may—

(a) issue instructions for the regulation, restriction, or prohibition of the entry into or departure from the Bechuanaland Protectorate (herein after referred to as "the territory") or the movement from one part of the territory to another of any person or persons;

(b) order the prohibition of the issue of passes to any person or persons to proceed to any area which may be known to have become infected with plague;

(c) order the detention of any person or persons known or suspected to have entered the territory from any area infected with plague, and order such person to be examined forthwith by a medical practitioner;

(d) order the examination, detention, or disinfection of animals, articles, or things known or suspected to have come from any area infected with plague.

2. Any person suffering or suspected to be suffering from typhus

any area infected with plague.

2. Any person suffering or suspected to be suffering from typhus fever, smallpox, or plague (whether bubonic or pneumonic) may on the order of a resident magistrate be quarantined or removed to a hospital or place of isolation and there detained.

3. Every person having charge of a case or suspected case of typhus fever, smallpox, or plague (whether bubonic or pneumonic), which is not under treatment in hospital shall cause the premises and the body clothing, bedding, and effects of the patient to be cleaned and kept in a cleanly condition and, where the patient is suffering or is suspected of suffering from typhus, free from yermin, and shall not permit any person not being a medical or nursing or other necessary attendant to enter the room of or otherwise come in contact with the patient during the illness.

4. Any person who has been, or is suspected of having been, exposed to the infection of typhus, smallpox, or plague (whether bubonic or pneumonic) may, on the order of a resident magistrate, be quarantined or placed under observation or surveillance until considered free from infection.

5. Any person quarantined, detained in a hospital or place of isolation or placed under observation or surveillance under these regulations shall, for so long as he is required to submit to such quarantining, detention, observation, or surveillance, comply with all orders given by a resident magistrate, or by any officer or person appointed in writing by a resident magistrate to assist in carrying out these regulations, for the purpose of rendering effective such quarantining, detention, observation, or surveillance, and any remedial treatment provided in connection therewith.

6. Where deemed necessary for preventing the spread of typhus, smallpox, or plague (whether bubonic or pneumonic), a resident magistrate may issue an order prohibiting the convening or holding of any meeting, assembly, or public gathering of any nature whatsoever, and any person attending or taking part in, or attempting to attend or take part in any meeting, assembly, or public gathering in respect of which such an order has been issued shall be deemed to be guilty of a contravention of such order unless he proves that he was not aware that such order had been issued.

7. It shall be lawful for a resident magistrate to issue orders regulating or restrictions on, the movements of all persons, or of persons of any particular class or description, into or out of any area in which typhus, smallpox, or plague (whether bubonic or pneumonic) exists or is suspected to exist.

8. Every chief and every headman of a village shall restrict the movements of or detain all persons under them in such a manner as the resident magistrate of the district concerned or any officer of police or any other duly authorized officer may direct.

9. These regulations shall have force and take effect from the date hereof, and may be withdrawn at any time by notice in the Gazette.
