#### HIGH COMMISSIONER'S NOTICE No. 49 of 1924.

It is hereby notified for general information that His Excellency the High Commissioner has been pleased to approve the following further amendments in the regulations for the prevention of scab in Basutoland published under High Commissioner's Notice No. 18 of 1923:

- 1. The following shall be added to section 2:-
- "Dip supervisor" shall mean and include any native assistant regularly employed with and working under the control and supervision of an inspector, and shall include a native in charge of a Government dipping tank.

  2. The words "or dip supervisor" shall be added after the word "inspector" wherever it occurs in sections 5, 9, 10, 11, 12, 13, and 15.
