PROCLAMATION

[13]5650 117741 -

BY HIS EXCELLENCY THE HIGH COMMISSIONER.

Whereas it is desirable to make further provision in respect of the penalties prescribed under the Basutoland Stock and Produce Theft Repression Proclamation, 1921, hereinafter called the principal law;

Now therefore under and by virtue of the powers in me vested I do hereby declare proclaim and make known as follows:---

1. Where any male person has been committed for trial under section seventeen or section eighteen of the principal law and has been convicted before the Court of the Resident Commissioner of the theft of stock or produce the Court may in addition to any other penalty and notwithstanding anything contained in Regulation No. 14 promulgated under the High Commissioner's Proclamation No. 28 of the twenty-ninth day of May 1884 impose a penalty of whipping not exceeding fifteen strokes.

2. This Proclamation shall be read as one with the principal v and shall have force and take effect from the date of its publication in the Gazette.
