PROCLAMATION

BY HIS EXCELLENCY THE HIGH COMMISSIONER.

Whereas it is desirable to make further provision out of the public revenue and other funds of Basutoland to meet certain additional expenditure incurred during the year which ended the 31st day of March, 1924;

Now therefore under and by virtue of the powers in me vested 1 do hereby declare, proclaim and make known as follows:---

- 1. The public revenue or other funds of Basutoland are hereby charged with a further sum of £5,520. 12s. 10d. (five thousand five hundred and twenty pounds twelve shillings and tenpence) to meet expenditure incurred during the year which ended the 31st day of March, 1924, in excess of the amounts appropriated for that purpose according to the particulars set forth in the Schedule to this Proclamation.
- 2. This Proclamation may be cited as the Basutoland Further Appropriation (1923-1924) Proclamation of 1924, and shall have force and take effect from the date of its publication in the Gazette.

PROCLAMATION

BY HIS EXCELLENCY THE HIGH COMMISSIONER.

Whereas it is expedient to amend the Public Roads Proclama-

Now therefore under and by virtue of the powers in me vested I do hereby declare, proclaim and make known as follows:--

1. (1) This 'Proclamation shall be of force and effect within those portions of the Bechuanaland Protectorate (herein after called the said Protectorate) which are known as the farm Panyane or

Ramathlabama's Kuil, the farm Hildavale, the farm Crocodile Pools, the farm Forest Hill, the farm Traquair, the Lobatsi Block, the Gaberones Block, the Gaberones Crown Reserve, and the Tati District, excepting such portions thereof as are assigned to or specifically set apart for the occupation of natives.

- (2) The High Commissioner may by notice in the Gazette from time to time specify other areas within the said Protectorate to which the provisions of this Proclamation shall apply and the said provisions shall apply accordingly within such areas from the date of the respective notices.
- 2. (1) It shall not be lawful to draw or trail any sledge, timber, or other heavy material upon any public road notified as such by notice of the Resident Commissioner in terms of section one of the Public Roads Proclamation 1907.
- (2) Any person contravening the provisions of this Proclamation shall be liable on conviction to a fine not exceeding two pounds or in default of payment to imprisonment with or without hard labour for any period not exceeding two months.
- 3. This Proclamation may be cited as the Public Roads Proclamation 1907 Amendment Proclamation 1924, and shall have force and take effect from the date of its publication in the Gazette.

Whereas it is expedient to proclaim certain portion of land in Swaziland to be Crown land;

Now therefore under and by virtue of the powers, authorities and jurisdiction conferred upon and committed to me by His Majesty under the Swaziland Order-in-Council 1903 as amended by the Swaziland Order-in-Council 1906 and the Swaziland Order-in-Council 1909 and by virtue of the further authority conferred upon me under the Swaziland Crown Lands and Minerals Order-in-Council 1908, as amended by the Swaziland Crown Lands and Minerals Amendment Order-in-Council 1910, I do hereby declare proclaim and make known as follows:—

The area of land in Swaziland described in the Schedule to this Proclamation shall, from the date of the publication of this Proclamation in the Gazette be Crown land and shall be registered and known as Lot No. 209 District Hlatikulu, Swaziland; provided always that the proclamation of the said area a Crown land shall not affect any concession lease servitude or other right subsisting in respect of the said area which is registered at the date of such publication and is not vested in the Crown.
