## PROCLAMATION

BY HIS EXCELLENCY THE HIGH COMMISSIONER.

Whereas it is expedient further to amend the Basutoland Medical Dental and Pharmacy Proclamation, 1921 (hereinafter referred to as "the said Proclamation");

Now therefore under and by virtue of the powers in me vested I do hereby declare, proclaim and make known as follows:—

follows:

- Section nine of the said Proclamation shall be and is hereby repealed and the following substituted therefor:—
  - "9. Notwithstanding anything contained in this Proclamation any member of any recognised missionary society certified as such by the Assistant Commissioner of the district in which such member resides shall be permitted without being registered as provided in this Proclamation to prescribe drugs and afford medical and surgical aid provided that such member has—
    - (a) been certified by the Principal Medical Officer, or any Medical Officer of the Basutoland Government
    - any Medical Officer of the Basutoland Government as possessing the requisite qualifications or know-ledge to prescribe drugs and to render such medical and surgical aid; and

      (b) that such member shall supply such drugs and afford such medical and surgical aid without any fee or reward exceeding one shilling for each supply of drugs and a like amount for each such attendance."
- 2. This Proclamation may be cited as the Basutoland Medical Dental and Pharmacy (Further Amendment) Proclamation 1934, and shall have force and take effect from the date of its publication in the Gazette.

#### PROCLAMATION

By HIS EXCELLENCY THE HIGH COMMISSIONER.

Whereas it is desirable to make provision out of the public revenue or other funds of Swaziland for the service of the year ending on the 31st day of March, 1935.

Now therefore under and by virtue of the powers, authorities and jurisdiction conferred upon and committed to me by His Majesty under the Swaziland Order-in-Council 1903 as amended by the Swaziland Order-in-Council 1906 and the

Swaziland Order-in-Council 1909, I do hereby declare, proclaim and make known as follows:-

- 1. The public revenue or other funds of Swaziland are hereby charged towards the service of the year ending on the 31st day of March, 1935, with a sum of £115,511 (one hundred and fifteen thousand five hundred and eleven pounds).
- 2. The moneys granted by this Proclamation shall be applied 2. The moneys granted by this Proclamation shall be applied to the purposes and services set forth in the Schedule hereto annexed and more particularly specified in the Estimates of the Expenditure of Swaziland for the year ending on the 31st day of March, 1935, submitted to and approved by the Secretary of State for Dominion Affairs.
- 3. The moneys granted by this Proclamation shall not be issued or applied to any use, intent or purpose other than the particular service to which the said amounts have been granted respectively by this Proclamation.
- 4. This Proclamation may be cited as the Swaziland Appropriation Proclamation 1934, and shall have force and take effect from the 1st April, 1934.

Whereas by treaty, grant, usage, sufferance, and other lawful means, His Majesty has power and jurisdiction within the territories mentioned in the Schedule to this Order:

And whereas certain persons who are regarded as belonging to those territories are afforded His Majesty's protection, and are known as British protected persons:

And whereas it is expedient to define in relation to those territories the persons who are so regarded as belonging thereto:

Now. therefore, His Majesty, by virtue and in exercise of the powers in that behalf by the Foreign Jurisdiction Act, 1890, or otherwise, in His Majesty vested, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:—

1. In this Order, unless the context otherwise requires, the expression "the territory" means any territory mentioned in the Schedule to this Order.

2. The following persons shall be regarded as belonging to the territory:—

the territory:-

(a) any person born (whether before or after the entry into

(a) any person born (whether before or after the entry into force of this Order) within the territory who is not, at the time of his birth, a British subject, and who does not, at the time of his birth, possess under the law of some other State the nationality of such State;
(b) any person born (whether before or after the entry into force of this Order) out of the territory who is not, at the time of his birth, a British subject and does not possess under the law of some other State the nationality of such State and whose father was, at the time of that person's birth, a person who under this Order is regarded as belonging to the territory and was himself born within the territory;
Provided that any person born after the death of his father

was himself born within the territory;

Provided that any person born after the death of his father (whether before or after the entry into force of this Order) shall be regarded as belonging to the territory if he would, if born before his father's death, have been so regarded.

3. The wife of a person who under this Order is regarded as belonging to the territory shall be regarded as belonging to the territory if she has, with the permission of the Government, become resident with her husband in the territory, and is not a British subject and does not possess the nationality of any other State.

4. A person who under this Order is regarded as belonging to the territory and who

(a) becomes a British subject; or

(a) becomes a British subject; or

(a) becomes a British subject; or
(b) not being a married woman, minor, lunatic, or idiot, by some voluntary and formal act, acquires the nationality of a State in which he is resident; or
(c) being the wife or minor child of a person who ceases to be regarded as belonging to the territory under paragraph (b) of this Article, acquires the nationality of some other State; or
(d) being the wife of a national of some other State, acquires the nationality of her husband,

shall thereupon cease to be regarded as belonging to the

territory.
5. This Order may be cited as the British Protected Persons Order, 1934. M. P. A. HANKEY.
