PROCLAMATION

Now therefore under and by virtue of the powers in me vested I do hereby declare, proclaim and make known as follows:—

1. Sub-section (1) of section twenty-nine of the said Proclamation shall be and is hereby amended by the deletion of the words "sole right to prospect thereon" and the substitution therefor of the words "right to prospect in terms thereof".

2. This Proclamation shall be deemed to have had force and to have taken effect from the date of the taking effect

of the said Proclamation.
