# PROCLAMATION

By His Excellency the High Commissioner.

Whereas it is deemed expedient to amend the Intestacy Law of the Bechuanaland Protectorate: Now therefore under and by virtue of the powers in me vested I do hereby declare, proclaim and make known as follows :-

- 1. The surviving spouse of every person married out of community of property who after the commencement of this Proclamation dies either wholly or partly intestate is hereby declared to be an intestate heir of the deceased spouse according to the following rules:—
  - If the deceased spouse leaves any descendant who is entitled to succeed ab intestato the surviving spouse shall succeed to the extent of a child's share or to so much as does not exceed six hundred pounds in value,
  - whichever is the greater.

    (b) If the deceased spouse leaves a parent or a brother or sister whether of the full or half-blood who is entitled so to succeed, the surviving spouse shall succeed to the extent of one-half share or to so much as does not exceed six hundred pounds in value, whichever is the greater.

(c) In any case not covered by paragraph (a) or (b) the surviving spouse shall be the sole intestate heir.

2. Paragraph (4) of section four of Proclamation No. 4 of 1895 shall apply to any succession accruing to a surviving

1895 shall apply to any succession accruing to a surviving spouse under the provisions of this Proclamation.

3. This Proclamation may be cited for all purposes as the "Bechuanaland Protectorate Succession Proclamation, 1934", and shall have force and take effect from the date of its publication in the Gazette.

#### **PROCLAMATION**

BY HIS EXCELLENCY THE HIGH COMMISSIONER.

Whereas it is expedient to proclaim certain portions of land in Swaziland to be Crown lands;

Now therefore under and by virtue of the powers, authorities and jurisdiction conferred upon and committed to me by His Majesty under the Swaziland Order-in-Council 1903 as amended by the Swaziland Order-in-Council 1906 and the Swaziland Order-in-Council 1909 and by virtue of the further

authority conferred upon me under the Swaziland Crown Lands and Minerals Order-in-Council 1908, as amended by the Swaziland Crown Lands and Minerals Amendment Order-in-Council 1910, I do hereby declare, proclaim and make known

The areas of land in Swaziland described in the Schedule to this Proclamation shall, from the date of the publication of this Proclamation in the Gazette be Crown lands and shall be registered and known as numbered in the said Schedule, provided always that the proclamation of the said areas as Crown land shall not affect any concession lease servitude or other right subsisting in respect of the said areas which is registered at the date of such publication and is not vested in the Crown.

#### **PROCLAMATION**

BY HIS EXCELLENCY THE HIGH COMMISSIONER.

Whereas it is expedient further to amend the Basutoland Income Tax Proclamation, 1920 as amended (hereinafter referred to as "the principal Proclamation") and to fix the rates of normal tax and super tax in respect of the twelve months ended the thirtieth day of June, 1934;

Now therefore under and by virtue of the powers in me vested I do hereby declare, proclaim and make known as follows:—

follows : -

- 1. Section seven of the principal Proclamation shall be and is hereby amended by the deletion of the whole of the paragraph (a) of sub-section (2) and the substitution therefor of the following new paragraph (a):—
  - "(a) A sum of four hundred pounds."
- 2. In terms of sub-section (3) of section five of the principal Proclamation there shall be levied in respect of every taxable income (as in the principal Proclamation defined) accrued to

or in favour of any person during the twelve months ended on the thirtieth day of June, 1934, an income tax (referred to in the principal Proclamation as normal tax) at the rates specified in section two of the Basutoland Income Tax Proclamation, 1932.

- 3. In terms of sub-section (4) of section eighteen of the principal Proclamation there shall be levied in respect of every income subject to super tax (as defined in section nuneteen of the principal Proclamation) which shall have accrued to or in favour of any person other than a public company during the twelve months ended on the thirtieth day of June, 1934, a super tax at the rates specified in section twenty-three of the principal Proclamation as amended by section seven of the Basutoland Income Tax Further Amendment Proclamation, 1921.
- 4. This Proclamation may be cited for all purposes as the Basutoland Income Tax Proclamation 1934 and shall have force and take effect from the date of its publication in the Gazette; Provided that the amendments to the principal Proclamation shall first take effect in respect of assessments made for the year of assessment ended on the thirtieth day of June, 1934.

#### HIGH COMMISSIONER'S NOTICE No. 147 of 1934.

It is hereby notified for general information that, under and by virtue of the powers in him vested by section two of the Swaziland Diseases of Stock Proclamation, 1933, His Excellency the High Commissioner has been pleased to amend the regulations published under High Commissioner's Notice No. 173 of 1933, by the addition to Regulation No. 26 of the following paragraph:-

following paragraph:—

"It shall be the duty of every owner of cattle, in the event of the death of any cattle from any cause, whether or not he has reason to suspect that the cattle were suffering or died from any disease, to take blood-smears from the animal as soon as possible, and not later than twelve hours after death, or to take the kidneys or spleen of the dead animal to the nearest Assistant Commissioner, police post, stock inspector or native cattle guard in charge of the nearest cattle dipping-tank, who shall make the blood smears and forward them in the speediest manner possible, to the nearest Assistant Commissioner, police post, or stock inspector, who shall forward the smears at once to the proper place for examination.

Blood-smears should be taken from the spleen, kidneys, or lymphatic glands, except in the case of suspected anthrax, when it should be taken from the tip of the ear only and the carcass destroyed intact."
