# ACT

## To amend the Medical, Dental and Pharmacy Act, 1928.

**BE IT ENACTED** by the King's Most Excellent Majesty, by the Senate and House of Assembly of the Union of South Africa, as follows:—

Amendment of  
section 7 of Act  
13 of 1928.

1. Section *seven* of the Medical, Dental and Pharmacy Act, 1928 (hereinafter referred to as the principal Act), is hereby amended by the deletion of all words after the word "but" and the substitution therefor of the words: "no penalty imposed by any such committee other than a caution or a reprimand or a reprimand and a caution shall be of force and effect until the council or board has confirmed its imposition".

13 of 1928.

2. Section *thirteen* of the principal Act is hereby repealed and the following new section *thirteen* substituted:—"Amend. 13. The Governor-General may from time to time by regulation amend the First Schedule to this Act".

3. Section *twenty-two* of the principal Act is hereby amended by the insertion after the word "druggists" where it occurs for the first time, of the words "if they have, before or in connection with or after the acquisition of those degrees, diplomas or certificates, complied with such conditions or requirements as may be prescribed in any such regulation".

section 23 of Act  
13 of 1928.

4. Sub-section (3) of section *twenty-three* of the principal Act is hereby amended by the insertion after the words "(as the case may be)" where they occur for the first time, of the words "if he has, before or in connection with or after the acquisition of any such degree, diploma or certificate, complied with such conditions or requirements as may be prescribed in any such regulation".

section 28 of Act  
13 of 1928.

5. Sub-section (2) of section *twenty-eight* of the principal Act is hereby amended by the insertion after the word "druggist" where it occurs for the first time, of the words "if he has, before or in connection with or after the acquisition of any such diploma or certificate, complied with such conditions or requirements as may be prescribed in any such regulation".

section 42 of Act  
13 of 1928.

6. Paragraph (a) of sub-section (1) of section *forty-two* of the principal Act is hereby deleted and the following paragraph substituted therefor:

"(a) a caution or a reprimand or a reprimand and a caution".

Act 13 of 1928.

7. Sub-section (1) of section *ninety-nine* of the principal Act is hereby amended by the insertion, after the words "purposes of this Act" of the words "except for the purposes of paragraph (b) of the proviso to sub-section (4) of section two".

8. This Act shall be known as the Medical, Dental and Pharmacy Amendment Act, 1935.

# WET

## **Tot wysiging van die Wet op Geneeshere, Tandartse en Aptekers, 1928.**

**DIT WORD BEPAAL** deur Sy Majesteit die Koning, die Senaat en die Volksraad van die Unie van Suid-Afrika, as volg :—

1. Artikel *sewe* van die Wet op Geneeshere, Tandartse en Wysiging van Aptekers, 1928 (hieronder die Hoofwet genoem) word hiermee artikel 7 van gewysig deur alle woorde na die woord „maar” te skrap en Wet 13 van 1928. te vervang deur die woorde „geen straf deur so ’n komitee opgelê (behalwe ’n waarskuwing of ’n berispeling of ’n berispeling en ’n waarskuwing) is regsgeldig nie totdat die raad of kommissie die oplegging daarvan bekratig het.”
2. Artikel *dertien* van die Hoofwet word hiermee herroep Wysiging van en deur die volgende artikel vervang : artikel 13 van „Wysiging 13. Die Goewerneur-generaal kan van tyd tot Wet 13 van 1928. van Eerste tyd die Eerste Bylae tot hierdie Wet deur regulasies Bylae. wysig”.
3. Artikel *twee-en-twintig* van die Hoofwet word hiermee Wysiging van gewysig deur die volgende woorde na die woord „aptekers”, artikel 22 van waar dit vir die eerste keer voorkom, in te voeg : „mits hulle voor of in verband met of na die verkryging van daardie grade, diplomas of sertifikate voldoen het aan die voorwaardes of vereistes wat so ’n regulasie mag voorskryf”.
4. Sub-artikel (3) van artikel *drie-en-twintig* van die Hoofwet Wysiging van word hiermee gewysig deur die volgende woorde na die woorde „geregistreer te word” in te voeg : „mits hy voor of in verband met of na die verkryging van so ’n graad, diploma of sertifikaat voldoen het aan die voorwaardes of vereistes wat so ’n regulasie mag voorskryf”.
5. Sub-artikel (2) van artikel *agt-en-twintig* van die Hoofwet Wysiging van word hiermee gewysig deur die volgende woorde na die woorde „geregistreer te word” in te voeg : „as hy voor of in verband met of na die verkryging van so ’n diploma of sertifikaat voldoen het aan die voorwaardes of vereistes wat so ’n regulasie mag voorskryf”.
6. Paragraaf (a) van sub-artikel (1) van artikel *twee-en-veertig* van die Hoofwet Wysiging van word hiermee geskrap en deur die artikel 42 van volgende paragraaf vervang : „(a) ’n waarskuwing of ’n berispeling of ’n berispeling en ’n waarskuwing of”.
7. Sub-artikel (1) van artikel *negen-en-negentig* van die Wysiging van Hoofwet word hiermee gewysig deur die volgende woorde artikel 99 van na die woorde „doeleindes van hierdie Wet” in te voeg : „behalwe vir die doeleindes van paragraaf (b) van die voorbehoudsbepaling tot sub-artikel (4) van artikel *twee*”.
8. Hierdie Wet heet die Wysigingswet op Geneeshere, Kort titel. Tandartse en Aptekers, 1935.

**ACT**

**To apply a further sum not exceeding one million one hundred and fifty-nine thousand three hundred and seventy-three pounds towards the service of the Union for the year ending on the thirty-first day of March, 1935.**

**B**E IT ENACTED by the King's Most Excellent Majesty, the Senate and the House of Assembly of the Union of South Africa, as follows:—

Exchequer Account charged with £527,703 on revenue account.

1. The Exchequer Account is hereby charged with such sums of money as may be required for the service of the Union (and chargeable to revenue account) during the year ending on the thirty-first day of March, 1935, not exceeding in the whole the sum of five hundred and twenty-seven thousand seven hundred and three pounds, in addition to the sums charged by the Appropriation Act, 1934 (Act No. 66 of 1934), and the Additional Appropriation Act, 1935 (Act No. 1 of 1935).

Exchequer Account charged with £631,670 on loan account.

2. The Exchequer Account is further charged with such sums of money as may be required for the service of the Union (and chargeable to loan account) during the year ending on the thirty-first day of March, 1935, not exceeding in the whole the sum of six hundred and thirty-one thousand six hundred and seventy pounds, in addition to the sums charged by the Appropriation Act, 1934 (Act No. 66 of 1934), and the Additional Appropriation Act, 1935 (Act No. 1 of 1935).

How money to be applied.

3. The money appropriated by this Act shall be applied to the services detailed in the Schedule hereto, and more particularly specified in the Second Estimates of Additional Expenditure (U.G. 3—1935) as approved by Parliament, and to no other purpose.

Short title.

4. This Act shall be known as the Second Additional Appropriation Act, 1935.

**Tot aanwending van 'n verdere som van nie meer as een miljoen eenhonderd-negen-en-vyftigduisend driehonderd drie-en-sewentig pond vir die diens van die Unie, vir die jaar wat eindig op die een-en-dertigste dag van Maart 1935.**

**DIT WORD BEPAAL** deur Sy Majesteit die Koning, die Senaat en die Volksraad van die Unie van Suid-Afrika as volg:—

1. Die Skatkisrekening word hiermee belas met sodanige somme geld as wat benodig mag wees vir die diens van die Unie (en wel ten laste van die inkomsterekening) gedurende die jaar wat eindig op die een-en-dertigste dag van Maart 1935 maar gesamentlik nie meer as vyfhonderd sewen-en-twintig duisend sewehonderd en drie pond, buiten en behalwe die somme uitgetrek, kragtens die Begrotingswet, 1934 (Wet No. 66 van 1934), en die Addisionele Begrotingswet, 1935 (Wet No. 1 van 1935).

2. Die Skatkisrekening word verder belas met sodanige somme geld as wat benodig mag wees vir die diens van die Unie (en wel ten laste van die leningsrekening) gedurende die jaar wat eindig op die een-en-dertigste dag van Maart, 1935, maar gesamentlik nie meer as seshonderd een-en-dertig duisend seshonderd en sewentig pond, buiten en behalwe die somme uitgetrek kragtens die Begrotingswet, 1934 (Wet No. 66 van 1934), en die Addisionele Begrotingswet, 1935 (Wet No. 1 van 1935).

3. Die geld deur hierdie Wet beskikbaar gestel, moet aangewend word vir die dienste opgenoem in die aangehegte Bylae en met meer besonderhede vermeld in die Tweede Begroting van Addisionele Uitgawes (U.G. 3—1935), soos deur die Parlement goedgekeur, en vir geen ander doel.

**ACT**

**To apply a further sum of money towards the service of the Union for the year ended on the thirty-first day of March, 1934, for the purpose of meeting and covering certain unauthorized expenditure.**

**B**E IT ENACTED by the King's Most Excellent Majesty, the Senate and the House of Assembly of the Union of South Africa, as follows:—

Exchequer  
Account charged  
with £13,180 16s.

1. The Exchequer Account of the Union is hereby charged with the sum of thirteen thousand one hundred and eighty pounds sixteen shillings, to meet certain expenditure over and above the amounts appropriated for the service of the Union for the year which ended on the thirty-first day of March, 1934. Such expenditure is set forth in the Schedule to this Act and is more particularly specified on pages 98, 183, 194, 245 and 246 of the Report (which has been submitted to Parliament) of the Controller and Auditor-General on the accounts of the said year and in the First Report of the Select Committee on Public Accounts, 1935.

Short title. 2. This Act shall be known as the Unauthorized Expenditure (1933-'34) Act, 1935.

Hierdie uitgawes word uiteengesit in die Bylae tot hierdie Wet en word nader omskryf op bladsye 100, 185, 196 en 250 van die aan die Parlement voorgelegde Verslag van die Kontroleur en Ouditeur-generaal oor die rekenings vir voormalde jaar en in die Eerste Verslag van die Gekose Komitee oor Openbare Rekenings, 1935.
