## PROCLAMATION

Whereas it is expedient to amend the provisions of the Bechuanaland Protectorate Mines and Minerals Proclamation, 1932 (No. 33 of 1932) (hereinafter referred to as the "said Proclamation"), relating to the opening for prospecting of areas included in Native Reserves;

Now, therefore, under and by virtue of the powers in me vested, I do hereby declare, proclaim and make known as follows:—

1. Sub-section (3) of section six of the said Proclamation shall be and is hereby amended by the deletion of the words "at the date of this Proclamation coming into force and taking effect".

2. This Proclamation shall be deemed to have had force and to have taken effect from the date of the taking effect of the said Proclamation.
