## ACT

**To apply a further sum not exceeding one million seven hundred and eight thousand, seven hundred and twenty-seven pounds towards the service of the Union for the year ending on the thirty-first day of March, 1936.**

**BE IT ENACTED** by the King's Most Excellent Majesty, the Senate and the House of Assembly of the Union of South Africa, as follows:—

Exchequer Account charged with £1,024,824 on revenue account.

**1.** The Exchequer Account is hereby charged with such sums of money as may be required for the service of the Union (and chargeable to revenue account) during the year ending on the thirty-first day of March, 1936, not exceeding in the whole the sum of one million and twenty-four thousand eight hundred and twenty-four pounds, in addition to the sums charged by the Appropriation Act, 1935 (Act No. 56 of 1935).

Exchequer Account charged with £683,903 on loan account.

**2.** The Exchequer Account is further charged with such sums of money as may be required for the service of the Union (and chargeable to loan account) during the year ending on the thirty-first day of March, 1936, not exceeding in the whole the sum of six hundred and eighty-three thousand nine hundred and three pounds, in addition to the sums charged by the Appropriation Act, 1935 (Act No. 56 of 1935).

How money to be applied.

**3.** The money appropriated by this Act shall be applied to the services detailed in the Schedule hereto, and more particularly specified in the Estimates of Additional Expenditure (U.G. 2—1936) as approved by Parliament, and to no other purpose.

Short title.

**4.** This Act shall be known as the Additional Appropriation Act, 1936.

**1.** Die Skatkisrekening word hiermee belas met sodanige somme geld as wat benodig mag wees vir die diens van die Unie (en wel ten laste van die inkomsterekening) gedurende die jaar wat eindig op die een-en-dertigste dag van Maart 1936 maar gesamentlik nie meer as een miljoen vier-en-twintigduisend agthonderd vier-en-twintig pond, buite en behalwe die somme uitgetrek, kragtens die Begrotingswet, 1935 (Wet No. 56 van 1935).

**ACT**

**To apply a sum not exceeding thirteen million pounds on account of the service of the Union for the year ending the thirty-first day of March, 1937.**

**BE IT ENACTED** by the King's Most Excellent Majesty, the Senate and the House of Assembly of the Union of South Africa, as follows :—

Exchequer Account charged with £10,000,000 on Revenue Account and £3,000,000 on Loan Account.

Sums issued under this Act to be advances in anticipation.

Short title.

1. On and after the first day of April, 1936, there may be issued out of the Exchequer Account such sums of money not exceeding in the aggregate the sum of ten million pounds for revenue services and three million pounds for loan services, as may from time to time be required for the service of the Union for the year ending the thirty-first day of March, 1937, until such time as provision is made therefor by Parliament in an Appropriation Act.

2. All sums issued under the provisions of this Act shall be deemed to be advances on account of grants to be made by Parliament in an Appropriation Act for the year ending the thirty-first day of March, 1937, and immediately on the commencement of such Appropriation Act, this Act shall cease to have effect and issues already made hereunder shall be deemed to be issues under that Appropriation Act, and shall be accounted for in accordance with the provisions thereof :

Provided that no services upon which expenditure has not been duly authorized under an Appropriation Act during the year ending the thirty-first day of March, 1936, or for which there is no statutory authority, shall be deemed to be authorized under section one of this Act.

3. This Act shall be known as the Part Appropriation Act, 1936.

**DIT WORD BEPAAL** deur Sy Majesteit die Koning, die Senaat en die Volksraad van die Unie van Suid-Afrika, as volg :—

1. Op en na die eerste dag van April 1936, mag daar uit die Skatkisrekening sodanige somme geld uitgegee word van gesamentlik nie meer as tien miljoen pond vir inkomstediens en drie miljoen pond vir leningsdienste as wat van tyd tot tyd benodig mag wees vir die diens van die Unie vir die jaar wat eindig op die een-en-dertigste dag van Maart 1937, totdat die Parlement deur 'n Begrotingswet daarvoor voorsiening maak.

Skatkisrekening belast met £10,000,000 op Inkomsterekening en £3,000,000 op Leningsrekening.

2. Alle somme, kragtens die bepalings van hierdie Wet uitgegee, word beskou as voorskotte op rekening van geld wat deur die Parlement by 'n Begrotingswet toegestaan sal word vir die jaar wat eindig op die een-en-dertigste dag van Maart 1937, en onmiddellik na die inwerkingtreding van daardie Begrotingswet, tree hierdie Wet buite werking en word geld wat kragtens hom reeds uitgegee is, beskou as uitgawe kragtens daardie Begrotingswet en moet verantwoord word ooreenkomsdig die voorskrifte daarvan :

Somme ingevolge hierdie Wet uitgegee word beskou as voorlopige voorskotte.

**To apply a further sum of money towards the service of the Union for the year ended on the thirty-first day of March, 1935, for the purpose of meeting and covering certain unauthorized expenditure.**

**BE IT ENACTED** by the King's Most Excellent Majesty, the Senate and the House of Assembly of the Union of South Africa, as follows:—

Exchequer Account charged with £37,619 11s. 1d.

Short title.

1. The Exchequer Account of the Union is hereby charged with the sum of thirty seven thousand six hundred and nineteen pounds, eleven shillings and one penny, to meet certain expenditure over and above the amounts appropriated for the service of the Union for the year which ended on the thirty-first day of March, 1935. Such expenditure is set forth in the Schedule to this Act and is more particularly specified on pages 97, 128, 145, 170, 195 and 247 of the Report (which has been submitted to Parliament) of the Controller and Auditor-General on the accounts of the said year and in the First Report of the Select Committee on Public Accounts, 1936.

2. This Act shall be known as the Unauthorized Expenditure (1934-'35) Act, 1936.

**ACT**

**To apply a further sum of money for the purpose of meeting certain unauthorized expenditure incurred during the financial year which ended the thirty-first day of March, 1935.**

**BE IT ENACTED** by the King's Most Excellent Majesty, the Senate and the House of Assembly of the Union of South Africa, as follows:—

Railway and Harbour Fund charged with £16,592 14s. 5d. in respect of expenditure of year 1934-35.

1. The Railway and Harbour Fund is hereby charged with the sum of sixteen thousand five hundred and ninety two pounds fourteen shillings and five pence to meet certain expenditure not authorized by the Railways and Harbours Appropriation Act, 1934, and the Railways and Harbours Additional Appropriation Act, 1935, for revenue services during the financial year which ended the thirty-first day of March, 1935. Such expenditure is specified on page 3 of the Report (which has been submitted to Parliament) of the Controller and Auditor-General on the accounts for that year.

Short title.

2. This Act shall be known as the Railways and Harbours Unauthorized Expenditure Act, 1936.

**DIT** word bepaal deur Sy Majesteit die Koning, die Senaat en die Volksraad van die Unie van Suid-Afrika as volg :—

1. Die Spoorweg- en Hawefonds word hiermee belas met die som van sestieduisend vyfhonderd twee-en-negentig pond veertien sjelings en vyf pennies tot dekking van sekere uitgawe vir inkomstedienste gedurende die boekjaar wat op die een-en-dertigste dag van Maart 1935 geëindig het, waartoe die Spoorweg- en Hawebegrotingswet 1934, en die Addisionele Begrotingswet op Spoorweë en Hawens, 1935, geen magtiging verleen het nie. **ACT**

**To apply a further sum not exceeding four million nine hundred and twenty-eight thousand one hundred and twenty-eight pounds from the Railway and Harbour Fund for the service of the railways and harbours for the financial year ending the thirty-first day of March, 1936.**

**BE IT ENACTED** by the King's Most Excellent Majesty, the Senate and the House of Assembly of the Union of South Africa, as follows:—

Railway and Harbour Fund to be charged with £4,928,128.

How moneys to be applied.

Minister may authorize variations.

Lines under construction.

Increase in expenditure on certain authorized lines.

Sources from which moneys appropriated will be provided.

Short title.

1. The Railway and Harbour Fund of the Union is hereby charged towards the service of the financial year ending the thirty-first day of March, 1936, with a sum not exceeding in the whole for revenue services, the sum of four million six hundred and ninety-thousand and seven pounds and, for capital and betterment services, two hundred and thirty-eight thousand one hundred and twenty-one pounds in addition to the sums provided by the Railways and Harbours Appropriation Act, 1935 (Act No. 45 of 1935).

2. The moneys appropriated by this Act shall be applied to the purposes set forth in the First and Second Schedules thereto and more particularly specified in the Estimates of Additional Expenditure (U.G. 6—1936 and U.G. 7—1936) for the said financial year as approved by Parliament, but no portion of the sum of nine hundred and eighty-one thousand pounds contributed from the Betterment Fund specified in the Third Schedule to Act No. 45 of 1935 or of the sum of five hundred thousand pounds specified in the First Schedule to this Act shall be utilized for expenditure except for the purposes falling under heads numbered 2, 4, 8 and 9 of the Second Schedule to this Act and heads numbered 2 to 9 inclusive in the Second Schedule to Act No. 45 of 1935.

3. With the approval of the Minister of Railways and Harbours any saving on any amount shown in Column 1 of the First Schedule to this Act may be made available for any excess of expenditure on any other head appearing in Column 1 of the First Schedule to Act No. 45 of 1935, and similarly any saving on the amount shown in Column 1 of the Second Schedule to this Act may be made available for any excess of expenditure on any other head appearing in Column 1 of the Second Schedule to Act No. 45 of 1935: Provided that no excess shall be incurred on any sum appearing in Column 2 of either of the said Schedules nor shall savings thereon be available for any purposes other than that for which the money is hereby appropriated as indicated in those Schedules: Provided further that the amount appearing in Column 3 of the Second Schedule to this Act may be made available for any services falling under the heads numbered 2, 4 and 8 of that Schedule and heads numbered 2 to 8 inclusive in the Second Schedule to Act No. 45 of 1935.

4. In the case of the service falling under Head No. 1 of the Second Schedule, the total expenditure on any line under construction shall not exceed the amount prescribed by law as the maximum amount which may be expended thereon.

5. Anything to the contrary notwithstanding in any law authorizing the construction, equipment or purchase of any line mentioned in Column 1 of the Fourth Schedule to this Act the amount mentioned in Column 2 of that Schedule opposite the name of any such line (being the amount prescribed by law as the maximum sum to be expended on that line) shall be increased to the sum set out in Column 3 opposite such name.

6. The moneys appropriated by this Act for capital and betterment services shall be provided from the sources set out in the Third Schedule thereto.

7. This Act shall be known as the Railways and Harbours Additional Appropriation Act, 1936.

Die Spoorweg- en Hawefonds van die Unie word hiermee Spoorweg- en belas vir die diens van die boekjaar eindigende die een-en-dertigste dag van Maart 1936, met 'n som wat gesamentlik nie meer bedra nie as viermiljoen seshonderd-en-negentigduisend en sewe pond vir inkomstedienste en tweehonderd agt-en-dertigduisend eenhonderd een-en-twintig pond vir kapitaal- en verbeteringsdienste, buite en behalwe die bedrae waarvoor voorsiening gemaak is kragtens die Spoorweg- en Hawebegrotingswet, 1935 (Wet No. 45 van 1935), met £4,928,128.
2. # ACT

Short title.

**BE IT ENACTED** by the King's Most Excellent Majesty, the Senate and the House of Assembly of the Union of South Africa, as follows :—

1. On and after the first day of April, 1936, there may be issued out of the Railway and Harbour Fund for revenue and loan services of the Railway Administration of the Union, such sums of money, not exceeding in the aggregate the sum of eight million five hundred thousand pounds as may from time to time be required for the railways and harbours service of the Union for the year ending the thirty-first day of March, 1937, until such time as provision is made therefor by Parliament in a Railways and Harbours Appropriation Act.

2. All sums issued under the provisions of this Act shall be deemed to be advances on account of grants to be made by Parliament in a Railways and Harbours Appropriation Act for the year ending the thirty-first day of March, 1937, and immediately on the commencement of such Appropriation Act, this Act shall cease to have effect and issues already made hereunder shall be deemed to be issues under that Appropriation Act, and shall be accounted for in accordance with the provisions thereof :

Provided that no services upon which expenditure has not been duly authorized under an Appropriation Act during the year ending the thirty-first day of March, 1936, and for which there is no statutory authority, shall be deemed to be authorized under this Act.

3. This Act shall be known as the Railways and Harbours Part Appropriation Act, 1936.

## WET

**Tot aanwending van 'n som van hoogstens agtmiljoen vyfhonderdduisend pond ten behoeve van die diens van die Spoorweg- en Hawe-administrasie vir die jaar wat eindig op die een-en-dertigste dag van Maart 1937.**

**DIT WORD BEPAAL** deur Sy Majesteit die Koning, die Senaat en die Volksraad van die Unie van Suid-Afrika, as volg :—

**1.** Op en na die eerste dag van April 1936 kan uit die Spoorweg- en Hawefonds vir inkomste en leningsdienste van die Spoorwegadministrasie van die Unie sulke somme getrek word, van gesamentlik nie meer dan agtmiljoen vyfhonderdduisend pond as wat van tyd tot tyd nodig mag wees vir die spoorweg- en hawediens van die Unie vir die jaar wat eindig op die een-en-dertigste dag van Maart 1937, totdat die Parlement deur 'n Spoorweg- en Hawebegrotingswet daarvoor voorsiening maak.

**2.** Alle somme kragtens die bepalings van hierdie Wet kan getrek, word beskou as voorskotte op rekening van geldie wat deur die Parlement by 'n Spoorweg- en Hawebegrotingswet bewillig sal word vir die jaar wat eindig op die een-en-dertigste dag van Maart 1937, en onmiddellik na die inwerkingtreding van daardie begrotingswet, tree hierdie Wet buite werking en word geldie wat kragtens hom reeds uitgegee is, beskou as uitgawe kragtens daardie begrotingswet en moet, ooreenkomsdig die voorskrifte daarvan, verantwoord word :

Met dien verstande dat dienste waarvoor gedurende die jaar wat eindig op die een-en-dertigste dag van Maart 1936, geen uitgawe behoorlik geoutorisir is kragtens 'n begrotingswet of waarvoor geen wetlike magtiging verleen is nie, nie beskou word deur hierdie Wet gemagtig te wees nie.

**3.** Hierdie Wet heet die Gedeeltelike Spoorweg- en Hawe- Kort titel. begrotingswet 1936.
