

It is hereby notified for general information that the Live Stock and Meat Industries Control Board has, under and by virtue of the powers conferred upon it by Proclamation by His Excellency the Governor-General, No. 134, dated the 1st day of August, 1934, determined that during any week falling within the period from the 16th day of June, 1936, to the 15th day of September, 1936 (both dates included), it shall not be lawful to sell or to offer for sale at the Municipal Live Stock Market, Johannesburg, more than four thousand five hundred head of slaughter cattle and twenty thousand slaughter sheep.

It is hereby notified for general information that the Live Stock and Meat Industries Control Board has, under and by virtue of the powers conferred upon it by Proclamation by His Excellency the Governor-General, No. 134, dated the 1st day of August, 1934, determined that during any week falling within the period from the 16th day of June, 1936, to the 15th day of September, 1936 (both dates included), it shall not be lawful to transport or bring more than five thousand two hundred and fifty head of slaughter cattle nor more than twenty-five thousand head of slaughter sheep nor more than five tons of beef nor more than five tons of mutton into the Magisterial Districts of Benoni, Boksburg, Brakpan, Germiston, Johannesburg, Krugersdorp, Pretoria and Springs.
