MARKETING ACT, 1937.

PAYMENT OF LEVY ON DRIED FRUIT.

His Excellency the Governor-General has been pleased, under the powers vested in him by paragraph (b) of sub-section (1) of section *forty-three* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, to make the following regulations relating to the payment of any levy imposed on dried fruit in terms of the Dried Fruit Scheme published under Proclamation No. 229 of 1938:—

Any levy imposed in terms of section *eleven* of the Dried Fruit Scheme published under Proclamation No. 229 of 1938, on dried fruit purchased or otherwise acquired from a producer thereof by any person dealing in the course of trade with dried fruit, shall be payable by such person to the Chairman of the Dried Fruit Board, Stellenbosch, on or before the eighth day of the month following that during which he so purchased or acquired such dried fruit.

LEVY ON DRIED FRUIT.

In terms of sub-section (1) of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, WILLIAM RICHARD COLLINS, Minister of Agriculture and Forestry, hereby notify that the Dried Fruit Board established under section *two* of the South African Dried Fruit Scheme published under Proclamation No. 229 of 1938, has, in terms of section *eleven* of that Scheme and with my approval, imposed on all dried fruit purchased or otherwise acquired from a producer thereof by any person dealing with dried fruit in the course of trade, a levy of six pence per hundred pounds net weight of such dried fruit.

And I do hereby further notify that the said levy shall become operative from the date of publication of this notice.

BETALING VAN HEFFING OP DROEVrugTE.

Dit het Sy Eksellensie die Goewerneur-generaal behaag om, kragtens die bevoegdheid hom verleen by paragraaf (b) van subartikel (1) van artikel *drie-en-veertig* van die Bemerkingswet, 1937 (Wet No. 26 van 1937), soos gewysig, die volgende regulasies te maak, betreffende die betaling van 'n heffing gelé op droëvrugte ooreenkomstig die Droëvrugteskema gepubliseer by Proklamasie No. 229 van 1938:—

'n Heffing wat ooreenkomstig artikel *elf* van die Droëvrugteskema, gepubliseer by Proklamasie No. 229 van 1938, gelé word op droëvrugte wat van 'n produsent daarvan gekoop of op 'n ander wyse verkry word deur 'n persoon wat as 'n besigheid met droëvrugte handel, moet deur sodanige persoon aan die Voorsitter van die Droëvrugteraad, Stellenbosch, betaal word op of voor die agste dag van die maand wat volg op die maand waarin hy daardie droëvrugte aldus gekoop of verkry het.

HEFFING OP DROEVrugTE.

Ooreenkomstig subartikel (1) van artikel *nege-en-twintig* van die Bemerkingswet, 1937 (Wet No. 26 van 1937), soos gewysig, maak ek, WILLIAM RICHARD COLLINS, Minister van Landbou en Bosbou, hierby bekend dat die Droëvrugteraad, ingestel kragtens artikel *twee* van die Suid-Afrikaanse Droëvrugteskema gepubliseer by Proklamasie No. 229 van 1938, ooreenkomstig artikel *elf* van daardie Skema en met my goedkeuring op alle droëvrugte wat van 'n produsent daarvan gekoop op of 'n ander wyse verkry word deur iemand wat as 'n besigheid met droëvrugte handel, 'n heffing van ses pennies per honderd pond netto gewig van sodanige droëvrugte gelé het.

En ek maak hierby verder bekend dat genoemde heffing van krag sal wees vanaf datum van publikasie van hierdie kennisgewing.
