### PROCLAMATION

BY HIS EXCELLENCY THE HIGH COMMISSIONER.

Whereas it is expedient to amend the Bechuanaland Protectorate Pounds and Trespasses Proclamation, 1925 (hereinafter referred to as "the principal law"), in order to make special provision regarding the impounding of donkeys:

Now therefore under and by virtue of the powers in me vested I do hereby declare, proclaim and make known as follows:—

Special procedure relating to impounded donkeys. 1. (1) Notwithstanding anything contained in the principal law, whenever any donkey has been impounded the poundmaster shall forthwith post or cause to be posted at the gate of the pound and at the nearest police station a notice setting forth a description and the marks or distinguishing peculiarities (if any) of such animal, and fixing a date, which shall not be less than fourteen days from the date of the impounding, when such animal will be sold.

(2) If at the sale so advertised and held no offer is made for the purchase of the animal, it may be destroyed by the poundmaster.

2. Notwithstanding anything contained in the principal law, the following rates of mileage, trespass money, pound fees and sustenance fees shall apply to the impounding of donkeys:

#### Rate of mileage:

For one or more donkeys going to the pound, per mile ... ... ... ... 1d.

#### Trespass on cultivated land:

If land enclosed with sufficient fence ... ... ... ... 3d. per head.  
If land not so enclosed ... 1d. per head.

#### Trespass on uncultivated land:

If land enclosed with sufficient fence ... ... ... ... 1d. per head.  
If land not so enclosed ... 4d. per head.

#### Pound fees:

Per head ... ... ... ... 1d.

#### Sustenance fees:

Per head ... ... ... ... ½d. per diem.

#### Fees for donkeys to be separately herded:

Per head ... ... ... ... 3d. per diem.

3. This Proclamation may be cited as the short title and commencement. Bechuanaland Protectorate Pounds and Trespasses (Amendment) Proclamation, 1939, and shall have force and take effect from the date of its publication in the *Gazette*.

### PROCLAMATION

Whereas it is expedient to amend the Basutoland Native Courts Proclamation, 1938 (No. 62 of 1938), hereinafter referred to as "the said Proclamation":

Now therefore under and by virtue of the powers in me vested I do hereby declare, proclaim and make known as follows:—

1. Section *thirty-five* of the said Proclamation is hereby amended by deleting the words Amendment of section 35 of Proclamation No. 62 of 1938. "six months" and substituting therefor the words "nine months".

2. This Proclamation may be cited as the short title and commencement. Basutoland Native Courts (Amendment) Proclamation, 1939, and shall have force and take effect as from the first day of July, 1939.
