### VERKOOP VAN MIELIES EN MIELIEPRODUKTE DEUR PRODUSENTE VAN MIELIES.

Ooreenkomsdig subartikel (1) van artikel *nege-en-twintig*  
van die Bemarkingswet, 1937 (Wet No. 26 van 1937), soos  
gewysig, maak ek, WILLIAM RICHARD COLLINS, Minister van  
Landbou en Bosbou, hierby bekend dat die Raad van Beheer  
oor die Mielienywerheid genoem in artikel *twee* van die  
Mieliereelingskema, gepubliseer by Proklamasie No. 77 van  
1939, kragtens paragraaf (s) van subartikel (1) van artikel  
*twee-en-twintig* van daardie skema, en met my goedkeuring,  
die volgende verbod opgelê het:—

„Geen produsent van mielies mag mielies of mielie-  
produkte aan iemand, wat nie volgens artikel *agt-en-twintig*  
van die Mieliereelingskema, gepubliseer by Proklamasie  
No. 77 van 1939, geregistreer is, verkoop nie.“

En ek maak hierby verder bekend dat genoemde verbod  
op die datum van publikasie van hierdie kennisgewing van  
krag word.

MEALIE CONTROL SCHEME.

### SALE OF MEALIES AND MEALIE PRODUCTS BY PRODUCERS OF MEALIES.

In terms of sub-section (1) of section twenty-nine of the  
Marketing Act, 1937 (Act No. 26 of 1937), as amended, I,  
WILLIAM RICHARD COLLINS, Minister of Agriculture and  
Forestry, hereby make known that the Mealie Industry  
Control Board referred to in section two of the Mealie Control  
Scheme published under Proclamation No. 77 of 1939, has,  
in terms of paragraph (s) of sub-section (1) of section twenty-  
two of that Scheme, and with my approval imposed the  
following prohibition:—

“No producer of mealies shall sell mealies or any  
mealie product to any person who is not registered in  
terms of section twenty-eight of the Mealie Control  
Scheme published under Proclamation No. 77 of 1939.”

And I do hereby further make known that the said prohi-  
bition shall come into operation on the date of publication  
of this notice.
