NOTICE UNDER SECTION THREE OF THE ANNEXURE TO PROCLAMATION No. 201 OF 1939.

THE RICHARD STUTTAFORD, Minister of Commerce and Industries, acting in terms of Section 3 of the National Emergency Regulations set forth in the Annexure to Proclamation No. 201 of 1939, and on the recommendation of the National Supplies Control Board, do hereby throughout the Union and the Mandated Territory of South West Africa fix as the maximum retail price at which any of the goods specified in the Annexure hereto may be sold in any particular place, the retail price at which such goods were ordinarily sold at that place on the 7th October, 1939; provided that the terms of this notice shall not apply in respect of any such goods for which retail prices may have been fixed by any Regulatory Board which administers a scheme under the Marketing Act, 1937.
