TO PROCLAMATION No. 201 of 1939.

KENNISGEWING INGEVOLGE ARTIKEL DRIE VAN
DIE AANHANGSEL TOT PROKLAMASIE No. 201
VAN 1939.

THE RIGHT HON. RICHARD STUTTAFFORD, Minister of Commerce and Industries, acting in terms of Section 3 of the National Emergency Regulations set forth in the Annexure to Proclamation No. 201 of 1939, and on the recommendation of the National Supplies Control Board, do hereby throughout the Union and the Mandated Territory of South West Africa fix as the maximum retail price at which any of the goods specified in the Annexure hereto may be sold in any particular place, the retail price at which such goods were ordinarily sold at that place on the 7th October, 1939; provided that the terms of this notice shall not apply in respect of any such goods for which retail prices may have been fixed by any Regulatory Board which administers a scheme under the Marketing Act, 1937.

Ingevolge die bevoegdheid my verleen by artikel 3 van die Landsnoodtoestand-regulasies, uiteengesit in die Aanhangel tot Proklamasie, No. 201 van 1939, en op aanbeveling van die Raad van Beheer van Landvoorrade, stel ek RICHARD STUTTAFFORD, Minister van Handel en Nywerheid, hierby vas dat die maksimum kleinhandelprys waarteen enige van die goedere in die bygaande aanhangsel gespesifiseer op enige plek binne die Unie of die Mandaatgebied Suidwes-Afrika verkoop mag word, die prys is waarteen sodanige goedere gewoonlik op daardie plek op 7 Oktober 1939 verkoop is; met dien verstande dat die bepalinge van hierdie kennisgewing nie van toepassing is op sodanige goedere waarvan die kleinhandelpryse deur enige Raad wat 'n skema ingevolge die Bemarkingwet, 1937, beheer, vasgestel is.
