### PROCLAMATIONS

By HIS EXCELLENCE THE RIGHT HONOURABLE SIR PATRICK DUNCAN, A MEMBER OF HIS MAJESTY'S MOST HONOURABLE PRIVY COUNCIL, KNIGHT GRAND CROSS OF THE MOST DISTINGUISHED ORDER OF SAINT MICHAEL AND SAINT GEORGE, ONE OF HIS MAJESTY'S COUNSEL LEARNED IN THE LAW, DOCTOR OF LAWS, GOVERNOR-GENERAL OF THE UNION OF SOUTH AFRICA.

Whereas by Proclamation No. 201 of 1939 the National Emergency Regulations, set forth in the Annexure to that Proclamation, were brought into operation;

And whereas it is expedient to amend the said Regulations by providing for the employment of the Seaward Defence Force outside the territorial waters of the Union;

Now therefore I do hereby proclaim, declare and make known that the said Regulations are hereby amended as set out in the Annexure to this Proclamation.

### ANNEXURE.

The following new regulation is inserted after regulation 31:

#### 32. EMPLOYMENT OF SEWARD DEFENCE FORCE.

During the present war, any portion of the Seaward Defence Force, or any member thereof, may be employed on any ship commissioned by the Secretary for Defence for purposes of defence, when such ship is in any of the waters surrounding South Africa, whether within or outside the territorial waters of the Union.

#### 32. AANWENDING VAN VERDEDIGINGSMAG TER SEE.

Gedurende die huidige oorlog kan enige gedeelte van die Verdedigingsmag ter See of enige lid daarvan op enige skip wat deur die Sekretaris van Verdediging vir verdedigingsdoeleindes in bedryf gestel is, aangewend word wanneer so'n skip in die waters van Suid-Afrika is, onverskillig of dit binne of buite die territoriale waters van die Unie is.

Whereas the National Emergency Regulations set forth in the Annexure to Proclamation No. 201 of 1939, dated the 14th day of September, 1939, have been brought into operation by the said Proclamation;

And whereas such regulations have been amended; And whereas it is expedient that such regulations be further amended;

Now therefore I do hereby proclaim, declare and make known that the said regulations are hereby amended as indicated in the Annexure to this Proclamation.

2. Regulation 29 is hereby amended as follows:—
  - (a) By the deletion in sub-regulation (1) of the words "situated in an urban area";
  - (b) by the insertion in paragraph (i) (b) of sub-regulation (3) of the word "Corporal" after the word "Sergeant";
  - (c) by the deletion in sub-regulation (4) of the words "which shall be stationed in the urban areas of the Union";
  - (d) by the deletion of sub-regulation (6);
  - (e) by the deletion in paragraph (ii) of sub-regulation (8) of the words "and transport";
  - (f) by the insertion in paragraph (iii) of sub-regulation (8) after the words "to serve in" of the words "or outside";
  - (g) by the insertion in sub-regulation (13) after the word "remuneration" appearing in (13) (c) of the words "and allowances"; and
  - (h) by the insertion of the following new paragraph (13) (c) *bis* after paragraph (13) (c):—

Provision of transport or payment of allowances in lieu.
