PROCLAMATION

By HIS EXCELLENCY THE HIGH COMMISSIONER.

Whereas it is deemed expedient to amend the Bechuanaland Protectorate Gold Premium Taxation Proclamation, 1939 (No. 57 of 1939), hereinafter styled the "principal law";

Now therefore under and by virtue of the powers in me vested I do hereby declare, proclaim and make known as follows:—

Amendment of Section 11 of Proclamation No. 57 of 1939. 1. Section *eleven* of the principal law is hereby amended by the deletion of the following words:—

"It shall expire on the thirteenth day of June, 1940, except as respects things previously done or omitted to be done".

Commencement. 2. This Proclamation shall have force and take effect from the date of its publication in the *Gazette*.
