BYLAE.

OFFISIERE VAN DIE UNIE-VERDEDIGINGSMAG.—
AFNEEM VAN EDE BUITE DIE UNIE.

'n Offisier van die Unie-Verdedigingsmag wat minstens kapteinsrang beklee, is vir solank hy so'n rang beklee of wetlik in so'n hoedanigheid waarneem, 'n kommissaris van ede vir die doel om 'n beëdigde of 'n plegtige verklaring op watter plek ook buite die Unie te attesteer, terwyl so'n verklaring waaruit blyk dat dit aldus geattesteer is, vir alle doeleindes geldig is binne die Unie en op elke plek waar die Unie-Verdedigingsmag diens doen in verband met die huidige oorlog waaraan gemelde mag deelneem, en op elke plek waar so 'n verklaring kragtens die Zuid-Afrika Verdedigings Wet, No. 13 van 1912, soos gewysig, of 'n regulasie daarkragtens, vir watter doel ook benodig word, en vir enige doel kragtens die Unie se Reglement van Dissipline.

KENNISGEWING INGEVOLGE REGULASIE 3 VAN
OORLOGSMAATREEL No. 100 VAN 1942.

MAKSIMUM PRYSE VAN VLEIS.

1. Ek, EDWARD JAMES CREAN, Pryskontroleur, handelende kragtens regulasie 3 van Oorlogsmaatregel No. 100 van 1942, bepaal hierby met ingang van 1 Maart 1943 dat—

(a) die pryse wat in bygaande lyste 1 en 2 aangegee word, die maksimum pryse is waarteen die goedere wat daarin vermeld word, deur 'n handelaar op die vermelde plekke verkoop mag word aan—

(i) 'n ander handelaar;

(ii) 'n skip of die eienaar, agent, kaptein of ander offisier van 'n skip of iemand wat namens 'n skip of sodanige eienaar, agent, kaptein of ander offisier koop;

(iii) enige land-, vloot- of lugmag hoegenaamd of iemand wat namens so'n mag koop;

PROCLAMATION

By HIS EXCELLENCY THE RIGHT HONOURABLE NICOLAAS JACOBUS DE WET, A MEMBER OF HIS MAJESTY'S MOST HONOURABLE PRIVY COUNCIL, OFFICER ADMINISTERING THE GOVERNMENT OF THE UNION OF SOUTH AFRICA.

Under the powers vested in me by section one bis of the War Measures Act, 1940 (Act No. 13 of 1940), as inserted by section one of the War Measures Amendment Act, 1940 (Act No. 32 of 1940), I do hereby make the regulations set out in the Annexure to this Proclamation.

This Proclamation shall be called War Measure No. 13 of 1943.

ANNEXURE.

UNION DEFENCE FORCE OFFICERS.—ADMINISTRATION OF OATHS OUTSIDE THE UNION.

Any person who is an officer of the Union Defence Force of the rank of captain or of higher rank shall, during his tenure of such rank or while he is acting lawfully in such rank, be a Commissioner of Oaths for the purpose of attesting any sworn or solemn declaration at any place outside the Union and any such declaration, which purports to have been so attested, shall be valid for all purposes in the Union and at any place where the Union Defence Force may be on duty in connection with the present war in which the said Forces are engaged or at any place where such declaration is required for any purpose under the South Africa Defence Act, No. 13 of 1912, as amended, or any regulation thereunder and for any purpose under the Union Military Discipline Code.

NOTICE UNDER REGULATION 3 OF WAR MEASURE
No. 100 OF 1942.

MAXIMUM PRICES OF MEAT.

1. In terms of regulation 3 of War Measure No. 100 of 1942, I, EDWARD JAMES CREAN, Price Controller, do hereby, with effect from 1st March, 1943, fix—

(a) the prices specified in Schedules 1 and 2 hereto as the maximum prices at which the goods specified therein may be sold at the places specified by a dealer to—

(i) any other dealer;

(ii) any ship or the owners, agents, captain or other officer of any ship, or any person buying on behalf of any ship or any such owner, agent, captain or other officer;

(iii) any military, naval or air forces whatsoever, or any person buying on behalf of any such forces;

met dien verstande dat genoemde pryse die aflewering op die perseel van die koper insluit, en met dien verstande verder dat, wanneer aflewering nie deur die verkoper geskied nie, genoemde pryse met 'n bedrag ten aansien van karweikoste bereken teen een pennie per myl per 100 pond van sodanige goedere, verminder moet word; en

- (b) die pryse wat in bygaande lyste 3 en 4 aangegee word, die maksimum pryse is waarteen die goedere wat daarin vermeld word, deur 'n kleinhandelaar aan iemand anders op die vermelde plekke verkoop mag word vir aflewering op die perseel van die verkoper teen prompte kontante betaling; met dien verstande dat die maksimum pryse vir enige hoeveelheid van genoemde goedere behalwe 1 pond eweredig volgens die vermelde prys per pond bereken moet word, en met dien verstande verder dat, wanneer genoemde goedere op krediet verkoop en/of aan die koper gelewer word, genoemde pryse met 'n bedrag van hoogstens vyf persent van sodanige pryse verhoog mag word as 'n bepaalde toevoeging moet verskyn op die maandelikse of ander gereelde rekening wat aan die koper gestuur word.

2. Kragtens paragraaf (b) van regulasie 9 van genoemde Oorlogsmaatreël gelas ek hierby dat elke handelaar in paragraaf 1 (a) hiervan vermeld, aan die koper tydens die verkoping of binne 'n redelike tydperk daarna 'n faktuur of opgawe met 'n volnommer en met die volgende besonderhede moet verstrek:—

- Die naam en adres van die verkoper;
- die naam en adres van die koper;
- die datum van verkoping;
- 'n noukeurige beskrywing (met inbegrip van die graad) van die verkoopte goedere;
- die gewig in pond van elke artikel op die faktuur aangetoon;
- die prys per 100 pond of per 1 pond van elke artikel die totale prys van elke artikel en die gesamentlike prys van al die artikels op die genoemde faktuur of opgawe.

3. Kragtens subregulasie (3) van regulasie 3 van genoemde Oorlogsmaatreël gelas ek hierby dat elke handelaar in paragraaf 1 (b) hiervan vermeld, die pryse wat in bygaande lyste 3 en 4 aangegee is en van toepassing is op die gebied waarin sy besigheidperseel geleë is, op en na 8 Maart 1943 in albei offisiële tale en duidelik leesbaar in sy winkel moet vertoon op 'n plek wat vir lede van die publiek goed sigbaar en maklik toeganklik is, as hulle genoemde goedere koop.

4. Vir doeleindes van hierdie kennisgewing omvat—
- „Kaaipstad”, die munisipale gebiede Kaaipstad, Bellville, Vishoek, Goodwood en Parow en die reggebiede van die plaaslike Rade van Milnerton en Pinelands Garden City;
 - „Durban”, die munisipale gebiede Durban (stad) en die dorpsraadgebiede Pinetown, Malvern en Westville;
 - „Witwatersrand” die gebiede onder die jurisdiksie van die plaaslike owerhede van Alberton, Benoni, Boksburg, Brakpan, Edenvale, Elsburg, Germiston, Johannesburg, Krugersdorp, Nigel, Randfontein, Roodepoort-Maraisburg en Springs;
 - „Pretoria”, die munisipale gebiede Pretoria, Hercules en Pretoria-Noord.

5. Goewernementskennisgewings No. 2470 van 1 Desember 1942 en 45 van 8 Januarie 1943 word hierby met ingang van 1 Maart 1943 ingetrek.

provided that the said prices shall include delivery to the premises of the purchaser, provided further that where delivery is not made by the seller, the said prices shall be reduced by an amount in respect of transport charges calculated at the rate of one penny per mile per 100 lb. of such goods; and

- (b) the prices specified in Schedules 3 and 4 hereto as the maximum prices at which the goods specified therein may be sold at the specified places by a retail dealer to any other person for delivery at the premises of the seller against immediate cash payment; provided that the maximum prices for any quantity of the said goods other than 1 lb. shall be calculated proportionately to the specified price per lb., provided further that where the said goods are sold on credit and/or delivered to the purchaser, the said prices may be increased by an amount not exceeding five per cent. of such prices, to be shown as a specific addition to the monthly or other periodical account rendered to the purchaser.

2. In terms of paragraph (b) of regulation 9 of the said War Measure, I hereby direct that every dealer referred to in section 1 (a) hereof shall give to the purchaser at the time of the sale or within a reasonable period thereafter a serially numbered invoice or memorandum giving the following particulars:—

- The name and the address of the seller;
- the name and address of the purchaser;
- the date of the sale;
- an exact description (including the grade) of the goods sold;
- the weight in lb. of each item shown on the invoice;
- the price per 100 lb. or per 1 lb. of each item, the total price of each item and the aggregate price of all the items on the said invoice or memorandum.

3. In terms of sub-regulation (3) of regulation 3 of the said War Measure, I hereby direct that every dealer referred to in section 1 (b) hereof shall, on and after the 8th March, 1943, display the prices specified in Schedules 3 and 4 hereof and applicable to the area wherein his business premises are situated, in both official languages, in clearly legible form and at a place in his shop which is prominent and easily accessible to members of the public when purchasing the said goods.

4. For the purposes of this notice—

- “Cape Town” includes the Municipal Areas of Cape Town, Bellville, Fish Hoek, Goodwood and Parow and the areas under the jurisdiction of the Milnerton Local Board and the Pinelands Garden City Local Board;
- “Durban” includes the Municipal Areas of Durban (Borough) and the Town Boards of Pinetown, Malvern and Westville;
- “Witwatersrand” includes the areas under the jurisdiction of the Local Authorities at Alberton, Benoni, Boksburg, Brakpan, Edenvale, Elsburg, Germiston, Johannesburg, Krugersdorp, Nigel, Randfontein, Roodepoort-Maraisburg and Springs;
- “Pretoria” includes the Municipal Areas of Pretoria, Hercules and Pretoria North.

5. Government Notices No. 2470 of 1st December, 1942, and No. 45 of 8th January, 1943, are hereby withdrawn, as and from the 1st March, 1943.
