Ek, Frederick Viljoen Ashpole, Pryskontroleur, handelende kragtens regulasie 12 van Oorlogsmaatregel No. 49 van 1946, wysig hierby Goewermentskennisgewing No. 1636 van 20 Julie 1950 (Vrystelling van Prysbeheer-regulasies—Vrystelling van Pryse) deur die skrapping in die Bylae daarvan van die woorde „Sterk drank” (moutdrank en spirituelieë) en die vervanging daarvan deur die woorde „Sterkdrank (spirituelieë)”.

MAKSIMUM PRYSE VAN TIMMERHOUT EN KASPLANKE.

Ek, Frederick Viljoen Ashpole, Pryskontroleur, handelende kragtens regulasie 3 van Oorlogsmaatregel No. 49 van 1946, bepaal hierby vir die hele Unie, met uitsondering van die mandaatgebied Suidwes-Afrika en die hawe en nedersetting Walvisbaai as volg:—

1. Die maksimum prys waarteen timmerhout aan 'n persoon deur die oorspronklike koper daarvan verkoop mag word, is die koste van die timmerhout vir die oorspronklike koper plus 30 persent van die koste in die geval van sagtehout of $37\frac{1}{2}$ persent van die koste in die geval van hardehout, min handels- en kontakfondings teen die koers gewoonlik toegelaat deur die verkoper in dergelyke transaksies gedurende die maand Julie 1950.

PRICE CONTROL.

EXEMPTIONS FROM PRICE CONTROL REGULATIONS (DECONTROL OF PRICES).

In terms of regulation 12 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, hereby amend Government Notice No. 1636 of 20th July, 1950 (Exemptions from Price Control Regulations—Decontrol of Prices) by the deletion in the Schedule thereto of the words "Liquor (Malted and Spirituous)" and the substitution therefor of the words "Liquor (Spirituous)".

PRICE CONTROL.

MAXIMUM PRICES OF TIMBER AND BOX SHOCKS.

In terms of regulation 3 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, do hereby throughout the Union, excluding the Mandated Territory of South-West Africa and the port and settlement of Walvis Bay—

1. Fix the maximum price at which any timber may be sold to any person by the original purchaser thereof at the cost of such timber to such original purchaser plus 30 per cent. of such cost in the case of softwood or $37\frac{1}{2}$ per cent. of such cost in the case of hardwood less trade and cash discounts at the rates ordinarily allowed by the seller in similar transactions during the month of July, 1950.

2. Die maksimum prys waarteen 'n houtsaer hout aan 'n ander persoon mag verkoop, is die prys wat hy gewoonlik gedurende die maand Februarie 1949 gevra het vir dergelike hout aan dergelike persone op dergelike voorwaardes verkoop.

3. Die maksimum prys waarteen enigeen, insluitende 'n houtsaer kasplanke mag verkoop, is die prys wat hy gewoonlik gedurende die maand Februarie 1949 gevra het vir dergelike kasplanke wat aan dergelike persone op dergelike voorwaardes verkoop is, met dien verstande dat, wanneer so iemand nie dergelike kasplanke gedurende genoemde maand verkoop het nie of dit nie aan dergelike persone op dergelike voorwaardes verkoop het nie, hy teen die maksimum prys mag verkoop wat kragtens hierdie kennisgewing gevorder kan word deur 'n persoon in dieselfde of die naaste omgewing wat gedurende genoemde maand dergelike kasplanke aan dergelike persone op dergelike voorwaardes verkoop het.

4. Vir die toepassing van hierdie kennisgewing—

- (a) beteken „oorspronklike koper”, met betrekking tot timmerhout, die invoerder daarvan of, in die geval van timmerhout in die Unie vervaardig, die persoon wat die timmerhout verkry het van die houtsaer deur wie dit vervaardig is;
- (b) beteken „houtsaer” iemand wat ru bewerkte hout of geskaafde hout uit saagblomme hetsy rond of vierkantig, vervaardig, en ook 'n houthakker of fabrikant van kasplanke;
- (c) sluit „timmerhout” in ru bewerkte hout, balke, geskaafde hout en opgelegde hout, maar nie kasplanke nie.

PRYSBEHEER.

MAKSIMUM PRYSE VAN FIETSBUITEBANDE EN -BINNEBANDE EN MAKSIMUM PRYSE VIR DIE AANSIF VAN BUITEBANDE EN BINNEBANDE AAN FIETSE.

Ek, Frederick Viljoen Ashpole, Pryskontroleur, handelende kragtens regulasie 3 van Oorlogsmaatreel No. 49 van 1946, bepaal hierby vir die hele Unie, met uitsondering van die mandaatgebied Suidwes-Afrika en die hawe en nedersetting Walvisbaai, as volg:

(1) Die maksimum prys waarteen die goedere in die Bylae hiervan vermeld, deur 'n handelaar verkoop mag word—

- (a) aan 'n ander handelaar, is die prys wat in kolom 1 van genoemde Bylae aangegee word;
- (b) aan enigeen behalwe 'n handelaar, is die prys wat in kolom 2 van genoemde Bylae aangegee word.

(2) Die maksimum prys wat in genoemde Bylae vir 'n buite- of binneband aangegee word, kan verhoog word met die koste wat die verkoper of vorige verkoper (uitsluitend die fabrikant) noodwendig moes aangaan in verband met die vervoer daarvan per spoor en/of per pad van die perseel van die fabrikant daarvan na dié van die verkoper.

(3) Die maksimum bedrag wat iemand mag vorder—

- (a) vir die aansit van 'n buiteband of 'n binneband of albei aan die voorwiel van 'n fiets is een sjeling en drie pennies; en
- (b) vir die aansit van 'n buiteband of 'n binneband of albei aan die agterwiel van 'n fiets is twee sjelings.

2. Fix the maximum price at which any sawmiller may sell any timber to any other person at the price ordinarily charged by him during the month of February 1949 for like or similar timber sold to like or similar persons on like or similar terms and conditions.

3. Fix the maximum price at which any person, including a sawmiller may sell any box shooks at the price ordinarily charged by him during the month of February 1949, for like or similar box shooks sold to like or similar persons on like or similar terms and conditions; provided that where such person did not sell like or similar box shooks during the said month or did not sell it to like or similar persons on like or similar terms and conditions, he may sell at the maximum price that may in terms of this notice be charged by a person in the same or nearest locality, who during the said month sold like or similar box shooks to like or similar persons on like or similar terms and conditions.

4. Direct that for the purpose of this notice—

- (a) “original purchaser” in relation to any timber means the importer thereof or in the case of timber produced in the Union the person who acquired such timber from the sawmiller by whom it was produced;
- (b) “sawmiller” means a person who manufactures lumber or dressed timber from sawlogs, whether in the round or square and includes a woodcutter and a manufacturer of box shooks;
- (c) “timber” includes lumber, baulks, dressed timber, and plywood but excludes box shooks.

5. Withdraw Government Notice No. 1726 of 20th July, 1950 (Maximum Prices of Timber).

PRICE CONTROL.

MAXIMUM PRICES OF BICYCLE TYRES (COVERS) AND TUBES AND MAXIMUM CHARGES FOR THE FITTING OF TYRES AND TUBES TO BICYCLES.

In terms of regulation 3 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, do hereby, throughout the Union, excluding the Mandated Territory of South West Africa and the port and settlement of Walvis Bay:

(1) Fix the maximum prices at which the goods specified in the Schedule hereto may be sold by a dealer—

- (a) to any other dealer, the prices specified in column 1 of the said Schedule, and
- (b) to any person other than a dealer, the prices specified in column 2 of the said Schedule.

(2) Direct that the maximum prices specified in the said Schedule for any tyre (cover) or tube may be increased by the addition thereto of the cost necessarily incurred by the seller and any previous seller (excluding the manufacturer) in the transportation of such tyre (cover) or tube by rail and/or road from the premises of the manufacturer thereof to that of the seller.

(3) Fix the maximum charge that may be made by any person—

- (a) for the service of fitting a tyre (cover) or tube or both to the front wheel of a bicycle at one shilling and threepence, and
- (b) for the service of fitting a tyre (cover) or tube or both to the back wheel of a bicycle at two shilling.

(4) Goewermentskennisgewing No. 1664 van 20 Julie 1950 (Maksimum Pryse van Fietsuitebande en -binnebande en maksimum prys vir die aansit van Buitebande en Binnebande aan Fietse) word hierby herroep.

OPMERKING.—Die toepassing van klosule (2) in verband met die toelaatbare verhoging vir vervoerkoste kan geïllustreer word deur die volgende voorbeeld:—

'n Groothandelaar in B koop 'n buiteband van die fabrikante uit hul dépôt in A. Vir hierdie buiteband word die groothandelprys in die Bylae, sê, as 6s. 4d. aangegee. Die spoorvrag daarop van A na B is x pennies. Die groothandelaar in B kan nou aan die kleinhandelaar, wat, sê, in C is, teen 6s. 4d. plus x pennies verkoop. Die spoorvrag en/of padvervoerkoste van B na C is sê y pennies. Die kleinhandelaar in C kan die buiteband weer vir 8s. plus x+y spoorvrag verkoop. Indien B en C dieselfde is, d.w.s. as die kleinhandelaar in dieselfde dorp as die groothandelaar is, is die maksimum kleinhandelprys slegs 8s. plus x pennies. Indien A en B dieselfde is, d.w.s. as die groothandelaar in dieselfde dorp as die fabrikant se dépôt is, is die maksimum kleinhandelprys slegs 8s. plus y pennies. Indien A, B en C dieselfde is, is die maksimum kleinhandelprys slegs 8s.

(4) Withdraw Government Notice No. 1664 of 20th July, 1950, (Maximum Prices of Bicycle Tyres and Tubes and Maximum charges for the fitting of Tyres and Tubes to Cycles).

NOTE.—The operation of clause (2) regarding the permissible increases for transportation charges may be illustrated by the following example:—

A wholesaler at point B buys a tyre from the manufacturers ex their depot at point A. For this tyre the maximum wholesale price is listed in the Schedule at, say, 6s. 4d. The railage thereon from point A to point B is x pence. The wholesaler at point B may now sell to the retailer, who is (say) at point C, for 6s. 4d. plus x pence. The railage and/or road transportation cost from point B to point C is, say, y pence. The retailer at point C may resell the tyre for 8s. plus x+y railage. If points B and C are the same, i.e. if the retailer is in the same town as the wholesaler, the maximum retail price is 8s. plus x pence only. If points A and B are the same, i.e. if the wholesaler is in the same town as the manufacturer's depot, the maximum retail price is 8s. plus y pence only. If points A, B and C are the same the maximum retail price is 8s. only.
