## MAXIMUM PRICES OF NEW AND USED MOTOR VEHICLES AND NEW MOTOR CYCLES.

In terms of regulation 9 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, hereby amend Government Notice No. 2355 of 22nd September, 1950 (Maximum Prices of New and Used Motor Vehicles and New Motor Cycles):—

1. By the substitution in paragraph (7) thereof of the words and numerals "Government Notice No. 1642 of 20th July, 1950" for the words "the notice of this date".
2. By the substitution in paragraph (8) thereof of the words and numerals "Government Notice No. 1640 of 20th July, 1950" for the words "the notice of this date".
3. By the substitution of the following new paragraph (9) for paragraph (9) thereof:—

"(9) Prescribe that notwithstanding the provisions of paragraph (1) of Government Notice No. 1640 of 20th July, 1950 relating to the issue of invoices every person who sells a new or used motor vehicle or a new motor cycle shall give to the purchaser thereof at the time of the sale or at the time when payment of the first instalment or any deposit is made, a serially numbered and dated invoice containing the following particulars:—

- (a) In the case of the sale of a new motor vehicle or new motor cycle—
  - (i) the name and address of the seller;
  - (ii) the name and address of the purchaser;
  - (iii) the date of the sale if such date differs from the date of issue of the invoice;
  - (iv) the make, type, year model and engine number (if any) of the vehicle or cycle sold;
  - (v) the price charged;
  - (vi) the amount allowed for any motor vehicle or motor cycle traded in against the purchase of the motor vehicle or motor cycle sold;
  - (vii) a full description of the motor vehicle or motor cycle traded in, giving make, type, year model and engine number (if any);
  - (viii) a detailed list of the accessories and equipment sold with the said vehicle or cycle;
  - (ix) the cost of insurance, registration, licence and any other amount actually disbursed by the seller at the request and on behalf of the purchaser;
  - (x) the maximum price of the vehicle or cycle sold.

Ek, Frederick Viljoen Ashpole, Pryskontroleur, handelende kragtens regulasie 9 van Oorlogsmaatreel No. 49 van 1946, wysig Goewermentskennisgewing No. 2355 van 22 September 1950 (Maksimum Pryse van Nuwe en Gebruikte Motorvoertuie en Nuwe Motorfietse) hierby as volg:—

1. Deur in paragraaf (7) daarvan die woorde „kennisgewing van hierdie datum” te vervang deur die woorde en syfers „Goewermentskennisgewing No. 1642 van 20 Julie 1950”.
2. Deur in paragraaf (8) daarvan die woorde „kennisgewing van hierdie datum” te vervang deur die woorde en syfers „Goewermentskennisgewing No. 1640 van 20 Julie 1950”.
3. Deur paragraaf (9) daarvan te vervang deur die volgende nuwe paragraaf (9):—

"(9) Ondanks die bepalings van paragraaf 1 van Goewermentskennisgewing No. 1640 van 20 Julie 1950, wat betrekking het op die uitreiking van fakture, moet elkeen wat 'n nuwe of gebruikte motorvoertuig of 'n nuwe motorfiets verkoop, ten tyde van die verkoop, of wanneer die eerste paaiement of 'n deposito betaal word, 'n seriegenommerde en gedateerde faktuur aan die koper daarvan verstrek wat die volgende besonderhede bevat:—

- (a) In die geval van 'n nuwe motorvoertuig of nuwe motorfiets wat verkoop word
  - (i) die naam en adres van die verkoper;
  - (ii) die naam en adres van die koper;
  - (iii) die datum van die verkoop, as dit verskil van die datum waarop die faktuur uitgereik word;
  - (iv) die fabrikant, tipe en jaarmodel en masjiennommer (as daar is) van die voertuig of fiets wat verkoop word;
  - (v) die prys wat gevra word;
  - (vi) die bedrag toegestaan op 'n motorvoertuig of motorfiets wat ingeruil word as deel van die koopprys van die motorvoertuig of motorfiets wat verkoop word;
  - (vii) 'n volledige beskrywing van die motorvoertuig of motorfiets wat ingeruil word, met vermelding van die fabrikaat, tipe, jaarmodel en masjiennommer (as daar is);
  - (viii) 'n uitvoerige lys van die toebehore en uitrusting wat saam met gemelde voertuig of fiets verkoop word;
  - (ix) die koste van versekering, registrasie, lisensiëring en enige ander bedrag wat werklik deur die verkoper op versoek van en namens die koper betaal is;
  - (x) die maksimum prys van die voertuig of fiets wat verkoop word.

- (b) In the case of the sale of a used motor vehicle—
- the particulars specified in (i) to (ix) of (a) above;
  - the maximum price of the vehicle sold, if the seller is a dealer; and
  - a statement of any additions made to the vehicle sold and/or repairs and reconditioning done thereto by the seller or on his behalf subsequent to the acquisition of such vehicle by him.

#### GENERAL NOTICE TO EXPORTERS.

The Director of Imports and Exports announces for the general information of—

- manufacturers who export goods containing raw materials imported by them; and
- merchants who export goods imported by them; that under the Export Incentive Scheme of the Directorate, provision is made for issuing additional import permits to replace in certain circumstances the value of imported materials contained in their exports.

Those desirous of availing themselves of this facility to acquire these additional import permits, issued over and above normal import allocations, should make application quarterly in duplicate on the prescribed form, specimen copies of which may be obtained from the Directorate.

Applications for the quarter ending 30th September, 1950, should be forwarded as soon as possible after that date to the Director of Imports and Exports, Munlochy Building, Schoeman Street, Pretoria.

#### IMPORTATION OF HIDES AND SKINS.

His Excellency the Governor-General has, under the powers vested in him by section *twenty-three* of the Diseases of Stock Act, 1911 (Act No. 14 of 1911), as amended, made the following regulation in substitution for regulation 7 (as substituted by Government Notice No. 1071 of the 11th June, 1943), of the regulations published under Government Notice No. 638 of the 14th June, 1915:—

7. (1) No person shall introduce or cause to be introduced into the Union any hide or skin derived from the carcass of any antelope, buffalo, cattle, camel, deer, elephant, equine, goat, giraffe, hippopotamus, rhinoceros, rockrabbit, sheep, swine, or any other animal of the class *Ungulata* except under the authority of a written permit issued by the Principal Veterinary Officer, or otherwise than in accordance with the conditions which may be specified in such permit.

(2) The issue of a permit, referred to in sub-regulation (1), may be refused unless—

- sufficient proof is produced to the Principal Veterinary Officer to satisfy him that the hide or skin in question is not infected with or likely to convey any animal disease; and
- in the case where the Principal Veterinary Officer so requires, the hide or skin is, to his satisfaction, subjected to such sterilization or disinfection process as he may determine.

(3) The prohibition imposed by sub-regulation (1) shall not apply in the case of the introduction of hides or skins from Basutoland or the Mandated Territory of South West Africa.

bekend dat daar ooreenkomsdig die Uitvoerbonusskema van die Direksie voorsiening gemaak word vir die uitreiking van addisionele invoerpermitte om in sekere gevalle die waarde te vervang van ingevoerde materiaal wat in hul uitvoere ingesluit is.

#### INVOER VAN HUIDE EN VELLE.

Sy Eksellensie die Goewerneur-generaal het, kragtens die bevoegdheid hom verleen by artikel *drie-en-twintig* van die Veeziekten Wet, 1911 (Wet No. 14 van 1911), soos gewysig, onderstaande regulasie gemaak ter vervanging van regulasie 7 (soos vervang deur Goewermentskennisgewing No. 1071 van 11 Junie 1943) van die regulasies gepubliseer by Goewermentskennisgewing No. 638 van 14 Junie 1915:—

7. (1) Niemand mag 'n huid of vel afkomstig van die karkas van 'n wildbok, buffel, bees, kameel, takbok, olifant, dier van die perdefamilie, bok, kameelperd, seekoel, renoster, klipdassie, skaap, vark of van 'n ander hoefdier in die Unie invoer of laat invoer nie, behalwe op gesag van 'n skriftelike permit deur die hoofveearts uitgereik, of anders as ooreenkomsdig die voorwaardes wat in sodanige permit gestel word.

(2) Die uitreiking van 'n permit, genoem in subregulasie (1), kan geweier word tensy—

(a) daar voldoende bewys aan die hoofveearts voorstellé word wat hom tevrede stel dat die onderhawige huid of vel nie met 'n dieresiekte besmet is of dit waarskynlik kan oordra nie; en

(b) waar die hoofveearts dit vereis, die huid of vel tot sy bevrediging aan sodanige sterilisasie- of ontsmettingsproses onderwerp word as hy bepaal.

(3) Die verbod opstellé by subregulasie (1) is nie van toepassing op die invoer van huide of velle uit Basoetoland of die Mandaatgebied van Suidwes-Afrika nie.
