Regulation 19 of the Regulations promulgated under the said Act provides that any person who after written notice has been served on him, fails to supply the required information within the period specified, shall be guilty of an offence and liable on conviction to a fine not exceeding £50 or to imprisonment for a period not exceeding six months.
