In terms of regulation 3 of War Measure No. 49 of 1946, I Frederick Viljoen Ashpole, Price Controller, hereby amend Government Notice No. 1713 of 20th July, 1950 (Maximum Prices op Groceries) by the substitution of the items in the Second, Third and Fourth Schedules hereto for the corresponding items in the Second, Third and Fourth Schedules hereto.

NOTE.—The effect of this notice is to increase the maximum prices of breakfast oats and oatmeal by 1d. per 2 lb. packet and $\frac{1}{2}$ d. per lb. respectively. This increase is due to the high cost of imported raw oats.

MAXIMUM PRICES OF CHILLED EGGS.

In terms of regulation 3 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, do hereby, throughout the Union, excluding the Mandated Territory of South West Africa and the port and settlement of Walvis Bay—

1. Fix the maximum prices at which chilled eggs may be sold by a dealer to another dealer at the prices specified in column 1 of the Schedule hereto.

2. Fix the maximum prices at which chilled eggs may, except in the case of a sale by a dealer to another dealer, be sold by any person to any other person at the prices specified in column 2 of the Schedule hereto; provided that if eggs are sold in cartons with fillers, the appropriate price so specified may be increased by *twopence* per dozen.

3. Direct that—

(1) every retail dealer in chilled eggs shall display under the heading "Maximum Prices of Chilled Eggs—Maksimum Pryse van Verkoelde Eiers", in both official languages, in clearly legible form and at a place in his shop or other place of business which is prominent and easily accessible to the public, the maximum prices which, in terms of paragraph 2 hereof, he may charge for such eggs;

(2) the provisions of this notice shall not apply to any sale of eggs by any person to the Director of Food Supplies and Distribution or by the Director of Food Supplies and Distribution to any person; and

(3) any expression to which in the regulations contained in the Schedule to Government Notice No. 632 of 28th March, 1947 (Grading, Packing and Marking of Chilled Eggs), as amended, a meaning has been assigned, bears when used in this notice, the meaning so assigned to that expression.

4. Withdraw Government Notice No. 1731 of 20th July, 1950 (Maximum Prices of Chilled Eggs).

ALGEMENE KENNISGEWING AAN INVOERDERS VAN VERBRUIKERSGOEDERE.

Die Direkteur van Invoer en Uitvoer maak vir algemene inligting bekend dat, in ooreenstemming met magtiging deur die Minister van Ekonomiese Sake verleen, permitte vir die invoer van algemene verbruikersgoedere ten opsigte van die tydperk 1 Januarie 1951 tot 30 Junie 1951, nou uitgereik word.

2. Hierdie permitte is weer op die V.A.B.-waarde van die 1948-invoere van verbruikersgoedere gebaseer, min die V.A.B.-waarde van die invoere van dié verbruikersgoedere waarop die bepalings van Goewermentskennisgewing No. 482 van 8 Maart 1950, soos gewysig by Goewermentskennisgewing No. 557 van 10 Maart 1950 van toepassing is en wat as die „vry lys” bekendstaan, en op dieselfde algemene basis as dié uiteengesit in Goewermentskennisgewing No. 1308 van 9 Junie 1950, behalwe dat die volgende toegegewings gedoen sal word:—

RESTRICTED PERMITS.

Seventy-five per cent. of the total allocation will be issued in the form of a Restricted Permit available for purchases in the soft currency countries only.

GENERAL PERMITS.

The balance, i.e. twenty-five per cent. of the allocation will be issued in the form of a general permit available for purchases in both hard and soft currency countries.

These permits are valid for direct shipment of goods not earlier than 1st January, 1951, and not later than the 30th September, 1951, and authorise the importer to import general merchandise, excluding goods listed in Schedules A and B to Government Notice No. 2386, dated the 5th November, 1948, as amended and as may be amended from time to time, and known as the "prohibited list".

3. The permits are identifiable by serial numbers bearing the prefixes G.C. for general permits and R.C. for restricted permits, respectively.

4. In order to accommodate the many importers who desire—

- (a) to increase the amount available for purchases in hard currency countries; and
- (b) to import goods which appear in Schedules A and B to Government Notice No. 2386, dated the 5th November, 1948, as amended and as may be amended from time to time, and known as the "prohibited list";

it has been decided to allow conversions in the manner as outlined hereunder.

5. In the case of paragraph 4 (a) above, importers will be permitted to convert their restricted consumer goods permits into hard currency (general permits) on the following basis:—

Fifty per cent. of the restricted permit on the basis of £1. hard currency for every £2 soft currency surrendered and the remaining fifty per cent. at the rate of £1 hard currency for every £5 soft currency surrendered.

Importers wishing to avail themselves of this facility should apply, in writing, to the Director of Imports and Exports (Consumer Goods Section), Munlochy Buildings, Pretoria, stating—

- (a) amount of soft currency they wish to convert to hard;
- (b) name and address of their bankers;
- (c) the restricted permit number and amount of the permit (permits should not be forwarded by applicants with their request); and
- (d) the most convenient branch of the South African Reserve Bank.

The various branches of the South African Reserve Bank will undertake the work of issuing the general permits and adjusting the restricted permits.

Authority for conversion will be conveyed on a form entitled "Authorization to Convert Soft Currency into Hard Currency". Upon receipt of such an authorization form in response to applications for conversion, importers should hand the permits concerned together with the authorization form to their bank, which will, in turn, make arrangements with the South African Reserve Bank as indicated above.

6. In regard to paragraph 4 (b) above, importers will be permitted to convert both their restricted- and general consumer goods permits to enable the importation of goods on the "prohibited list" on the basis of surrendering £5 of the available permits for every £1 prohibited goods to be imported from either soft or hard currency countries, as the case may be.

BEPERKTE PERMITTE.

Importers wishing to avail themselves of this facility should apply, in writing, to the Director of Imports and Exports (Consumer Goods Section), Munlochy Buildings, corner Schoeman and v. d. Walt Streets, Pretoria, stating—

- (a) amount of currency they wish to convert into a permit allowing them to import goods on the "prohibited list";
- (b) the goods they wish to import.

The relevant permits should accompany the application and in the case of partly converted permits the old permit, suitably endorsed as well as the new permit, will be returned to the applicant.

AMENDMENT.

In terms of section twenty-nine of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, STEPHANUS PETRUS LE ROUX, Minister of Agriculture, hereby make known that the Livestock and Meat Industries Control Board referred to in section 3 of the Livestock and Meat Control Scheme, published by Proclamation No. 265 of 1945, as amended, has, under the powers vested in it by section 14 of the said Scheme, with my approval, amended the prohibitions and determinations published in the Schedule to Government Notice No. 2100 of 1950, in the manner set out in the Schedule hereto.

And I hereby further make known that the said amendments shall come into operation on the 31st December, 1950.

SCHEDULE.

1. Clause 2 of the Schedule to Government Notice No. 2100 of 1950, as amended, is hereby amended by the substitution for sub-clause (1) thereof, of the following sub-clause:—

"(1) No producer of slaughter animals shall in any controlled area sell—

(a) any sound carcase, in the case of—

(i) a calf, pig, lamb, sheep or goat carcase, at a price other than a price calculated in accordance with the weight of such carcase at the rate specified in Annexure I, II or III hereto, as the case may be;

(ii) a cattle carcase, at a price below a price calculated in accordance with the weight of such carcase at the minimum rate or above a price calculated in accordance with the weight of such carcase at the maximum rate specified in Annexure IV hereto;

in respect of that controlled area for a carcase of the class or grade specified in the relevant Annexure;

(b) any detained carcase, in the case of—

(i) a pig carcase, at a price other than a price calculated in accordance with the weight of such carcase at a rate thirty-five per cent. less than the rate specified in Annexure II hereto;

(ii) a cattle carcase, at a price below a price calculated in accordance with the weight of such carcase at a rate ten per cent. less than the minimum rate or above a price calculated in accordance with the weight of such carcase at a rate ten per cent. less than the maximum rate specified in Annexure IV hereto;

in respect of that controlled area for a carcase of the class or grade specified in the relevant annexure:

Provided that if the prices fixed for such carcases in respect of the week during which the slaughter animals, from which they are derived, are received at an abattoir in a controlled area are higher than the prices fixed in respect of the week during which the animals are slaughtered, the carcases shall be sold at the prices fixed in respect of the week during which the animals are so received."
