Ek, ERIC HENDRIK LOUW, in my hoedanigheid van Minister van Ekonomiese Sake en handelende kragtens die bevoegdheid my verleen deur Oorlogsmaatreef No. 146 van 1942, soos gewysig, gelees met Oorlogsmaatreef No. 75 van 1945, gelas hierby as volg:—

(1) Algemene en beperkte invoerpermitte uitgereik deur die Direkteur van Invoer en Uitvoer vir die eerste helfte van 1951, en geldig vir verskeping tussen 1 Januarie en 30 September 1951, sal nou van toepassing wees op die volle kalenderjaar 1951 en sal geldig wees vir verskeping tussen 1 Januarie 1951 en 31 Maart 1952.

(2) Magtigingsbriewe (L.A.G. en L.A.R.) met die opskrif „Invoerkwotas; Eerste Semester—1951”, uitgereik deur die Direkteur van Invoer en Uitvoer, en geldig om bestellings vir verskeping te plaas gedurende die tydperk 1 Januarie tot 30 Junie 1951, sal geldig wees vir die tydperk 1 Januarie tot 31 Desember 1951, mits die bestellings, daarkragtens gemagtig, geplaas en bekragtig word voor of op 30 November 1951 en mits die goedere nie later as 31 Maart 1952 uit die lewerende land verskeep word nie.

CONTROL OF IMPORTS.

I, ERIC HENDRIK LOUW, in my capacity as Minister of Economic Affairs, and acting under, and by virtue of the powers conferred upon me by War Measure 146 of 1942, as amended, read with War Measure 75 of 1945, do hereby order as follows:—

(1) That General and Restricted Import Permits issued by the Director of Imports and Exports for the first half of 1951 and valid for shipment between the 1st January and 30th September, 1951, shall now apply to the full calendar year 1951 and shall be valid for shipment between the 1st January, 1951 and the 31st March, 1952.

(2) That Letters of Authority (L.A.G. and L.A.R.) bearing the heading “Import Quotas: First Semester, 1951” issued by the Director of Imports and Exports, and valid for placing orders for shipment during the period 1st January to 30th June, 1951, shall be valid for the period 1st January to 31 December, 1951, provided that the orders authorised thereunder are placed and confirmed not later than 30th November, 1951, and provided that the goods are shipped from the country of supply not later than 31st March, 1952.

NOTE.—The effect of this notice is that both Import Permits and Letters of Authority for the first six months of 1951 are automatically extended to refer to the full calendar year 1951, and the latest date of shipment from the country of supply will now be 31st March, 1952, instead of 30th September, 1951.

Ek, Frederick Viljoen Ashpole, Prys-kontroleur, handelende kragtens regulasies 3, 9 en 11 van Oorlogsmaatreeël No. 49 van 1946, bepaal hierby, met ingang van 1 Maart 1951, vir die hele Unie uitgesonderd die mandaatgebied Suidwes-Afrika en die hawe en nedersetting Walvisbaai, as volg:—

1. Ondanks andersluidende bepalinge vervat in Goewermenskennisgewing No. 1635 van 20 Julie 1950, wat betrekking het op die berekening van koste, is die koste aan wal vir doeleindes van paragraaf 2 hiervan van—

- (1) gebaalde breiwool wanneer dit deur die invoerder daarvan—
 - (a) aan 'n handelaar verkoop word, die netto faktuurkoste van die breiwool plus *twalf en 'n half persent* daarvan;
 - (b) aan enigeen behalwe 'n handelaar verkoop word, die netto faktuurkoste van die breiwool plus *vyftien persent* daarvan;
- (2) breiwool in dose of kiste wanneer dit deur die invoerder daarvan—
 - (a) aan 'n handelaar verkoop word, die netto faktuurkoste van die breiwool plus *twintig persent* daarvan;
 - (b) aan enigeen behalwe 'n handelaar verkoop word, die netto faktuurkoste van die breiwool plus *twee-en-twintig en 'n half persent* daarvan.

2. PRICE CONTROL.

MAXIMUM PRICES OF KNITTING WOOLS.

In terms of regulations 3, 9 and 11 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, do hereby, with effect from 1st March, 1951, throughout the Union, excluding the Mandated Territory of South West Africa and the port and settlement of Walvis Bay:—

1. Prescribe that notwithstanding anything contained in Government Notice No. 1635 of 20th July, 1950, relating to the determination of costs, the landed cost for the purposes of paragraph 2 hereof of any—

- (1) baled knitting wool, when sold by the importer thereof—
 - (a) to a dealer, shall be the net invoiced cost of such knitting wool plus *twelve and one half per cent. thereof*;
 - (b) to any person who is not a dealer, shall be the net invoiced cost of such knitting wool plus *fifteen per cent. thereof*;

(2) boxed or cased knitting wool when sold by the importer thereof—

- (a) to a dealer, shall be the net invoiced cost of such knitting wool plus *twenty per cent. thereof*;
- (b) to any person who is not a dealer, shall be the net invoiced cost of such knitting wool plus *twenty-two and one half per cent. thereof*.

2. Fix the maximum price at which any knitting wool, other than a knitting wool specified in the Schedule hereto, may, except in the case of a sale by a dealer to another dealer, be sold by any person to any other person at the landed cost thereof; determined in accordance with paragraph 1 hereof plus *thirty-five per cent.* of such landed cost.

3. Fix the maximum prices at which the knitting wools specified in the Schedule hereto may, except in the case of a sale by a dealer to another dealer, be sold by any person to any other person at the prices specified in the said Schedule.

4. Waar breiwool in paragraaf 2 hiervan genoem deur 'n handelaar aan 'n ander handelaar verkoop word, moet die verkoper, benewens die besonderhede wat hy op die faktuur moet uitreik ingevolge Goewermentskennisgewing No. 1640 van 20 Julie 1950, wat betrekking het op die uitreiking van fakture, daarop die maksimum prys aangee waarteen sodanige breiwool ooreenkomstig hierdie kennisgewing verkoop mag word.

Ek, Frederick Viljoen Ashpole, Pryskontroleur, handelende kragtens regulasie 3 van Oorlogsmaatregel No. 49 van 1946, bepaal hierby vir die hele Unie, met uitsondering van die mandaatgebied Suidwes-Afrika en die hawe en nedersetting Walvisbaai, as volg:—

(1) Die maksimum pryse waarteen die goedere in die Bylae hiervan vermeld, deur 'n handelaar verkoop mag word—

- (a) aan 'n ander handelaar, is die pryse wat in kolom 1 van genoemde Bylae aangegee word;
- (b) aan enigeen behalwe 'n handelaar, is die pryse wat in kolom 2 van genoemde Bylae aangegee word.

(2) Die maksimum pryse wat in genoemde Bylae vir 'n buite- of binneband aangegee word, kan verhoog word met die koste wat die verkoper of vorige verkoper (uitsluitende die fabrikant) noodwendig moes aangaan in verband met die vervoer daarvan per spoor en/of per pad van die perseel van die fabrikant daarvan na dié van die verkoper.

(3) Die maksimum bedrag wat iemand mag vorder—

- (b) vir die aansit van 'n buiteband of 'n binneband of albei aan die agterwiel van 'n fiets is twee sjielings.

4. Direct that in any sale by a dealer to another dealer of any knitting wool referred to in paragraph 2 hereof the seller shall, in addition to the particulars required to be given by him on the invoice issuable by him in terms of Government Notice No. 1640 of 20th July, 1950, relating to the issue of invoices, endorse thereon the maximum price at which such knitting wool may be sold in terms of this notice.

5. Withdraw Government Notice No. 44 of the 5th January, 1951, relating to the maximum prices of knitting wools.

PRICE CONTROL.

MAXIMUM PRICES OF BICYCLE TYRES (COVERS) AND TUBES AND MAXIMUM CHARGES FOR THE FITTING OF TYRES AND TUBES TO BICYCLES.

In terms of regulation 3 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, do hereby, throughout the Union, excluding the Mandated Territory of South West Africa and the port and settlement of Walvis Bay:—

(1) Fix the maximum prices at which the goods specified in the Schedule hereto may be sold by a dealer—

- (a) to any other dealer, the prices specified in column 1 of the said Schedule; and
- (b) to any person other than a dealer, the prices specified in column 2 of the said Schedule.

(2) Direct that the maximum prices specified in the said Schedule for any tyre (cover) or tube may be increased by the addition thereto of the cost necessarily incurred by the seller and any previous seller (excluding the manufacturer) in the transportation of such tyre (cover) or tube by rail and/or road from the premises of the manufacturer thereof to that of the seller.

(3) Fix the maximum charge that may be made by any person—

- (a) for the service of fitting a tyre (cover) or tube or both to the front wheel of a bicycle at one shilling and threepence; and
- (b) for the service of fitting a tyre (cover) or tube or both to the back wheel of a bicycle at two shillings.

(4) Goewermentskennisgewing No. 2894 van 17 November 1950 (Maksimum Pryse van Fietsbuitebande en -binnebande en maksimum pryse vir die aansit van Buitebande en Binnebande aan Fietse) word hierby herroep.

OPMERKING.—Die toepassing van klousule (2) in verband met die toelaatbare verhoging vir vervoerkoste kan geïllustreer word deur die volgende voorbeeld:—

'n Groothandelaar in B koop 'n buiteband van die fabrikante uit hul dépôt in A. Vir hierdie buiteband word die groothandelsprys in die Bylae, sê, as 6s. 4d. aangegee. Die spoorvrag daarop van A na B is x pennies. Die groothandelaar in B kan nou aan die kleinhandelaar, wat, sê, in C is, teen 6s. 4d. plus x pennies verkoop. Die spoorvrag en/of padvervoerkoste van B na C is, sê, y pennies. Die kleinhandelaar in C kan die buiteband weer vir 8s. plus x + y spoorvrag verkoop. Indien B en C dieselfde is, d.w.s. as die kleinhandelaar in dieselfde dorp as die groothandelaar is, is die maksimum kleinhandelsprys slegs 8s. plus x pennies. Indien A en B dieselfde is, d.w.s. as die groothandelaar in dieselfde dorp as die fabrikant se dépôt is, is die maksimum kleinhandelspryse slegs 8s. plus y pennies. Indien A, B en C dieselfde is, is die maksimum kleinhandelsprys slegs 8s.

NOTE.—The operation of clause (2) regarding the permissible increases for transportation charges may be illustrated by the following example:—

The railage and/or road transportation cost from point B to point C is, say, y pence. The retailer at point C may resell the tyre for 8s. plus x + y railage. If points B and C are the same, i.e. if the retailer is in the same town as the wholesaler, the maximum retail price is 8s. plus x pence only. If points A and B are the same, i.e. if the wholesaler is in the same town as the manufacturer's depot, the maximum retail price is 8s. plus y pence only. If points A, B and C are the same the maximum retail price is 8s. only.

It is hereby notified for general information that His Excellency the Governor-General has approved, in terms of section *fourteen* of the Perishable Products Export Control Act, 1926 (Act No. 53 of 1926), of the amendment of the Regulations published in Government Notice No. 1959 dated the 11th November, 1927 (as amended by Government Notice No. 593, dated the 19th March, 1948, and Government Notice No. 2854 dated the 17th November, 1950), as set forth in the Annexure hereto.

Regulation 40 is hereby amended by designating the existing regulation paragraph (a) and by adding at the end thereof the following new paragraphs:—

- (b) The levy referred to in paragraph (a) shall be payable by the exporter concerned or his agent to the South African Railways and Harbours Administration at the time of shipment of the product.

It is hereby notified that the Livestock and Meat Industries Control Board, constituted in terms of section *three* of the Livestock and Meat Control Scheme published by Proclamation No. 265 of 1945, as amended, has, under the powers vested in it by section 14 of the said Scheme, decided that it will, during the periods stated in the Schedule hereto in the controlled areas specified in the said Schedule buy cattle carcasses from producers of slaughter animals, in the case of—

- (a) any sound carcase, at a price calculated in accordance with the rate specified in the said Schedule;
