PRICE CONTROL.

MAXIMUM PRICES OF CLOCKS AND WATCHES.

In terms of regulation 3 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, do hereby throughout the Union, excluding the Mandated Territory of South West Africa and the port and settlement of Walvis Bay:—

1. Subject to the provisions of paragraph 2 hereof—

(1) fix the maximum price at which any clock or watch may be sold to a dealer by the importer thereof at the cost of such clock or watch to the importer plus 30 per cent. thereof;

(2) fix the maximum price—

(a) at which any striking and/or chiming clock (excluding an alarm clock that does not also strike or chime), any clock of seven jewels or more or any watch may be sold to any person by any person other than the importer thereof at the cost of such clock or watch to the seller plus 65 per cent. thereof;

(b) at which any clock, other than a clock referred to in sub-paragraph (a) hereof, may be sold to any person by any person other than the importer thereof at the cost of such clock to the seller plus 50 per cent. thereof;

(3) fix the maximum price at which any clock or watch may be sold to any person other than a dealer by the importer thereof at the cost of such clock or watch to such importer plus 90 per cent. thereof.

2. Direct that notwithstanding anything to the contrary contained in sub-paragraph (2) (a) or sub-paragraph (3) of paragraph 1 hereof any licensed dealer who, at the time of the sale by him of any clock referred to in sub-paragraph (2) (a) of paragraph 1 hereof or any watch, gives to the purchaser a written and signed guarantee in the form prescribed in the Schedule hereto, may increase by five units the percentage which, in terms of sub-paragraph (2) (a) or sub-paragraph (3) of paragraph 1 hereof, as the case may be, he may add to his cost.

3. Withdraw the following Government Notice relating to the maximum prices of clocks and watches, namely, No 594 of 28th March, 1952.

MAXIMUM PRICES OF SWEETS.

In terms of regulation 3 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, do hereby throughout the Union, excluding the Mandated Territory of South West Africa and the port and settlement of Walvis Bay:—

1. Fix the maximum price at which sweets (including chocolate) may be sold by any person to any other person at the maximum price at which in terms of Government Notice No. 665 of 28th March, 1952, the seller may sell such sweets plus an amount calculated at the rate of *twopence* per lb., provided that this addition shall not apply to 3d. lines and 1d. lines, i.e. units of sweets, chocolates or chocolate separately wrapped or packaged to be sold by the manufacturer for retailing at 3d. each and packed in boxes containing 2 or more dozen and labelled as to such price and quantity by the manufacturer, and those units or separate pieces or slabs of sweet or chocolate to be sold by the manufacturer for retailing at 1d. each and packed in boxes containing one half gross and labelled as to such price and quantity by the manufacturers or to lines sold by count i.e. those sweets or chocolates sold by count by the manufacturer for retailing by count not exceeding sixpence per count and packed in boxes containing one or more gross and labelled as to such retail selling price and content packing by the manufacturer, subject to such lines having been sold and invoiced by the manufacturer as such count lines in the six months ended 29th February, 1952.

2. Amend Government Notice No. 737 of 28th March, 1952 (Maximum Prices of Beers, Cigarettes, Tobacco and Sweets) by the deletion of paragraph (4) thereof relating to sweets.

provided that if any cattle carcase or portion thereof or any cattle offal or hide is, after it has been purchased by any person in accordance with the Schedule to Government Notice No. 2103 of 1950, condemned solely by reason of contact with carcasses, offal or hides referred to in paragraph (a) or (b), the purchaser of such carcasses or portions thereof or hides or offal shall be compensated out of the funds collected from the said levy at the rate fixed for the calculation of the price at which the carcasses or portions thereof, or hides or offal were purchased by such purchaser";

- (d) by the substitution for clause 5, of the following clause:—

"5. Any person claiming compensation in respect of a dressed carcase or any portion thereof or any hide or offal referred to in clause 4 shall submit to the Board a certificate issued by competent authority setting out all the grounds on which such carcase or portion thereof or hide or offal was liable to condemnation in the interests of public health";

- (e) by the insertion in clause 6 after the word "shall", where it occurs for the first time, of the words "for the purposes of clause 4";

- (f) by the substitution for the proviso to clause 6, of the following proviso:—

In terms of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, STEPHANUS PETRUS LE ROUX, Minister of Agriculture, hereby make known that the Livestock and Meat Industries Control Board, referred to in section 3 of the Livestock and Meat Control Scheme, published by Proclamation No. 265 of 1945, as amended, has, under the powers vested in it by section 14 of the said scheme, with my approval, amended the Schedule to Government Notice No. 2100 of 1950, as amended, in the manner set out in the Schedule hereto.
