PROCLAMATION

BY HIS EXCELLENCY THE HONOURABLE ERNEST GEORGE JANSEN, DOCTOR OF LAWS, GOVERNOR-GENERAL OF THE UNION OF SOUTH AFRICA.

PROHIBITION ON THE SALE OF CERTAIN MEALIE PRODUCTS UNLESS PACKED OR MARKED ACCORDING TO GRADE IN PRESCRIBED MANNER.

Under the powers vested in me by section *thirty-six* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I do hereby declare that as from the 1st of May, 1952, no person may sell mealie flour, bakers' cones, sifted granulated mealie meal, unsifted granulated mealie meal, unsifted non-granulated mealie meal, mealie grits, mealie rice, samp, unsifted crushed mealies, sifted crushed mealies, fine sifted crushed mealies, germ-meal, hominy chop or mealie bran in the Union, unless it is packed or marked according to grade in a manner prescribed by regulation under the said Act.

PRICES OF MEALIES AND MEALIE PRODUCTS.

In terms of sub-section (1) of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, STEPHANUS PETRUS LE ROUX, Minister of Agriculture, do hereby make known that the Mealie Industry Control Board, referred to in section 2 of the Mealie Control Scheme, published by Proclamation No. 77 of 1939, as amended, has, in terms of section 22 of that Scheme imposed the prohibitions mentioned—

- (a) in Schedule A hereto in connection with the sale of mealies by producers of mealies;
- (b) in Schedule B hereto in connection with the sale of mealies by persons other than producers of mealies in quantities of not less than one bag at a time to a particular person;

PRYSSE VAN MIELIES EN MIELIEPRODUKTE.

Kragtens subartikel (1) van artikel *nege-en-twintig* van die Bemarkingswet, 1937 (Wet No. 26 van 1937), soos gewysig, maak ek, STEPHANUS PETRUS LE ROUX, Minister van Landbou, hierby bekend dat die Raad van Beheer oor die Mielenywerheid wat in artikel 2 van die Mieliereelingskema, gepubliseer by Proklamasie No. 77 van 1939, soos gewysig, genoem word, kragtens artikel 22 van die Skema, die verbodsbeplings uiteengesit—

- (a) in Bylae A hiervan in verband met die verkoop van mielies deur produsente van mielies;
- (b) in Bylae B hiervan in verband met die verkoop van mielies deur iemand anders as 'n produsent van mielies in hoeveelhede van minstens een sak tegelyk aan 'n bepaalde persoon;

- (c) in Schedule C hereto in connection with the sale of mealie products by any person in quantities of not less than one bag at a time to a particular person; and
 (d) in Schedule D hereto in connection with the sale of mealies or mealie products by any person in quantities of less than one bag at a time to a particular person;

in substitution of the prohibitions made known by Government Notice No. 1014 of 27th April, 1951, as amended by Government Notice No. 1488 of 15th June, 1951, Government Notice No. 1870 of 20th July, 1951, and Government Notice No. 3251 of 21st December, 1951, with effect from 1st May, 1952, and these prohibitions shall remain in force until the 30th day of April, 1953, unless amended at an earlier date.

SCHEDULE A.

PRODUCERS' PRICES OF MEALIES.

1. No producer of mealies shall sell—

- (a) mealies, except mealies intended for seed purposes, of any of the grades mentioned in the table below, in quantities of 200 lb. net weight or more at a time, and—
 (i) contained in new or grade 1 second-hand bags at a price other than the price specified in column 1 of that table for mealies of that grade;
 (ii) contained in grade 2 second-hand bags at a price other than the price specified in column 1 of that table for mealies of that grade less 6d. per bag;
 (iii) delivered to the elevators of the South African Railways and Harbours Administration in the period from 1st May, 1952, to 30th April, 1953, and represented by elevator receipts issued by the said Administration, at a price other than the price specified in column 2 of that table for mealies of that grade;
 (b) mealies intended for seed purposes at a price less than 30s. per bag;
 (c) mealies, not being mealies intended for seed purposes and not being mealies of a grade mentioned in the table below, at a higher price than 29s. 2d. per 200 lb. net weight when the mealies are contained in bags;
 (d) mealies, except mealies intended for seed purposes, in quantities of less than 200 lb. net weight at a time—
 (i) of any of the grades mentioned in the table below at a price other than 1½d. per lb.;
 (ii) not being mealies of a grade mentioned in the table below, at a higher price than 1½d. per lb.;

provided that in the calculation of the amount payable an amount less than a half-penny may be increased to a half-penny.

- (a) mielies, behalwe mielies bestem vir saaddoeleindes, van een of ander van die grade in die tabel hieronder genoem, in hoeveelhede van 200 lb. netto gewig of meer tegelyk, en—
 (i) verpak in nuwe of graad 1 tweedehandse sakke teen 'n ander prys as die prys in kolom 1 van die tabel vir mielies van dié graad;
 (ii) verpak in graad 2 tweedehandse sakke teen 'n ander prys as die prys in kolom 1 van die tabel vir mielies van dié graad, min 6d. per sak;
 (iii) gelewer aan die graansuikers van die Suid-Afrikaanse Spoerweg- en Hawensadministrasie in die tydperk van 1 Mei 1952 tot 30 April 1953, en verteenwoordig deur graansuikerkwitansies, uitgereik deur genoemde Administrasie, teen 'n ander prys as die prys in kolom 2 van die tabel vir die mielies van dié graad;
 (b) mielies bestem vir saaddoeleindes teen 'n laer prys as 30s. per sak;
 (c) mielies in sakke bevat, behalwe mielies bestem vir saaddoeleindes en uitgesonderd mielies van een of ander van die grade in die tabel hieronder genoem, teen 'n prys hoër as 29s. 2d. per 200 lb. netto gewig;
 (d) mielies, behalwe mielies bestem vir saaddoeleindes, in hoeveelhede minder as 200 lb. netto gewig tegelyk—

2. The prices for the respective grades of mealies specified in clause 1, shall in the case of mealies produced in—

- (a) Area A, apply in respect of mealies delivered to the order of the Board or the order of an agent of the Board either at the premises of such agent of the Board or at his nearest station or at the nearest station of the producer;
- (b) Area B, apply in respect of mealies delivered free on rail producer's nearest station, or delivered to the premises of the trader, at whichever point delivery is effected in terms of the conditions of sale of the mealies.

SCHEDULE B.

TRADERS' PRICES OF MEALIES.

SALES IN BAG-LOT QUANTITIES.

1. (1) Except in the case of mealies intended for seed purposes, no person shall sell in the Union mealies contained in bags of a grade mentioned in the following table (excluding mealies represented by an elevator receipt issued by the South African Railways and Harbours Administration), in quantities of more than nine bags to one and the same person at one and the same time, at a price in excess of the price specified in that table in respect of mealies of that grade.

(2) No person shall sell in the Union—

- (a) mealies intended for seed purposes at a price of less than 30s. per bag;
- (b) mealies contained in bags, not being mealies of a grade mentioned in the table to sub-clause (1), and not being mealies intended for seed purposes, at a price of more than 28s. 2d. per bag.

2. The prices specified in clause 1—

- (a) may be increased by an amount not exceeding 7d. per 200 lb. net weight in respect of mealies sold in quantities of five to nine bags at a time to any one person, and by an amount not exceeding 1s. 1d. per 200 lb. net weight in respect of mealies sold in quantities of one to four bags at a time to any one person;
- (b) may be increased where rail facilities are available by an amount equal to the railage laid down by the South African Railways Administration in connection with the transport by rail of such mealies, or where transport facilities by the Railway Road Motor Service are available, the tariff laid down by the South African Railways and Harbours Administration in respect of such transport, or where rail or R.M.S. facilities are not available, by an amount to cover the cost of transport equal to the actual cost incurred in connection with such transport; provided that in the latter case the amount by which the said prices may be increased to cover the cost of transport, shall not exceed 1d. per mile for the first ten miles and 4d. per mile for distances beyond ten miles per 100 lb. net weight of mealies so transported;
- (c) may be further increased where mealies are consigned to or from a station where cartage charges for collection and delivery are levied by the South African Railways and Harbours Administration, by an amount equal to the charges so levied by the said Administration;

2. Die pryse vir die onderskeie grade mielies in klosusle 1 gemeld, geld in die geval van mielies geproduseer in—

- (a) kan vermeerder word met 'n bedrag van hoogstens 7d. per 200 lb. netto gewig ten opsigte van mielies verkoop in hoeveelhede van vyf tot nege sakke tegelyk aan een en dieselfde persoon en met 'n bedrag van hoogstens 1s. 1d. per 200 lb. netto gewig ten opsigte van mielies verkoop in hoeveelhede van een tot vier sakke tegelyk aan een en dieselfde persoon;
- (b) kan vermeerder word waar spoorfasiliteite beskikbaar is, met 'n bedrag gelyk aan die spoorvrag deur die Suid-Afrikaanse Spoornet- en Hawensadministrasie ten opsigte van die vervoer per spoor van sodanige mielies neergelê, of, waar vervoergeriewe per spoorwegpadmotordiens beskikbaar is, die tarief deur die Suid-Afrikaanse Spoornet- en Hawensadministrasie ten opsigte van sodanige vervoer vasgestel, of waar geen spoor- of padmotordiensfasiliteite beskikbaar is nie, met 'n bedrag, tot dekking van die vervoerkoste, gelyk aan die werklike koste aangegaan in verband met die vervoer van bedoelde mielies, met dien verstande dat in die laasgenoemde geval die bedrag waarmee genoemde prys tot dekking van die vervoerkoste vermeerder kan word, nie hoër mag wees nie, as 1d. per myl vir die eerste tien myl en 4d. per myl vir afstande verder as tien myl per 100 lb. netto gewig van die mielies aldus vervoer nie;
- (c) kan verder vermeerder word waar mielies versend word van of na 'n stasie waar bestelkoste vir afhaal en aflewering deur die Suid-Afrikaanse Spoornet- en Hawensadministrasie gehef word, met 'n bedrag gelyk aan die koste aldus deur genoemde Administrasie gehef;

(d) shall apply in respect of mealies paid for in cash, or not later than the end of the month immediately following the month during which delivery or despatch of the mealies was effected and may, where payment is effected after the lapse of that period, be increased by 2d. per 200 lb. in respect of every month or part thereof after the end of the month immediately following upon the month during which delivery or despatch of those mealies was effected and during which the price remains unpaid.

SALES IN BAG-LOT QUANTITIES.

Millers' Prices.

1. No person shall sell any mealie product derived from mealies ground, crushed, gristed or otherwise processed by him or on his behalf by any other person and contained in large jute or hessian bags and specified in Table A hereunder, or contained in 90 lb. jute or hessian bags and specified in Table B hereunder, or contained in cotton or linen bags and specified in Table C hereunder, at prices in excess of the prices specified in those tables in respect of that mealie product; provided that the prices mentioned in the said tables may be increased by 8d. per 180 lb. of any mealie product referred to in the said tables where the total quantity of that mealie product sold to any one person at one and the same time is less than 1,800 lb.

(c) shall apply in respect of mealie products paid for in cash, or not later than the end of the month immediately following the month during which delivery or despatch of the mealie products was effected and may, where payment is effected after the lapse of that period, be increased by 2d. per 180 lb. in respect of every month or part thereof after the end of the month immediately following upon the month during which delivery or despatch of those mealie products was effected and during which the price remains unpaid.

1. No person selling mealies or mealie products in quantities of less than a bag to any one person at one and the same time—

(a) at places within a radius of five miles from the nearest station in—

- (i) the Province of the Orange Free State and the Transvaal (excluding the Magisterial Districts of Barberton, Letaba, Pietersburg, Pilgrims Rest and Zoutpansberg) or in the Magisterial Districts of Dundee, Helpmekaar, Klip River, Newcastle, Ngotshe, Nqutu, Paulpietersburg, Utrecht and Vryheid, in the Province of Natal, or in the Magisterial Districts of Albert, Aliwal North, Barkly West, Colesberg, Kimberley, Mafeking, Taungs and Vryburg in the Province of the Cape of Good Hope, shall supply quantities less than those specified in Table A hereunder for the respective prices;
- (ii) the Union other than the places referred to in (i) above, shall supply quantities less than those specified in Table B hereunder for the respective prices;

(b) at Port Nolloth shall for the respective prices specified in Table A hereunder supply quantities less than the respective quantities specified in that Table decreased at the rate of 10 oz. per sixpence.

2. The minimum quantities fixed for the respective areas referred to in paragraph (a) above, may be decreased by $\frac{1}{4}$ oz. per sixpence per five miles or part thereof, excluding the first five miles, when the products are sold at places beyond a radius of five miles from the nearest station.

3. The minimum quantities to be sold for prices not stated in Tables A and B hereunder, shall in the case of prices of less than 12s. 6d. be calculated in proportion to the minimum quantity specified for the next higher price stated and in the case of prices of more than 12s. 6d. in proportion to the minimum quantity specified for 12s. 6d.

4. The minimum quantities fixed or determined in clause 1 above are inclusive of containers, but when the purchaser provides his own container the quantity shall be increased by 2 oz. per sixpence.

DEFINITIONS.

For the purpose of this Government Notice—

“bag”, in relation to mealies, shall mean a quantity of mealies of a net weight of 200 lb., determined on a moisture content not exceeding 12½ per cent. by weight;

“jute or hessian bag” shall mean, in relation to the mealie products specified in Tables A and D—

- (i) samp, 200 lb. net weight of samp;
- (ii) germ meal or hominy chop, 150 lb. net weight of germ meal and hominy chop;
- (iii) mealie bran (coarse or fine), 80 lb. net weight of mealie bran;
- (iv) any mealie product other than samp, germ meal, hominy chop or mealie bran (coarse or fine), 180 lb. net weight of such mealie product;

“jute or hessian bag” shall mean, in relation to the mealie products specified in Tables B and E, 90 lb. of such products:

“cotton or linen bag” shall mean, for the purpose of Tables C and F, cotton or linen bags containing 90 lb., 50 lb., 25 lb., 10 lb. or 5 lb. of mealie products;

“Area A” shall mean the area comprising the Provinces of Transvaal and the Orange Free State and the Magisterial Districts of Mafeking and Vryburg in the Province of the Cape of Good Hope;

“Area B” shall mean the area comprising the Provinces of Natal and the Cape of Good Hope, excluding the Magisterial Districts of Mafeking and Vryburg;

“trader” shall mean a person registered in terms of paragraph (a) of sub-section (1) of section 28 of the Mealie Control Scheme to purchase or otherwise acquire mealies produced in Area B or mealie products derived from such mealies;

“sell” shall have the meaning assigned thereto in the Marketing Act, 1937, as amended;

“nearest station” shall mean the nearest railway station or siding, including any private siding to which a train service is conducted;

the mealie products referred to in the said prohibitions shall be the products described in the Schedule to Government Notice No. 948 of the 30th April, 1952, as amended;

the grades of mealies referred to in the said prohibitions shall be the grades described in the Schedule to Government Notice No. 826 of 1949, as amended;

the grades of bags referred to in the said prohibitions shall be the grades as described by regulation by the Price Controller from time to time.

GRADING, PACKING AND MARKING OF MEALIE PRODUCTS.

His Excellency the Governor-General has, under the powers vested in him by section *forty-three* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, and with effect from the 1st of May, 1952, made the regulations set out in the Schedule hereto, regarding mealie products to which the provisions of a proclamation issued in terms of section *thirty-six* of the said Act, apply.

SCHEDULE.

DEFINITIONS.

1. For the purpose of these regulations—

- “hand sieve” means a hand sieve with a wooden frame $\frac{1}{8}$ inches thick with inside dimensions of 12 inches square and four inches deep;
- “filtering cloth” means Byzan linen cloth having 40 weft threads and 52 warp threads per linear inch;
- “5 wire mesh” means a wire mesh which has five meshes to the linear inch and is made from light plated steel wire of No. 20 imperial standard wire gauge;
- “8 wire mesh” means a wire mesh which has eight meshes to the linear inch and is made from light plated steel wire of No. 26 imperial standard wire gauge;
- “10 wire mesh” means a wire mesh which has 10 meshes to the linear inch and is made from light plated steel wire of No. 28 imperial standard wire gauge;
- “14 wire mesh” means a wire mesh which has 14 meshes to the linear inch and is made from light plated steel wire of No. 28 imperial standard wire gauge;
- “18 wire mesh” means a wire mesh which has 18 meshes to the linear inch and is made from light plated steel wire of No. 31 imperial standard wire gauge;
- “20 wire mesh” means a wire mesh which has 20 meshes to the linear inch and is made from light plated steel wire of No. 31 imperial standard wire gauge;
- “24 wire mesh” means a wire mesh which has 24 meshes to the linear inch and is made from light plated steel wire of No. 35 imperial standard wire gauge;
- “40 wire mesh” means a wire mesh which has 40 meshes to the linear inch and is made from light plated steel wire of No. 38 imperial standard wire gauge;
- “60 wire mesh” means a wire mesh which has 60 meshes to the linear inch and is made from light plated steel wire of No. 41 imperial standard wire gauge.

GRADES.

2. (1) There shall be one grade of *mealie flour* which shall be any pure sound product which has been obtained from the milling of white mealies, and—

- (i) which has a fibre content, calculated on a moisture-free basis, not exceeding 1·0 per cent. by weight; and
- (ii) which is of a fineness that will allow not less than 90 per cent. by weight thereof to pass through a 60 wire mesh hand sieve.

(2) There shall be one grade of *bakers' cones* which shall be any pure sound product which has been obtained from the milling of white mealies, and—

- (i) which has a fibre content, calculated on a moisture-free basis, not exceeding 0·8 per cent. by weight; and
- (ii) which is of a fineness that will allow not less than 95 per cent. by weight thereof to pass through a 40 wire mesh hand sieve, and not more than 50 per cent. by weight thereof through a 60 wire mesh hand sieve.

- (i) which has a fibre content, calculated on a moisture-free basis, of not less than 0·9 per cent. by weight and not exceeding 1·5 per cent. by weight; and
- (ii) which is of a fineness that will not allow less than 95 per cent. by weight thereof to pass through a 24 wire mesh hand sieve, and not more than 30 per cent. by weight thereof through a 60 wire mesh hand sieve.

(4) There shall be one grade of *unsifted granulated mealie meal* which shall be any pure sound product which has been obtained from the milling of white mealies, and—

- (i) which has a fibre content, calculated on a moisture-free basis, of not less than 1·8 per cent. by weight and not exceeding 3·0 per cent by weight; and
- (ii) which is of a fineness that will allow not less than 95 per cent. by weight thereof to pass through a 24 wire mesh hand sieve, and not more than 30 per cent. by weight thereof through a 60 wire mesh hand sieve.

(5) There shall be one grade of *unsifted non-granulated mealie meal* (straight-run non-granulated mealie meal) which shall be any pure sound product which has been obtained from the milling of mealies and—

- (i) which has a fibre content, calculated on a moisture-free basis, of not less than 1·8 per cent. by weight and not exceeding 3·0 per cent. by weight; and
- (ii) which is of a fineness that will allow not less than 95 per cent. by weight thereof to pass through an 18 wire mesh hand sieve.

(6) There shall be one grade of *mealie grits* (brewers' grits) which shall be any pure sound product which has been obtained from the milling of degenerated white mealies and consists of the starchy portion of the grain, and—

- (i) which has a fibre content, calculated on a moisture-free basis, not exceeding 0·8 per cent. by weight; and
- (ii) which has a fat content, calculated on a moisture-free basis, not exceeding 1·0 per cent. by weight; and
- (iii) which is of a fineness that will allow not less than 95 per cent. by weight thereof to pass through a 10 wire mesh hand sieve, and not more than 5 per cent. by weight thereof through a 24 wire mesh hand sieve.

(7) There shall be one grade of *mealie rice* which shall be any pure sound product which has been obtained from the milling of degenerated white mealies and consists of the starchy portion of the grain, and—

- (i) which has a fibre content, calculated on a moisture-free basis, not exceeding 0·8 per cent. by weight; and
- (ii) which is of a fineness that will allow not less than 95 per cent. by weight thereof to pass through a 5 wire mesh hand sieve, and not more than 5 per cent. by weight thereof through an 18 wire mesh hand sieve.

(8) There shall be one grade of *samp* which shall be any pure sound product which has been obtained from the milling of degenerated white mealies and consists of the starchy portion of the grain, and—

- (i) which has a fibre content, calculated on a moisture-free basis, not exceeding 0·6 per cent. by weight; and
- (ii) is of such a size that not more than 5 per cent. by weight thereof are whole kernels, and not more than 5 per cent. by weight thereof will pass through an 8 wire mesh hand sieve.

(9) There shall be one grade of *unsifted crushed mealies* which shall be any pure sound product of whole mealies which has been broken, cut or crushed, and—

- (i) which has a fibre content, calculated on a moisture-free basis, not exceeding 3·0 per cent. by weight; and

(6) Daar is een graad *mieliegruis* wat enige suwer, gesonde produk is wat verkry is deur die maal van witmielies waarvan die kiem verwijder is, en wat bestaan uit die styselgedeelte van die mieliepit en—

- (i) wat 'n veselgehalte, op 'n vogvrye basis bereken, van hoogstens 0·8 persent, volgens gewig, het; en
- (ii) wat 'n vetgehalte, op 'n vogvrye basis bereken, van hoogstens 1·0 persent, volgens gewig, het; en
- (iii) wat so fyn is dat minstens 95 persent daarvan, volgens gewig, deur 'n 10-draadmaas-handsif en hoogstens 5 persent daarvan, volgens gewig, deur 'n 24-draadmaas-handsif gaan.

- (ii) wat so fyn is dat minstens 95 persent daarvan, volgens gewig, deur 'n 5-draadmaas-handsif en hoogstens 5 persent daarvan, volgens gewig, deur 'n 18-draadmaas-handsif gaan.

(8) Daar is een graad *stampmielies* wat enige suwer, gesonde produk is wat verkry is deur die maal van witmielies waarvan die kiem verwijder is en wat bestaan uit die styselgedeelte van die mieliepit en—

- (i) wat 'n veselgehalte, op 'n vogvrye basis bereken, van hoogstens 0·6 persent, volgens gewig, het; en
- (ii) wat van so 'n grootte is dat hoogstens 5 persent daarvan, volgens gewig, heel pitte is, en hoogstens 5 persent daarvan, volgens gewig, deur 'n 8-draadmaas-handsif gaan.

(9) Daar is een graad *ongesifte gebreekte mielies* wat enige suwer, gesonde produk is wat verkry is deur heel mielies te breek, te sny of te vergruis en—

- (i) wat 'n veselgehalte, op 'n vogvrye basis bereken, van hoogstens 3·0 persent, volgens gewig, het; en

(ii) is of such a size that not more than 5 per cent. by weight thereof are whole kernels and not more than 40 per cent. by weight thereof will pass through an 8 wire mesh hand sieve.

(10) There shall be one grade of *sifted crushed mealies* which shall be any pure sound product of whole mealies which has been broken, cut or crushed, and—

- (i) which has a fibre content, calculated on a moisture free basis, not exceeding 2·0 per cent. by weight; and
- (ii) is of such a size that not more than 5 per cent. by weight thereof are whole kernels and not more than 5 per cent. by weight thereof will pass through a 14 wire mesh hand sieve; and
- (iii) which has been so sifted and separated that it has a loose bran content not exceeding 0·5 per cent. by weight thereof.

(11) There shall be one grade of *fine sifted crushed mealies* which shall be any pure sound product of whole mealies which has been broken, cut or crushed, and—

- (i) which has a fibre content, calculated on a moisture free basis, not exceeding 2·0 per cent. by weight; and
- (ii) which is of a fineness that will allow not less than 95 per cent. by weight thereof to pass through an 8 wire mesh hand sieve; and not more than 10 per cent. by weight thereof to pass through a 20 wire mesh hand sieve; and
- (iii) which has been so sifted and separated that it has a loose bran content not exceeding 0·5 per cent. by weight thereof.

(12) There shall be one grade of *germ meal* which shall be the sound product which has been obtained from mealies in the degenerating process, and consists of that portion of the grain which is separated as offals from the main starchy portion thereof, and which has a fibre content, calculated on a moisture free basis, not exceeding 9 per cent. by weight.

(13) There shall be one grade of *hominy chop* (finely ground bran and offal) which shall be the sound product which has been obtained from the milling of mealies, and consisting mainly of the husk of the grain, and—

- (i) which has a fibre content, calculated on a moisture free basis, not exceeding 14 per cent. by weight; and
- (ii) which is of a fineness that will allow not less than 95 per cent. by weight thereof to pass through a 10 wire mesh hand sieve.

(14) There shall be one grade of *mealie bran*, which shall be the sound product which has been obtained from the milling of mealies, and consists mainly of the husk of the grain, and which has a fibre content, calculated on a moisture free basis, not exceeding 14 per cent. by weight.

(15) (a) Mealie products defined in this regulation, other than germ meal, hominy chop and mealie bran, shall be deemed to include such products of which the fibre content does not exceed 0·05 per cent. below the prescribed minimum or above the prescribed maximum.

(b) Germ meal, hominy chop and mealie bran shall be deemed to include germ meal, hominy chop and mealie bran of which the fibre content does not exceed 0·1 per cent. above the prescribed maximum.

(c) Mealie grits (brewers' grits) shall be deemed to include mealie grits of which the fat content does not exceed 0·1 per cent. above the prescribed maximum.

(d) Mealie products defined in this regulation shall be deemed to include such products of which a percentage not exceeding 0·5 per cent. below the prescribed minimum or above the prescribed maximum passes through the relative wire mesh hand sieve.

- (ii) wat so fyn is dat minstens 95 persent daarvan, volgens gewig, deur 'n 8-draadmaas-handsif, en hoogstens 10 persent daarvan, volgens gewig, deur 'n 20-draadmaas-handsif gaan; en
- (iii) wat op sodanige wyse gesif en afgeskei is dat hoogstens 0·5 persent los semels volgens gewig daarin aanwesig is.

(14) Daar is een graad *mieliesemels* wat die gesonde produk is wat verkry is deur die maal van mielies, en wat hoofsaaklik bestaan uit die dop van die mieliepit, en wat 'n veselgehalte, op 'n vogvrye basis bereken, van hoogstens 14 persent, volgens gewig, het.

(15) (a) Mielieprodukte, in hierdie regulasie omskryf, uitgesonderd kiemmeel, mielie-afval en mieliesemels, word geag sodanige produkte in te sluit waarvan die veselgehalte hoogstens 0·05 persent laer as die voorgeskrewe minimum of hoër as die voorgeskrewe maksimum is.

(b) Kiemmeel, mielie-afval en mieliesemels word geag kiemmeel, mielie-afval en mieliesemels in te sluit waarvan die veselgehalte hoogstens 0·1 persent hoër as die voor- geskrewe maksimum veselgehalte is.

(c) Mieliegruis word geag mieliegruis in te sluit waarvan die vetgehalte hoogstens 0·1 persent hoër as die voor- geskrewe maksimum vetgehalte is.

(d) Mielieprodukte, in hierdie regulasie omskryf, word geag sodanige produkte in te sluit waarvan 'n persentasie van hoogstens 0·5 persent laer as die voorgeskrewe minimum of hoër as die voorgeskrewe maksimum deur die betrokke handsif gaan.

TESTING.

3. For the purpose of these regulations the moisture content, fat content, fibre content, fineness and loose bran content of mealie products are determined in the following manner:—

(1) The sample of mealie products of which the moisture content, fat content or fibre content is to be determined, shall be ground to a fineness which will allow all the material to pass through a 20 wire mesh hand sieve, and every sample shall be thoroughly mixed before a determination is made.

Hot Air Oven Method for the Determination of Moisture Content.

(2) The moisture content of a sample shall be determined as follows:—

Two clean, flat-bottomed, covered dishes with a diameter of not less than 6 cm. each are dried in a drying oven to a constant weight at a temperature of 130°C . (with a variation of not more than 3°C . either way) and then cooled in a desiccator to room temperature. They are then weighed separately, and into each 2 grammes (with a variation of not more than 0·1 gramme either way) of the well-mixed sample are placed. The dishes with contents and their respective lids leaning against them are then dried for one hour in the oven at a temperature of 130°C . (with a variation of not more than 3°C . either way). The hour shall be calculated from the time at which the temperature of the oven returns to 130°C . after the introduction of the dishes. At the end of the hour's heating the dishes are covered with their respective lids while still in the oven and transferred to a desiccator. As soon as they have cooled to room temperature they are weighed separately and the weight in each case is then deducted from the weight of the respective covered dish plus the weight of the original sample. These losses in weight are expressed as percentages of the original weights of the respective samples. If the two percentages so obtained do not differ by more than 0·2 the average is taken to represent the moisture content of the sample. If the percentages differ by more than 0·2 the test must be repeated.

Method for the Determination of Fat Content.

(3) After the determination of the moisture content, as described in sub-regulation (2) above, if the difference between the two percentages so obtained is not more than 0·2, the fat content of the sample shall be determined in the following manner:—

The dry material in the two flat-bottomed dishes, after the determination of the moisture content, is carefully transferred to two separate Soxhlet extraction thimbles without any loss of material and the thimbles plugged with high-grade cotton wool. The Soxhlet extraction thimbles are then placed each in a separate Soxhlet extraction apparatus, the extraction flasks of which have been dried at a temperature of 95°C . cooled in a desiccator and weighed beforehand. The material in the extraction apparatus is then extracted with redistilled petroleum ether (boiling point 40°C . to 60°C) for 18 hours, after which the thimbles with extracted material are removed from the extraction apparatus, the petroleum ether allowed to drain into the apparatus and the contents of the thimbles reserved for the fibre determination. The two flasks containing the extract are then heated on a boiling water bath, so as to distil off the petroleum ether as far as possible, after which the flasks with their contents are dried in the hot air oven at a temperature of 95°C . for 30 minutes. The flasks are then transferred to a desiccator allowed to cool to room temperature and weighed. This procedure is repeated until the weight of each flask remains constant.

The difference in weight between the two weighings of the same flask before and after extraction, expressed as a percentage of the dry weight of the

TOETSMETODE.

3. Vir die toepassing van hierdie regulasies word die voggehalte, vetgehalte, veselgehalte, fynheid en persentasie los semels van mielieprodukte soos volg bepaal:—

(1) Die monster mielieproduk waarvan die voggehalte, vetgehalte of veselgehalte bepaal moet word, word so fyn gemaal dat al die materiaal deur 'n 20-draadmaas-handsif gaan, en die monster word deeglik gemeng voordat 'n bepaling gedoen word.

Warmlugoondmetode vir die bepaling van voggehalte.

(2) Die voggehalte van 'n monster word soos volg bepaal:—

Twee skoon platboombakkies met 'n deursnee van minstens 6 cm. elk, word met hul deksels in 'n droogond gedroog by 'n temperatuur van 130°C . (met 'n speling van hoogstens 3°C . hoér of laer) totdat die gewig konstant bly en dan in 'n desikkator tot by kamertemperatuur afgekoel. Hulle word dan afsonderlik geweeg en in elkeen word 2 gram (met 'n speling van hoogstens 0·1 gram meer of minder) van die goedgemengde monster wat getoets word, geplaas. Die bakkies met inhoud en deksels wat teen die onderskeie bakkies leun, word vir een uur in die oond gedroog, by 'n temperatuur van 130°C . (met 'n speling van hoogstens 3°C . hoér of laer). Die uur word bereken vanaf die oomblik waarop die oond se temperatuur tot 130°C . terugkeer nadat die bakkies daarin geplaas is. Aan die einde van die uur se verhitting word die bakkies met hul onderskeie deksels toegemaak terwyl hulle nog in die oond is en in 'n desikkator oorgeplaas. Sodra hulle tot by kamertemperatuur afgekoel het, word hulle afsonderlik geweeg en die gewig word in elke gevall afgetrek van die gewig van die onderskeie toegemaakte bakkies plus die gewig van die oorspronklike monster. Hierdie gewigsverlies word uitgedruk as persentasies van die oorspronklike gewigte van die onderskeie monsters. Metode vir die bepaling van vetgehalte.

(3) Na die bepaling van die voggehalte, soos in sub-regulasié (2) hierbo beskryf, as die verskil tussen die twee persentasies wat aldus verkry is nie meer as 0·2 is nie, word die vetgehalte van die monster soos volg bepaal:—

Die droë materiaal in die twee platboombakkies word, ná die bepaling van die voggehalte, versigtig oorgeplaas in twee afsonderlike Soxhlet-ekstraksievingerhoede, sonder enige verlies aan materiaal, en die ekstraksievingerhoede word met hoëgraadse watte toegestop. Die ekstraksievingerhoede word dan elkeen in 'n aparte soxhlet-ekstraksieapparaat geplaas waarvan die ekstraheerflessie vooraf by 95°C . gedroog, in 'n desikkator afgekoel en geweeg is. Die materiaal in die apparaat word dan met herdistilleerde petroleum-eter (kookpunt 40°C . tot 60°C) geëkstraheer vir 18 uur, waarna die ekstraksievingerhoede uit die apparaat gehaal word, die petroleum-eter toegelaat word om in die apparaat af te dreineer en die inhoud dan vir die veselbepaling gehou word. Die twee flessies met ekstrak word dan weer verhit ten einde sover moontlik die petroleum-eter op 'n kokende waterbad af te stook, waarna die flessies met inhoud vir 30 minute in 'n droogond by 'n temperatuur van 95°C . gedroog word. sample as obtained in the determination of the moisture content, represents the percentage of crude fat in the moisture free sample.

If the two percentages so obtained do not differ by more than 0·2, the average is taken to represent the fat content of the sample. If the percentage differ by more than 0·2 the test must be repeated.

Method for the Determination of Fibre Content.

(4) After the extraction of the crude fat in the Soxhlet apparatus, as described in sub-regulation (3) above, the fibre content of the sample shall be determined in the following manner:—

The contents of the two thimbles, after extraction, are allowed to dry in the air, and are then carefully transferred to two separate 500 ml. beakers, without any loss of weight. In each of two other beakers 200 ml. of sulphuric acid of 1·25 per cent. strength are measured off, the acid is brought to boiling point and transferred at once to the beakers containing the samples. The mixture in the beakers is boiled at once and the boiling continued gently for 30 minutes. The volume of the mixture in each beaker is kept constant by means of a 500 ml. round-bottomed boiling flask containing cold water acting as a condenser on the beaker, and by the addition of boiling water. The mixture is then filtered through the filtering cloth (defined in regulation 1). The residue is washed with boiling water until the filtrate is free from acid. 200 ml. of sodium hydroxide solution of 1·25 per cent. strength are measured off into a boiling flask and brought to boiling point. The boiling solution is used to wash the residue on the filtering cloth back into the beaker. The mixture in the beaker is at once brought to boiling point and the boiling continued for 30 minutes in the same way as in the case of the acid treatment. The mixture is then filtered through the filtering cloth and is washed with boiling water, until the filtrate is free from alkali. The residue on the filtering cloth is washed back into the beaker with water and thereafter filtered through a Gooch crucible, which has been prepared beforehand in the following manner: The crucible is packed with a thin but close layer of prepared asbestos (see below) and is then approximately half filled with clean sand of a grain size such as will pass through a 30 mesh (per linear inch) sieve, but not through an 80 mesh (per linear inch) sieve. The asbestos and the sand should previously have been digested on the steambath for 10 hours with a 5 per cent. solution of sodium hydroxide and then thoroughly washed with hot water. They are then digested in a similar manner with 10 per cent. hydrochloric acid and again washed thoroughly with hot water. Both these materials are then ignited in a muffle furnace at a bright red heat!

After the crude fibre has been filtered through the Gooch crucible, with the aid of a filter pump to expedite filtration, the crucible and contents are then dried to constant weight in a hot air oven at a temperature of 105° C. (with a variation of not more than 3° C. either way). It is then placed in a desiccator and weighed as soon as it has cooled to room temperature. The residue is then completely incinerated in a furnace at a temperature of 575° C. (with a variation of not more than 15° C. either way), and after cooling in a desiccator to room temperature, the crucible is again weighed. The difference in weight between the last two weighings, expressed as a percentage of the dry weight of the sample as obtained in the determination of the moisture content, represents the percentage of crude fibre in the moisture free sample. If the two percentages so obtained do not differ by more than 0·1 the average is taken to represent the fibre content of the sample. If the percentages differ by more than 0·1 the test

Metode vir die bepaling van veselgehalte.

(4) Ná die ekstraksie van die ru-vet met behulp van die Soxhlet-apparaat, soos beskryf in sub-regulasie (3) hierbo, word die veselgehalte van die monster soos volg bepaal:—

Die inhoud van die twee ekstraksievingerhoede word na die ekstraksie toegelaat om in die lug te droog, waarna hul inhoud in twee afsonderlike 500-ml.-bekers oorgegooi word, sonder enige verlies aan gewig. In elk van twee ander bekers word 200 ml. swawelsuur teen 'n sterkte van 1·25 persent afgemeet; die suur word tot by kookpunt verhit en dadelik in die bekers waarin die monsters is, oorgegooi. Die mengsel in die bekers word dadelik tot by kookpunt verhit en vir 30 minute stadig gekook. Die volume van die mengsel in elke beker word konstant gehou deur middel van 'n rondeboomkookfles van 500 ml. met koue water wat as verkoeler op die beker werk, en deur die byvoeging van kokende water. Die mengsel word dan deur die filtreerdekoek (soos in regulasie 1 omskryf) gefiltreer. Die residu word met kokende water gewas totdat die filtraat suurvry is. 'n Hoeveelheid van 200 ml. natriumhidroksiedoplossing teen 'n sterkte van 1·25 persent word in 'n kookfles afgemeet en tot by kookpunt verhit. Die kokende oplossing word gebruik om die residu op die filtreerdekoek in die beker terug te spoel. Die mengsel in die beker word dadelik tot by kookpunt verhit, en word, net soos in die geval van die suurbehandeling, vir 30 minute gekook. Die mengsel word dan weer deur die filtreerdekoek gefiltreer en met kokende water gewas totdat die filtraat vry van alkali is. Die residu op die filtreerdekoek word met water in die beker teruggespoel en daarna deur 'n Gooch-kroesie gefiltreer wat op die volgende manier voorberei is: Die kroesie word gepak met 'n dun maar vaste lagie asbes en daarna ongeveer halfvol gemaak met skoon sand wat van sodanige korrelgrootte is dat dit deur 'n sif met 30 mase (per strekkende duim) gaan maar nie deur 'n sif met 80 mase (per strekkende duim) gaan nie. Die asbes en die sand word vooraf vir 10 uur geëkstraheer op die kokende waterbad met 'n 5-persent oplossing natriumhidroksied, en dan deeglik met warm water gewas. Daarna word die asbes en sand weer op 'n soortgelyke wyse met 'n 10-persent-soutsuuroplossing geëkstraheer en dan weer deeglik met warm water gewas. Albei stowwe word dan ook in 'n verassingsoond by 'n helderrooi gloed gegloei.

Nadat die ru-vesel met behulp van 'n filtreerpomp, ten einde filtratie te bespoedig, deur die Gooch-kroesie gefiltreer is, word die kroesie met inhoud by 'n temperatuur van 105° C. (met 'n speling van hoogstens 3° C. hoër of laer) in 'n warmlugoond gedroog totdat die gewig konstant bly. Dit word dan in 'n desikkator geplaas, en sodra dit tot by kamertemperatuur afgekoel het, geweeg. Die residu word dan heeltemal verbrand in 'n verassingsoond by 'n temperatuur van 575° C. (met 'n speling van hoogstens 15° C. hoër of laer) en nadat die kroesie in 'n desikkator tot by kamertemperatuur afgekoel het, word dit weer geweeg. Die verskil in gewig tussen die laaste twee wegings, uitgedruk as 'n persentasie van die droë gewig van die monster soos verkry in die bepaling van die voggehalte, verteenwoordig die persentasie ru-vesel in die vogvrye monster. must be repeated; provided that in the case of fibre determinations on samples of germ meal, hominy chop and mealie bran, the aforesaid difference between the two percentages shall be not more than 0·2. If, in the case of these three products the two percentages differ by more than 0·2 the test must be repeated:

NOTES.

(i) The sodium hydroxide (NaOH) solution should be free, or practically free from sodium carbonate (Na_2CO_3).

(ii) The sodium hydroxide solution contains exactly 1·25 grammes of NaOH in 100 ml. as determined by titration, using phenolphthalein as indicator.

(iii) The sulphuric acid (H_2SO_4) solution contains exactly 1·25 grammes of H_2SO_4 in 100 ml. as determined by titration, using phenolphthalein as indicator.

(iv) Vacuum desiccators with silica gel or reignited quick lime as desiccants are recommended for this work.

(v) It is advisable that only one asbestos-packed Gooch crucible be placed in a desiccator.

(vi) It is advisable that the furnace be equipped with a pyrometer in order that a continuous check on the temperature may be kept.

(vii) Chemical balances of the semi-automatic type with air damping attachments are recommended for this work.

(viii) It is advisable that a Soxhlet extraction apparatus with an extractor of 60 ml. capacity be used for this work.

Method for the Determination of the Fineness of a Sample.

(5) In the determination of the fineness of a mealie product two 100-gramme sample shall be sifted in the following manner:—

A weighed quantity of 100 grammes of the mealie product is transferred into the appropriate hand sieve. The sieve is grasped with the one hand and is struck in a slightly inclined position against the palm of the free hand, held six inches away from the sieve, in such a manner that the material is evenly distributed over the surface of the screen during the sieving process. The sieving process should be continued for two minutes, at the rate of 150 strokes per minute. After 150 strokes the sieve should be turned and the side previously held should then be struck against the palm of the free hand. The sieving process should be continued immediately. After completion of the sieving process the material which has passed through the sieve should be weighed and the weight calculated as a percentage of the 100 grammes taken. If the difference between the percentages in respect of the two samples does not exceed 1·0 the average of the two percentages so determined shall be taken as the result; if the said difference exceeds 1·0 the test must be repeated.

The foregoing sieving procedure and calculation applies in the case of the 5-, 8-, 10-, 14-, 18-, 20- and 24-wire mesh hand sieves. In the case of the 40- and 60-wire mesh hand sieves, the same procedure is adhered to, but with this additional provision, viz., when the sieve becomes clogged by fine material, thus appreciably retarding the sieving process the contents are emptied on to a smooth piece of paper of ample size. The adhering fine material in the meshes of the sieve is removed with the aid of a small soft hair brush, and is allowed to pass through the sieve on to the material that has already passed through in the shaking process. Other entrapped material on the sieve that will not pass through is loosened by means of the brush. The material on the paper is returned to the sieve, and the sieving process is continued as before for one minute. The cleaning procedure is repeated if necessary until a quantity of five grammes or less

(5) Vir die bepaling van die fynheid van 'n mielieproduuk, word twee monsters van 100 gram elk op die volgende manier gesif:—

Honderd gram van die mielieproduuk word in die betrokke handsif gegooi. passes through the sieve during a shaking of one minute. The total weight of all material that has thus passed through the sieve is calculated as a percentage of 100 grammes of sample taken.

Method for the Determination of the Loose Bran Content.

(6) The loose bran content of a sample shall be determined in the following manner:—

The sample of crushed mealies to be tested is first mixed very thoroughly. Two 50-gramme samples of the crushed mealies are weighed out, and are spread out separately on two pieces of paper. The loose flakes of bran in each sample are sorted out by hand and weighed to the nearest milligramme. The weights of the two quantities of loose bran so obtained are expressed as percentages of the original weights of the respective samples. If the two percentages so obtained do not differ by more than 0·1, the average is taken to represent the loose bran content of the sample. If the percentages differ by more than 0·1 the test must be repeated.

NOTE.—If the number of flakes of loose bran is extremely small, the quantity of the samples originally taken may be increased to 100 or 200 grammes. If the number of loose bran flakes is very high with the result that hand-sorting takes too long, the quantity of the samples taken may be decreased to such an extent that the weight of loose bran obtained is not less than 25 milligrammes.

PACKING.

4. (1) Samp shall be packed in one or other of the following packings:—

- (i) Jute or hessian containers containing 200 lb. net weight or 90 lb. net weight;
- (ii) Cotton or linen containers containing 90 lb. net weight, 50 lb. net weight, 25 lb. net weight, 10 lb. net weight, or 5 lb. net weight.

(2) Sifted granulated mealie meal, unsifted granulated mealie meal, unsifted non-granulated mealie meal, fine sifted crushed mealies, sifted crushed mealies, unsifted crushed mealies, mealie rice, mealie flour, bakers' cones and mealie grits shall be packed in one or other of the following packings:—

- (i) Jute or hessian containers containing 180 lb. net weight or 90 lb. net weight;
- (ii) Cotton or linen containers containing 90 lb. net weight, 50 lb. net weight, 25 lb. net weight, 10 lb. net weight, or 5 lb. net weight.

(3) Germ meal and hominy chop shall be packed in jute container containing 150 lb. net weight.

(4) Mealie bran shall be packed in jute containers containing 80 lb. net weight.

5. Regulation 4 above shall not apply to quantities of mealie products of less than 90 lb., taken from any receptacle and weighed, at the time of sale.

MARKING.

6. Each container containing any of the mealie products listed in regulation 2 above, shall be plainly marked either by means of a label of a size not less than one inch by two inches or by a mark on the container itself, which label or mark shall indicate the name of the miller by whom the product was manufactured, the registered number allocated to him by the Mealie Industry Control Board, the net weight and the grade of the mealie product (as defined in this Schedule) contained therein; provided that the provisions of this regulation shall not apply to sales of mealie products in terms of regulation 5.

**PROHIBITION ON THE MANUFACTURE OR SALE
OF MEALIE PRODUCTS OTHER THAN CERTAIN CLASSES OF MEALIE PRODUCTS.**

In terms of sub-section 1 of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, STEPHANUS PETRUS LE ROUX, Minister of Agriculture, hereby make known that the Mealie Industry Control Board, referred to in section 2 of the Mealie Control Scheme, published by Proclamation No. 77 of 1939, as amended, has, in terms of section 22 of that scheme and with my approval, imposed the prohibitions specified in the Schedule hereto, and these prohibitions will become operative on the tenth day of May, 1952.

SCHEDULE.

1. Except under the authority of a permit issued by the said Board subject to such conditions (if any) as it may determine, no person shall either for human or animal consumption or industrial use sell, or manufacture or cause to be manufactured sifted granulated mealie meal, unsifted granulated mealie meal, unsifted non-granulated mealie meal, fine sifted crushed mealies, sifted crushed mealies, unsifted crushed mealies, samp, mealie rice, bakers' cones, mealie flour or mealie grits other than mixed sifted granulated mealie meal, mixed unsifted granulated mealie meal, mixed unsifted non-granulated mealie meal, mixed fine crushed mealies, mixed sifted crushed mealies, mixed unsifted crushed mealies, mixed samp, mixed mealie rice, mixed bakers' cones, mixed mealie flour or mixed mealie grits; provided that the prohibition with regard to the manufacture of mealie products shall not apply to a producer of mealies who manufactures or causes to be manufactured such mealie products for his own consumption or for consumption by his household or labourers or for the feeding of his livestock:

2. For the purpose of this notice—

- (a) mixed sifted granulated mealie meal, mixed unsifted granulated mealie meal, mixed unsifted non-granulated mealie meal, mixed fine sifted crushed mealies, mixed sifted crushed mealies, mixed samp, mixed mealie rice, mixed bakers' cones, mixed mealie flour and mixed mealie grits shall be—
 - (i) the respective grades of mealie products determined in Government Notice No. 948 of 1952, as amended, manufactured from a maximum of 60 per cent. white mealies and a minimum of 40 per cent. yellow mealies, processed simultaneously and evenly mixed;
 - (ii) of a colour not lighter than the colour obtained by evenly mixing 60 per cent. of those products derived from white mealies with 40 per cent. of those products derived from grade 6 yellow mealies;
- (b) "sell" shall have the meaning assigned thereto in the Marketing Act, 1937 (Act No. 26 of 1937), as amended;

"producer" shall have the meaning assigned thereto in the Mealie Control Scheme (Proclamation No. 77 of 1939), as amended.

MEALIE MILLERS.

1. (1) Every person registered in terms of section 28 of the Mealie Control Scheme published by Proclamation No. 77 of 1939, as amended (hereinafter called the Scheme), to grind, crush, grist or otherwise process mealies—

- (a) shall record each day in Afrikaans or English the particulars set out in Schedule B hereto, in respect of mealies ground, crushed, gristed or otherwise processed by him on that day;
- (b) who is not an agent of the Board and who is not registered to purchase mealies from producers, shall record each day in Afrikaans or English the particulars set out in Schedule B1 hereto in respect of mealies which he has on that day received as a result of purchase or delivered as a result of sale;
- (c) shall record each day in Afrikaans or English the particulars set out in Schedule B2 hereto in respect of mealie products which he has on that day received as a result of purchase or delivered as a result of sale;
- (d) shall within seven days after the end of each calendar month render to the Board a return in the form set out in Schedule A hereto, reflecting the particulars indicating in that form, regarding mealies ground, crushed, gristed or otherwise processed, and purchased and sold during that month, and held in stock at the end of that month.

(2) Whenever mealies have been ground, crushed, gristed or otherwise processed on any particular day on behalf of different persons in quantities of less than one bag of mealies in the case of any of those persons, it shall be sufficient compliance with the requirements contained in paragraph (a) of sub-clause (1) if the total quantity of mealies thus ground, crushed, gristed or otherwise processed on behalf of such persons is recorded in the said record.

(3) Whenever, on any particular day, mealies or mealie products have been sold—

- (a) for cash, in quantities of less than 2,000 lb. in the case of mealies and 1,800 lb. in the case of mealie products;
