PRICE CONTROL.

MAXIMUM PRICES OF EGGS.—SEASONAL INCREASE.

In terms of regulation 3 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, do hereby—

- (1) amend Government Notice No. 660 of the 28th March, 1952 (Maximum Prices of Eggs), by the substitution of the Schedules hereto for the Schedules thereto;
- (2) withdraw Government Notice No. 1052 of 9th May, 1952 (Maximum Prices of Eggs).

NOTE.—The effect of this notice is to increase the maximum prices of eggs by amounts ranging from 1d. to 4d. per dozen. The prices of Grade III eggs remain unchanged.

OILSEED CONTROL SCHEME.

PROHIBITION ON THE SALE OF OILSEEDS.

In terms of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, STEPHANUS PETRUS LE ROUX, Minister of Agriculture, hereby make known that the Oilseed Control Board, referred to in section 3 of the Oilseed Control Scheme published under Proclamation No. 24 of 1952, has, in terms of section 15 of that Scheme, and with my approval, prohibited any person from selling oilseeds unless he has acquired such oilseeds from the Board or from such persons as may have been determined by the said Board.

And I do hereby further make known that this prohibition shall come into operation on the date of publication hereof.

LUCERNE SEED CONTROL BOARD.

SPECIAL LEVY ON LUCERNE SEED.

In terms of sub-section (1) of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, STEPHANUS PETRUS LE ROUX, Minister of Agriculture, hereby make known that the Lucerne Seed Control Board, referred to in section 2 of the Lucerne Seed Scheme published by Proclamation No. 22 of 1952, has in terms of section 15 of that scheme, and with my approval, imposed a special levy of 1s. per 100 lb. on lucerne seed which is exported from the Union, which levy shall be payable by the person or persons who export the lucerne seed at the time when such lucerne seed is exported.

And I further make known that the said special levy shall come into operation on the date of publication hereof.
